### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (US GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Emphasis of Matter**

As discussed in note 10 to the financial statements, effective January 1, 2024, the Plan changed its accounting policy and began reporting pre-2009 contracts and accounts that were previously carved out from reporting under the Department of Labor Field Assistance Bulletins (FABs) 2009-02 and 2010-01. Our opinion is not modified with respect to this matter.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with US GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of US GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with US GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter**

*Supplemental Schedule Required by ERISA*

The supplemental schedule of assets held at year-end as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note 1. Description of Plan

#### Nature of Business

The following description of the Goodwill Industries of Middle Tennessee Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan which was adopted on May 1, 1991, to provide retirement benefits for employees of Goodwill Industries of Middle Tennessee, Inc. (the Employer). The Plan covers all employees, excluding leased employees. Effective January 1, 2023, highly compensated employees became eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was most recently amended and restated effective February 1, 2025.

#### Contributions

The Plan allows participants to contribute a portion of their eligible compensation, as defined in the Plan document. Eligible retirement plan contributions to the Plan are excludable from income by the participants for federal income tax purposes under Section 403(b) of the Internal Revenue Code (IRC). Participants are eligible upon hire and may elect to contribute pre-tax salary deferrals and after-tax Roth deferrals up to 100% of compensation, subject to certain IRC limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Effective January 1, 2023, the Plan was amended to become a safe harbor plan and participants became eligible to participate in the employer match upon hire. The Employer began to make safe harbor contributions equal to 100% of the first 4% of elective deferrals and 50% of the next 2%.

Effective February 1, 2025, participants age 21 or older with a minimum of 90 days of service will be eligible for an Employer safe harbor match.

Employer and participant contributions may not exceed the maximum amount allowable for federal income tax purposes.

Participants direct the investment of contributions into various investment options offered by the Plan.

#### Participant Accounts

Each participant's account is credited (charged) with the participant's contributions and allocations of Employer contributions, investment returns, and administrative expenses. Allocations are based on participant's compensation or account balances as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

### Note 1. Description of Plan

#### Vesting

Participants are immediately vested in their elective salary deferral plus actual earnings (losses) thereon. Vesting in the Employer's matching contributions plus related earnings are based on years of service. Prior to normal retirement age, a participant vests ratably 20% per year until fully vested after five years of service. Employer matching contributions become fully vested upon normal retirement, death, disability, or termination of the Plan. Effective January 1, 2023, participants are 100% vested in their safe harbor match.

#### Plan Loans

Participants may borrow funds directly from Variable Annuity Life Insurance Company (VALIC). Adequate security is required, and a portion of the participant's account is held in the fixed annuity funds as collateral in case of default. As of December 31, 2024 and 2023, collateral held was \$35,139 and \$33,563, respectively. Principal payments increase the amount of funds available for the participant's use. Interest is paid directly to VALIC. Loans from Delaware Charter Guarantee and Trust Company dba Principal Trust Company (Principal) are not allowed under the Principal contract.

#### Payment of Benefits

Upon termination of service, a participant or their beneficiary may receive payment of the vested interest in their account balance under lump-sum or installment payments in accordance with plan provisions.

The Plan permits in-service distributions for hardship reasons and upon attaining age 59½ in accordance with plan provisions.

#### Forfeited Accounts

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Employer contribution portion of their accounts. Such forfeitures reduce the Employer's contributions to the Plan. The balance of forfeitures totaled \$92 and \$1,065 as of December 31, 2024 and 2023, respectively. Additionally, \$37,090 and \$30,935 of forfeitures were used to reduce employer contributions during 2024 and 2023, respectively.

### Note 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America (US GAAP).

#### Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are stated at fair value except for the fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, investment providers, and insurance companies.

### Note 2. **Summary of Significant Accounting Policies**

#### **Investment Valuation and Income Recognition**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment to Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the processing of distributions and recordkeeping are included in administrative expenses and charged directly to the participant's account. Investment-related expenses are included in net change in fair value of investments.

### Note 3. **Certification**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in the accompanying financial statements, notes, and supplemental schedule was obtained by management and agreed to or derived from the information certified as complete and accurate by VALIC and Principal, the custodians of the Plan.

- Investments at fair value and contract value
- Net change in fair value of investments
- Interest and dividend income

### Note 4. **Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and that the Plan has the ability to access.

Level 2 inputs are based on observable inputs corroborated by market data but not quoted on active markets.

Level 3 inputs are based on unobservable inputs and include situations where there is little, if any, market activity for the assets or liabilities and have the lowest priority.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

#### Note 4. Fair Value Measurements

The following is a description of the valuation methodology used for assets measured at fair value.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively trading.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of a different methodology or assumption to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the methodology used at December 31, 2024 and 2023.

#### Note 5. Investment Contracts with Insurance Companies

The Plan is party to traditional fully benefit-responsive separate account investment contracts with an insurance company, VALIC, totaling \$37,139 and \$35,538 at December 31, 2024 and 2023, respectively. The Plan also maintains a fixed income guaranteed option account under a fully benefit-responsive contract with Principal totaling \$116,938 and \$103,216 at December 31, 2024 and 2023, respectively.

VALIC and Principal maintain the Plan's contributions in their general accounts which are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contracts are included in the financial statements at contract value as reported to the Plan by VALIC and Principal, respectively. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

#### **Note 5. Investment Contracts with Insurance Companies**

VALIC's crediting interest rate is based on the formula specified in the annuity contract. For the Fixed Account Plus investments, VALIC employs a modified new money interest crediting policy. Under this policy, VALIC declares a "current" interest rate at the beginning of each month applicable to contributions received during that month. The current rate declared is guaranteed until the end of that calendar year for contributions received that month. It is VALIC's intent to continue to credit interest at the same rate for such contributions for an additional calendar year. At the beginning of the third calendar year, such contributions will earn interest at a newly declared pool rate. This rate is established January 1 of each calendar year and guaranteed for that entire calendar year. The contractually guaranteed minimum interest rate is applicable for the lifetime of the contract.

The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 3% if the participant's account was set up before December 1, 2003, and 2% if the participant's account was set up after this date but before December 31, 2010. Such interest rates are reviewed on a monthly basis for resetting. Effective January 1, 2011, contracts issued to new participants have an indexed guaranteed interest rate.

Principal's credited interest rate is based on a formula specified in the annuity contract under a ventage method of crediting interest. Under this method, a composite interest rate is declared at the beginning of each composite period. The rate cannot be less than the contractually guaranteed minimum interest rate established in the contract and is subject to reset semiannually. Per the annuity contract, the guaranteed minimum interest rate will range from 1% to 3%. As of December 31, 2024, the composite interest rate for the Plan was 1.55%.

Certain events could limit the ability of the Plan to transact at contract value with VALIC and Principal. Such events include the following: (i) amendments to the Plan documents (including complete or partial plan termination or merger with another plan); (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; or (iii) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

#### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

#### **Note 7. Income Tax Status**

The Employer has adopted a pre-approved volume submitter plan document that has received an opinion letter from the IRS dated March 31, 2017, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

### Note 7. **Income Tax Status**

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions that have been taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to IRS examination for years prior to 2021.

As of the date the financial statements were available for issuance, plan compliance testing for 2024 was in process and not complete. While the outcome of any compliance failure is unable to be quantified at this time, plan administration does not anticipate any operational failures that would be material to these financial statements. Any noncompliance with applicable requirements of the IRC will be promptly corrected under acceptable correction methods.

### Note 8. **Related Party and Party-in-interest Transactions**

Plan investments are managed by VALIC and Principal, the custodians of the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management and administration services are included in net change in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan made direct payments to the recordkeeper of \$67,157 for the year ended December 31, 2024. All of these party-in-interest transactions are exempt from the prohibited transaction rules under ERISA.

### Note 9. **Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.

### Note 10. **Change in Accounting Policy**

Effective January 1, 2024, the Plan began reporting pre-2009 participant contracts and accounts that were previously carved out under the Department of Labor Field Assistance Bulletins (FABs) 2009-02 and 2010-01. Under the FABs, contracts and accounts that required a substantial administrative burden for reporting were offered reporting relief. The Plan changed third party administrators effective January 1, 2024, which lifted the burden.
