## Independent Auditors' Report

To the Board of Trustees of  
Ohio Bankers Benefits Trust

### **Opinion**

We have audited the financial statements of the Ohio Bankers Benefits Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits and of plan benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in plan benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and plan benefit obligations as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and plan benefit obligations for the year ended December 31, 2024 in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). ## NOTES TO FINANCIAL STATEMENTS

### **Note 1. Organization**

The following description of the Ohio Bankers Benefits Trust (the "Plan") provides a summary of general information relating to plan provisions and operations. Participants should refer to the Plan Agreement for a complete description of the Plan's provisions.

*General* – The Plan is a multiple employer welfare arrangement and provides medical, prescription drug, dental, vision and/or other benefits (collectively known as "benefits") to eligible employees of participating employers of the Ohio Bankers League (the "Association"). The Ohio Bankers League is the Plan Sponsor, and its Board of Trustees is the plan administrator and Trustee of the trust established for the benefit of the Plan. Participation in the Plan is voluntary, and each member bank can select the coverage it will provide for its employees and the effective date. The Plan is a self-funded plan for substantially all benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

*Contributions* – The Plan provides for contributions from participating employers. All contributions are submitted to the plan administrator monthly. Premiums represent a premium equivalent rate that is paid by the participating employer who has joined the Plan that includes an estimate of expected claims, reinsurance, administrative cost, taxes or assessment and other necessary and essential operational costs. Premium does not imply this is a fully insured arrangement nor is the Plan a health plan issuer subject to rating requirements required of such an entity. Premiums are earned and recorded pro rata over the period for which coverage is provided. The amount of required employee contributions varies among participating banks. The amount of gross premium required for each participant is determined by the Board of Trustees annually upon consultation with the Plan's actuary. COBRA contributions are made by inactive employees at rates determined by the Trustees.

*Benefits* – The Plan provides benefits to eligible participants as determined by each member bank. The Plan also provides benefits to participants during periods of unemployment. In addition, employees may elect coverage for qualified dependents under the Plan provisions as determined by each employer.

*Management's Funding Policy* – Management's funding policy for benefit obligations is to charge premiums that will pay current Plan obligations and create a reserve to fund future obligations based on actuarially determined liabilities.

*Plan Termination* – Although it has not expressed any intent to do so, the Plan's Board of Trustees has the right under the Plan to amend or terminate the Plan at any time subject to the provisions of ERISA. In the event of termination of the Plan, the Plan shall remain liable to pay benefits for "expenses incurred" and for any total disability that occurs prior to the effective date of Plan termination, but only to the extent of the assets set aside for that purpose. Any remaining surplus would be used and distributed as the Trustees so determine, until no assets remain.

### NOTES TO FINANCIAL STATEMENTS (CONTINUED)

#### **Note 2. Summary of Significant Accounting Policies**

*Basis of Accounting* – The financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of Estimates* – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

*Payment of Benefits* – Premiums paid are recorded as premium payments in the accompanying statement of changes in net assets available for benefits. Claim payments are recorded when submitted to the Plan by the third-party claims processor for reimbursement. Claims paid by the claims processor prior to year-end or claim payments submitted to the Plan by the claims processor that are not yet paid are recorded as an amount currently payable in the accompanying statements of plan benefit obligations. Premiums not yet paid at year-end are included as an amount currently payable in the accompanying statements of plan benefit obligations.

*Health Care Receivables and Pharmacy Rebates* – Prescription rebates due from the Plan's pharmacy benefits manager are recorded when earned as estimated by management. Rebates due at year-end are recorded as a receivable on the accompanying statements of net assets available for benefits, with the offset being netted against claims paid. For the year ended December 31, 2024, pharmacy rebates of approximately \$3,922,000 have been netted against claims paid in the accompanying statement of changes in net assets available for benefits.

*Employers' Contributions and Related Receivables* – Contributions receivable are reported at their outstanding balances net of an estimated allowance for credit losses. Management provides for probable uncollectible amounts through a provision for credit loss expense and an adjustment to a valuation allowance based on its assessment of the current status of individual receivables. As of December 31, 2024 and 2023, management has determined the receivables are fully collectible and, accordingly, has not established an allowance for credit losses. Premium payments received prior to the period of coverage are included as a component of accrued expenses and other liabilities.

*Investment Valuation and Income Recognition* – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Trustees determines the Plan's valuation policies utilizing information provided by custodians of the Plan's assets. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Note 2. Summary of Significant Accounting Policies (Continued)**

*Administrative Fees* – The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators which are recorded when incurred and reported in claims processing and other fees on the statement of changes in net assets available for benefits. All other administrative expenses, such as professional fees, are recorded when incurred and are reported on the statement of changes in net assets available for benefits. Certain administrative functions are performed by employees of the Association. No such employee receives compensation from the Plan. All administrative fees are paid by the Plan, unless paid by the Association or an affiliate of the Association.

*Subsequent Events* – The Plan has evaluated all subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

#### **Note 3. Claims Incurred but not Reported**

Benefit obligations include health claims currently payable, health claims incurred but not yet reported and premiums payable. Claims paid by the claims processor prior to the year-end that are not reimbursed by the Plan as of year-end are recorded as claims payable and included in claims payable and claims incurred but not reported on the statements of plan benefit obligations.

Claims and claims payable are reported on the statement of changes in net assets available for benefits, statements of plan benefit obligations and statement of changes in plan benefit obligations net of stop loss reinsurance, as referenced in Note 5. Claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the plan administrator. The estimates are subject to the effects of trends in claim severity and frequency, and a reasonable provision for adverse development has been incorporated in management's best estimate. Although considerable variability is inherent in such estimates, management believes that the amounts reported for unpaid claims and claims adjustment expenses are reasonable. The estimates are continually reviewed and adjusted as necessary as experience develops or new information becomes known; such adjustments are included in changes in net assets available for benefits. These amounts are paid by the Plan only if claims are submitted and approved for payment.

#### **Note 4. Fair Value**

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Note 4. Fair Value (Continued)**

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets of the Plan measured at fair value:

*Interest-bearing cash:* Valued at cost, which approximates fair value and is classified as Level 1.

*Certificates of deposit:* Valued using pricing models maximizing the use of observable inputs for similar securities and is classified as Level 2.

*U.S. Government securities:* Valued using pricing models maximizing the use of observable inputs for similar securities and is classified as Level 2.

*Municipal bonds:* Valued using pricing models maximizing the use of observable inputs for similar securities and is classified as Level 2.

*Corporate debt instruments:* Valued based on quoted prices for identical or similar assets in markets that are not active, contractual cash flows, benchmark yields and credit spreads and is classified as Level 2.

*Corporate stocks:* Valued based on unadjusted quoted prices or daily quoted net asset values for identical assets in active markets the Plan can access and is classified as Level 1.

**Note 4. Fair Value (Continued)**

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. There have been no changes in the methodologies used from 2023 to 2024. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note 5. Reinsurance**

The Plan was subject to a stop loss reinsurance agreement with Community Insurance Company d.b.a. Anthem Blue Cross and Blue Shield ("Anthem") for medical and prescription drug coverage. The specific stop loss threshold per covered person is \$350,000. Under the aggregate stop loss contract, the reinsurer pays all claims in excess of a fixed per employee per month amount that is the equivalent of 125% of actuarially expected claim costs for the entire arrangement (net of any specific stop loss reimbursements). Stop loss recoveries totaling \$2,239,369 have been netted against claims paid in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

The cost of stop loss insurance was \$2,448,968 for the year ended December 31, 2024. Premiums for stop loss insurance are included in premium payments in the accompanying statement of changes in net assets available for benefits.

#### **Note 6. Party-in-Interest Transactions**

Certain Plan investments are held by members of the Association. As such, these transactions qualify as party-in-interest transactions. Members holding Plan investments do not receive any compensation from the Plan for these transactions.

#### **Note 7. Income Tax Status**

The trust funding certain benefits of the Plan is exempt from federal income taxes under Section 501(c)(9) of the Internal Revenue Code as a Voluntary Employees' Benefit Association account ("VEBA"). In December 2019, the Internal Revenue Service finalized regulations under IRC Section 512(a)(3)(E)(i) which specified that net investment income earned by a VEBA is taxable as unrelated business income. Accordingly, unrelated business income taxes have been recorded in the accompanying financial statements.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of and December 31, 2024 and 2023, there were no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. As of December 31, 2024, the Plan's income tax years from 2021 and thereafter remain subject to examination by the Internal Revenue Service.

#### **Note 8. Risks and Uncertainties**

The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially the amounts reported in the statement of net assets available for benefits. Additionally, the Plan maintains its cash in bank deposit accounts, which at times may exceed federally insured limits.

Concentrations of credit risk arise due to the Plan operating solely in the banking industry in Ohio. Consequently, these operations and the associated credit risk may be affected, either positively or negatively, by changes in economic conditions in the geographic area.

Contributions from one participating employer accounted for approximately 13% of total employer contributions for the year ended December 31, 2024. In the event this participating employer were to suspend contributions, the Plan would terminate coverage to the employer's participants as set forth in the Plan document. The Plan would retain the risk of meeting current fixed administrative expenses until the appropriate adjustments were made.
