Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Harter's 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Note A - Description of the Plan

The following description of Harter's 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Harter's 401(k) Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Harter's Quick Clean-Up Service, Inc. (the "Company") and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan is intended to be a profit sharing plan within the meaning of Code section 401(a) and includes a cash or deferred arrangement permitted by Code section 401(k). The Plan is administered by an Administrative Committee appointed by the Company.

Substantially all employees who have completed at least six months of service with the Company, as defined in the Plan, and are age 18 or older are eligible to participate in the Plan. Participants are automatically enrolled in the Plan on the first day of the next plan quarter subsequent to meeting the eligibility requirements, unless they opt out. Upon enrollment in the Plan, a participant may direct employer and employee contributions to any combination of available investment options. Employees are eligible for Company discretionary matching contributions if they make elective contributions to the Plan in the Plan year for which the matching contributions are allocated. The Company may also make discretionary profit sharing contributions to the plan. For purposes of profit sharing contribution, participants qualify if employed by the Company on the last day of the Plan year and the participant completes at least 1,000 hours of service in the Plan year or terminates employment prior to the last day of the Plan year due to death, disability or attainment of normal retirement age and completes a pro rata portion of 1,000 hours of service during the Plan year.

Contributions

Participants may make voluntary contributions to the Plan. Contributions are limited to 100% of pretax annual compensation, as defined in the Plan. Participants may also make after-tax Roth contributions. The combined pretax and Roth contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participants who have attained age 50 before the end of the Plan year are eligible to make "catch-up" contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Automatically enrolled participants have their deferral rate set at 4% of eligible compensation, and their contributions invested in the designated default fund until changed by the participant.

The Company may make matching contributions based on a discretionary percentage of eligible compensation as determined by the Company's board of directors. The Company made matching contributions of 100% of a participant's contributions up to 2% of the participant's eligible compensation, and then 50% of a participant's contribution from 2% - 4% of the participant's eligible compensation. Matching contributions totaled \$400,589 for the year ended December 31, 2024. Additional profit sharing amounts may be contributed at the sole discretion of the Company's board of directors. No profit sharing contributions were made for the year ended December 31, 2024.

Participants' Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in the account balances of their salary deferral and rollover contributions. In the event of termination of employment, a participant is entitled to receive the full amount in their Company matching and profit sharing contributions based on the number of years of service prior to such termination. Participants become fully vested in Company matching and profit sharing contributions according to a vesting schedule that calls for 0% during the first three years and 100% thereafter.

Notes Receivable from Participants

The Plan administrator may direct the custodian of the Plan to make loans to active participants. The minimum loan amount that can be taken is \$1,000 and the maximum loan amount is limited to 50% of the participant's vested account balance or \$50,000, whichever is less. The interest rate on all loans is determined by the Plan administrator at the inception of the loan and is fixed for the duration of the loan. Interest rates are commensurate with local prevailing rates at the time funds are borrowed.

Payment of Benefits

Due to death, disability, retirement, or termination of employment, a participant may elect to receive a lump-sum amount equal to the value of his or her vested account, an IRA rollover, or other qualified plan rollover. Vested balances less than \$1,000 are automatically paid in a lump-sum to the participant. The Plan also allows for hardship withdrawals due to reasons listed in the Plan document.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$26 and \$241, respectively. This account will be used to reduce future employer contributions or plan administrative expenses. During 2024, forfeitures used to reduce employer contributions and expenses were \$24,500.

Note B - Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain administrative expenses of the Plan are paid by the Plan and totaled \$4,510 for the year ended December 31, 2024. Investment related expenses are included in net appreciation in fair value of investments.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes both realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management has evaluated subsequent events through October 10, 2025, the date on which the financial statements were available to be issued.

Note C - Information Prepared and Certified by the Plan Custodian

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Capital Bank and Trust Company (the "custodian" of the Plan), for the years ended December 31, 2024 and 2023.

Note D - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Note D - Fair Value Measurements (Continued)

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commissions. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market funds: Fair values are estimated to approximate deposit account balances, payable on demand.

Note E – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contribution accounts.

Note F – Tax Status

The IRS has determined and informed the Plan Committee by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; there are currently no audits for any tax periods in progress.

Note G – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note H - Related-Party Transactions

The Plan investments are held, invested and maintained by Capital Bank and Trust Company, the Plan custodian. The custodian also performs recordkeeping services for the Plan. These transactions qualify as party-in-interest transactions. The fees for these services paid by the Plan were approximately \$4,510 for the year ended December 31, 2024.
