The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

NOTE 1: DESCRIPTION OF PLAN

The following description of Enterprise Associates LLC 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined-contribution plan established on January 1, 1992 to provide retirement and other related benefits to all employees of Enterprise Associates, LLC (the "Company"). The Plan covers all full-time employees who are age 18 or older and have been employed with the Company for at least three months, except for those who are leased employees or nonresident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions: Each year, participants may contribute an amount up to 90% of their pretax annual compensation, as defined in the Plan, subject to limits imposed by the Internal Revenue Code ("IRC"). The Plan allows for both pre-tax and after-tax Roth contributions. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions as prescribed by Treasury regulations. Participants, with the consent of the Plan Administrator, may deposit amounts received from any other retirement plan which satisfy the tax rules for rollovers.

Upon meeting the eligibility requirements of the Plan, employees will be automatically enrolled in the Plan with participant contributions equal to 2% of an employee's compensation, unless instructed otherwise by the employee. Effective April 1, 2024, the automatic deferral rate increased to 3%.

Employer Contributions: Employer matching and profit-sharing contributions are discretionary and the amount of such contributions for a Plan year shall be set prior to the end of the Plan year. In order to share in the employer matching contributions an employee must be employed on the last day of the Plan year. To share in the profit-sharing contribution an employee must be employed on the last day of the Plan year and have completed one year of service. For the year ended December 31, 2024, the Company made a matching contribution of 25% of a participant's contributions up to 4% of their compensation. There was no profit-sharing contribution for the year ended December 31, 2024.

Participant Accounts: Each participant's account is credited with the participant's contributions and Plan earnings or losses and charged with an allocation of administrative expenses, if any. Allocations of participant earnings (losses) are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Investment Options: Participants direct the investment of contributions into various investment options offered by the Plan. The Plan also allows for self-directed brokerage accounts for which the participant is responsible for any investment decisions made on the brokerage account.

NOTE 1: DESCRIPTION OF PLAN (CONTINUED)

Vesting: A participant is 100% vested in their rollover contributions, deferral contributions, qualified non-elective contributions, and any earnings thereon. Employer matching and profit-sharing contributions and earnings shall be vested in accordance with the following vesting schedule:

Less than 2 Years of Service	0%
After 2 Years of Service	20%

After 4 Years of Service	60%

Notes Receivable from Participants: Participants may borrow a minimum of \$1,000 and a maximum of the lesser of 50% of their vested account balance or \$50,000. Interest rates on these loans are at prime plus 1% and the interest rates for outstanding loans currently range from 4.25% to 9.50%. Loans must be repaid within five years, unless the loan is taken for the purchase of a primary residence. Participants repay principal and interest through payroll deductions. If participants terminate or retire, they will have the choice of repaying the loan or having the loan offset from their account. The offset loan amount will be considered a taxable distribution.

Payment of Benefits: Benefits may be distributed to participants upon termination of employment by reason of retirement (65 years or older), disability, death, or other separation from service. Participants who terminate employment and have an account balance less than \$7,000 will receive a lump sum distribution of their benefits. A participant may also request a withdrawal upon attainment of age 59½, or upon demonstration by the participant to the Plan Administrator that the participant is suffering from a hardship, as defined in the Plan document. Participants may also withdraw any portion of their account attributed to rollover contributions at any time.

Plan Expense Reimbursement Account: The Plan maintains a plan expense reimbursement account (“PERA”) with the recordkeeper, ADP Retirement Services, which is funded through revenue-sharing credits and other administrative reimbursements received from certain investment options offered under the Plan. Amounts in the PERA are used to pay allowable plan expenses, such as recordkeeping, audit, and compliance fees, or may be applied to reduce participant administrative charges in accordance with the Plan’s provisions and applicable Department of Labor guidance.

Amounts credited to the PERA are recorded as “Other income” in the Statement of Changes in Net Assets Available for Benefits when received. Disbursements from the PERA to pay plan expenses are reflected as administrative expenses in the same statement. The PERA balance is held in the Plan’s common/collective trust and is included in plan assets in the accompanying financial statements. The account is not participant-directed. During 2024, \$43,277 was used to fund Plan expenses.

NOTE 1: DESCRIPTION OF PLAN (CONTINUED)

Forfeited Accounts: The forfeited non-vested account balance may be used to pay administrative expenses and any remaining amounts can be used to reduce future employer contribution. Forfeited non-vested accounts totaled \$29,808 and \$14,318 at December 31, 2024 and 2023, respectively. During 2024, \$6,296 of forfeited amounts were used to reduce employer contributions.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). The financial statements and supplemental schedule have been prepared to satisfy the reporting and disclosure requirements of ERISA.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, trustees and other parties involved with the Plan. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Use of Estimates: The preparation of financial statements in conformity GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties: The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statements of net assets available for benefits.

Payment of Benefits: Benefit payments to participants are recorded when paid.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Uncertain Tax Positions: GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Excess Contributions Refundable: Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The excess participant contributions were returned to the applicable Participants prior to March 15 of the following year.

NOTE 3: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate it at any time subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE 4: TAX STATUS

The IRS has determined in its opinion letter dated October 6, 2020, that the non-standardized prototype plan document of Automatic Data Processing, Inc, adopted by the Plan, constitutes a qualified trust under Section 401(a) of the IRC and is exempt from federal income taxes under provisions of Section 501(a). The Plan has been amended since the date of this letter; however, the Plan Administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

NOTE 6: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access at the measurement date.

Level 2 - inputs other than quoted market prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs that are unobservable for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There has been no change in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common stocks and exchange-traded funds: Valued at the closing price reported on the active market on which the individual securities are traded.

Interest-bearing cash (bank sweep accounts): Represents uninvested cash held in self-directed brokerage accounts that is automatically swept into interest-bearing deposit accounts at one or more financial institutions. The fair value approximates cost due to the short-term nature and liquidity of the deposits.

Common/collective trust: Valued at the NAV of units of a collective trust. The NAV, as provided by the fund manager, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
