**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Appalachian Wood Floor 401k Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for more complete description of the Plan's provisions.

General

Effective January 1, 2019, the board of directors of Appalachian Wood Floor, Inc. (the Company) adopted the Appalachian Wood Floor, 401k Retirement Plan, a defined-contribution, 401(k) deferred plan. Employees of the Company and employees of participating affiliates (Fifty-Seven Floors, LLC, AWF Transport, LLC, Graf Custom Logistics LLC and Graf Custom Lumber, LLC) become eligible for participation in the Plan after having completed six months of consecutive service and attainment of age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan's steering committee, which includes the Plan's administrator, oversees governance of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions and Forfeitures

Each year participants may contribute up to 60% of pretax annual compensation, as defined in the Plan. A participant may designate savings as before-tax savings, Roth IRA deferral, or any combination of the two. Employee rollover and catch-up contributions are also permitted. The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3%. The amount of a participant's contributions for any Plan year may not exceed certain limits which are set forth in the Plan and the Internal Revenue Code (the "Code"). The Company makes tiered basic matching contributions as follows: 100% match on the first 3% of deferrals and 50% match on deferrals between 3% and 5%. There is no match on deferrals in excess of 5%. In addition, the Company may make contributions for a plan year designated as "qualified Non-Elective Contributions".

Forfeited nonvested accounts totaling \$41,719 were used to reduce employer contributions during the Plan year ended December 31, 2024, in accordance with the Plan document.

Participant Accounts

Each participant's account is credited with the participant's contributions; the Company's matching contributions and an allocation of investment earnings and administrative expenses, if any.

Participant Accounts (continued)

Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may make changes of investment fund allocations on a daily basis.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's tiered basic matching contribution portion of their accounts, plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after 2 years of credited service. Vesting in the Company's qualified non-elective contribution, plus earnings thereon is based on years of continuous service. A participant's vesting is based on a graded vesting schedule and is 100% vested after 6 years of credited service.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions into thirty-three investment options.

The Options are listed, in the enrollment information provided during orientation and changes in investment options are timely provided to the plan participants.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$600 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance with only one loan permitted. Loan terms range from 1 to 5 years or no more than 30 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined by the plan administrator. Interest rates on outstanding participant loans are 5¼%-9%. Principal and interest are paid ratably through weekly payroll deductions.

Payment of Benefits

On termination of service due to retirement, disability, or death, a participant will become 100% vested in his or her account and may elect to receive either a lump sum payment or periodic payments, subject to certain provisions. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution or periodic payments, subject to certain provisions. Participants with an account balance of less than \$5,000 at termination of service, are required to take a lump-sum distribution, or roll the balance of the account to an IRA.

A participant's beneficiary will receive the participant's account balance in the event of a participant's death.

In Service Distributions

Hardship withdrawals are available to Plan participants for the various reasons as described in the Plan documents. Hardship withdrawals are limited to the pre-tax deferral portion of the participants account balance. Upon making such a withdraw, the participant is suspended from making deferrals for six months.

Employees who have reached the age of 59½ years old may withdraw all or a portion of their vested contributions.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make certain estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates and assumptions.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value as determined by the Plan's administrator, using market quotations and other available information. Securities are valued at the last reported sales price on the last business day of the Plan's fiscal year. The value of the investments in the collective trusts fund is based on the contractual terms of the underlying agreement which provides a daily mil-rate for income accretion. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade – date basis. Interest income is recorded on an accrual basis. Dividend income is recorded on the ex – dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Participant contributions and the employer matching contributions are recognized when the participant contributions are withheld from the participant's earnings. The Company's policy is to make the contribution of participant withholding and company match timely, normally within five business days of payroll withholding.

Payments of Benefits

Benefits are recorded when paid to participants or beneficiaries.

Operating Expenses

All expenses of maintaining the Plan including third party record keeping are paid by the Company.

Allowance for Credit Losses – Notes Receivable from Participants

The allowance for credit losses is a valuation account that is deducted from, or added to, the note receivable from participants amortized cost basis to present the net amount expected to be collected on the loan. Loans are charged off against the allowance when management believes the uncollectibility of a loan balance is confirmed.

Management estimates the allowance balance using relevant available information, from internal and external sources, relating to past events, current conditions, and reasonable and supportable forecasts. Historical credit loss experience provides the basis for the estimation of expected credit losses. Adjustments to historical loss information are made for changes in environmental conditions, such as changes in unemployment rates, collateral values, or other relevant factors. Management has determined there is no requirement to provide an allowance for credit loss because the loans are secured by the balance in the participant's account.

Allowance for Credit Losses – Investments

Management assesses the financial condition and near-term prospects of the issuer, industry and/or geographic conditions, credit ratings as well as other indicators at the individual security level. Impairments below cost in the estimated fair value of individual securities when there is an intent to sell or for which it is more likely than not the Plan will be required to sell before the impairment is recovered, are realized in other income in the statement of changes in net assets available for benefits. When there is not an intent to sell or it is more likely than not the Plan will not be required to sell the security before the impairment is recovered, management assesses whether the decline in fair value has resulted from credit losses or other factors. If the present value of discounted cash flows expected to be collected is less than the amortized cost basis, credit loss exists and an allowance for securities credit losses is recorded. Such losses are limited to the amount that amortized cost exceeds fair value, even if the amount of the credit loss is greater. Any future changes in the allowance for credit losses is recorded as provision for (reversal of) credit losses. Losses attributable to other factors are charged to net appreciation (depreciation in fair value of investments).

Mutual Funds are carried in the financial statements at fair value and Common/Collective Trust Funds are measured at net asset value, and both realized and unrealized gains and losses are included net increase (Decrease) in net assets.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available. The Plan's Administrator assigns levels and categories to the Plan's investments.

Level 1 - Quoted prices in active markets for identical assets at the measurement date. The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

Level 2 - Observable inputs other than quoted prices for the asset, either directly or indirectly observable, that reflect assumptions market participants would use to price the asset based on market data obtained from sources independent of the plan. This may include matrix pricing, yield curves and indices. No level 2 inputs were available to the Plan.

Level 3 - Unobservable inputs that reflects the plan's own assumptions about the assumptions market participants would use to price an asset based on the best information available in the circumstances. No level 3 inputs were available to the Plan.

The assets or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Collective Trust:** The fair value of the investments in the collective trust fund, Invesco Stable Asset Fund-ADPZ Class (Fund) is based on the contractual terms of the underlying agreement which provides a daily mil-rate for income accretion. The primary investment objective of the fund is to seek the preservation of principal and to provide interest income reasonably obtained under prevailing market conditions and rates, consistent with seeking to maintain required liquidity.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's policy is to recognize transfers into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no transfers into or out of Level 3.

**NOTE 4 – RELATED PARTY TRANSACTIONS**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The plan sponsor directly pays various administrative and third-party record keeping expenses for the Plan. Certain administrative functions are performed by the officers and employees of the Company (who may also be participants in the Plan) at no cost to the Plan. These transactions are not deemed prohibited party-in-interest transactions because they are covered by the statutory or administrative exceptions from the Internal Revenue Code's and ERISA's rules on prohibited transactions.

**NOTE 5 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**NOTE 6 – TAX STATUS**

The Department of the Treasury, Internal Revenue Service (IRS) has determined and informed the ADP, LLC, by a letter dated October 6, 2020, that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA and related trust are designed in accordance with applicable sections of the Internal Revenue Service Code (IRC). The Plan has been amended, since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The plan operates under a Non-Standardized Defined Contribution Pre-Approved Plan adoption agreement in connection with a pre-approved retirement plan and trust/custodial documents sponsored by ADP, LLC. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter.

However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator has analyzed the tax position taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by tax authorities, however, there are currently no audits for any tax period in progress.

**NOTE 7 – INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The plan administrator has elected the method of compliance permitted by ERISA Section 103 (a)(3)(C) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 – FORFEITED ACCOUNTS**

At DECEMBER 31, 2024 AND 2023, unallocated forfeitures of non-vested accounts were \$6,664 and \$75, respectively.

**NOTE 10 – BENEFITS ALLOCATED TO WITHDRAWN PARTICIPANTS**

At December 31, 2024 and 2023, there were no amounts due to participants who have withdrawn from the Plan and requested benefit payment prior to year-end.

**NOTE 11 – SUBSEQUENT EVENTS**

Plan management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 3, 2025, which is the date the financial statements were available to be issued.

**NOTE 12 – CARES ACT AND SECURE ACT**

The Plan implemented certain requirements by the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), which laws change the Plan to, among others, allow certain eligible individuals to receive coronavirus-related relief for loan repayment, suspend required minimum distributions, and delay the commencement date for required minimum distributions. The applicable features within these Acts have been implemented. Written amendments to the Plan to reflect these operational changes will be adopted at a later date, due to the extension of the December 31, 2025 amendment requirement, in accordance with applicable law and IRS guidance.
