Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the

purpose of expressing an opinion on the effectiveness of Standard Concrete Products, Inc. 401(k) Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are condition or events, considered in the aggregate, that raise substantial doubt about Standard Concrete Products, Inc. 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal-control related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental schedule of Form 5500 - Schedule H - Part IV, Item 4i - Schedule of Assets (Held at Year End) as of December 31, 2024, is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

STANDARD CONCRETE PRODUCTS, INC. 401(k) PLAN

NOTE A -- DESCRIPTION OF THE PLAN

The following description of the Standard Concrete Products, Inc. 401(k) Plan provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan, established by Standard Concrete Products, Inc. (Sponsor), covering all employees of Standard Concrete Products, Inc, Mason H. Lampton and Lampton Holdings, Inc. (effective April 1, 2024) with the exception of union employees, nonresident aliens and leased employees, who are age twenty-one (21) or older. Employees are eligible to participate as of the first day of the month after two months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended. The trustees oversee governance of the Plan and determine the appropriateness of the Plan's investment offerings, monitor investment performance and report to the Plan Sponsor's Board of Directors.

Contributions: Each year, participants may elect to defer up to 80% of their compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a collective trust as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a deferral rate set at 2% of eligible compensation. Contributions are automatically invested in a designated balance fund until changed by the participant. The Sponsor may make a discretionary contribution in the form of a matching contribution or a discretionary profit-sharing contribution on the employee's behalf. The Sponsor's discretionary match is equal to the participant's deferral, up to \$2,500 and \$1,500 in 2024 and 2023, respectively. Sponsor discretionary contributions are invested based on the participant's elections. Contributions are subject to statutory limitations.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's discretionary matching contribution, (b) the Company's discretionary profit-sharing contribution and (c) Plan earnings (losses) and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based upon participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions, employer matching contributions and profit-sharing contributions, plus actual earnings thereon.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the vested balance in the participant's account and bear an interest rate ranging from 4.25% to 9.50%. Principal and interest is paid ratably through monthly payroll deductions for salaried employees and through weekly payroll deductions for hourly employees.



NOTES TO FINANCIAL STATEMENTS - Continued

NOTE A -- DESCRIPTION OF THE PLAN - Continued

Payment of Benefits: On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account. For termination of service for other reasons, the full value of the participant's vested account shall be payable if the participant consents or his account is \$5,000 or less. If the participant fails to consent to the distribution of his account and his account exceeds \$5,000, he shall receive a lump-sum payment of his account at normal retirement age as defined in the Plan document.

NOTE B -- SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements are presented using the accrual basis of accounting.

The collective trust investment invests primarily in guaranteed investment contracts or funding agreements, security-backed investment contracts, separate accounts issued or wrapped by insurance companies, banks or other financial institutions, or externally managed stable value commingled investment funds. The fund may also invest in high-quality money market instruments. The investment contracts are non-transferable but provide for benefit-responsive withdrawals by plan participants at contract value. Contract value represents invested principal plus contractual interest earned thereon, less participant withdrawals and administrative expenses. Contract value is the relevant measurement attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from these estimates.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Delinquent participant loans are recorded as a benefit payment based on the terms of the Plan document. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

Receivables: The Plan believes that receivables are fully collectible and that no allowance for credit losses is needed.

Investment Valuation and Income Recognition: Investments are reported at fair value, except for fully benefit-responsive contracts which are reported at contract value (See Note I). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net

appreciation includes the Plan's gains and losses on investments bought and sold, as well as those held during the year.

Payment of Benefits: Benefits are recorded when paid.

Operating Expenses: All administrative expenses of maintaining the Plan are paid either by the Sponsor or from Plan assets, at the option of the Sponsor. During 2024 and 2023 the Plan paid a portion of its administrative expenses. Fees related to the administration of notes receivable from participants and withdrawals are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Date of Management's Review: The Plan has evaluated subsequent events through the date of the auditor's report which is the date when the audited financial statements were available to be issued.

NOTE C -- FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

- Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.
- Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.
- Level 3: Inputs that are unobservable inputs and have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are only used when Level 1 inputs are not available. Level 3 inputs would only be used in level 1 or level 2 inputs were not available. There are no Plan assets requiring the use of level 2 or 3 inputs for the periods presented.



NOTES TO FINANCIAL STATEMENTS - Continued

NOTE C -- FAIR VALUE MEASUREMENTS - Continued

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds: Values at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the US Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following table sets forth, by level within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

NOTE D -- INVESTMENT AND CONTRACT INFORMATION CERTIFIED BY THE TRUSTEE

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends earned and interest earned on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

NOTE E -- RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds or investment contracts which are managed by Reliance Trust Company. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.



NOTES TO FINANCIAL STATEMENTS - Continued

NOTE F – TERMINATION OF PLAN

Although it has not expressed any intent to do so, the Sponsor reserves the right to discontinue contributions or to terminate the Plan at any time subject to provisions of ERISA. Upon termination of the Plan, the participants shall become fully vested and receive the value of their accounts after payment of Plan expenses.

NOTE G -- INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan sponsor and the third-party administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. No tax liabilities for uncertain positions have been recorded in the accompanying Statements of Net Assets Available for Benefits. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE H -- RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the accompanying Statements of Net Assets Available for Benefits.

NOTE I -- COMMON COLLECTIVE TRUST – STABLE VALUE FUND

The Plan has invested in a stable value investment fund (Fund) that meets the criteria of a fully benefit-responsive investment contract and is therefore reported at contract value. Contract value represents contributions made to the Fund, plus earnings, less participant withdrawals. The Fund is comprised of a portfolio of short-term investments, traditional guaranteed investment contracts issued by an insurance company or other financial institution, synthetic investment contracts and wrap contracts that provide for participant transactions to be executed at contract value. Short-term investments are valued at contract value which approximates cost plus accrued interest which approximates fair value. Traditional guaranteed investment contracts are valued at contract value which represents principal plus accrued interest earned. These investments

are not tradable on a secondary market but provide for benefit-responsive withdrawals by plan participants at contract value. Synthetic investment contracts consist of security-backed guaranteed investment contracts (SBIC) which represent individual assets placed in a trust, with ownership by the Fund; a third-party issues a wrap contract that provides for participant transactions to be executed at contract value. Individual assets of the synthetic investment contract are valued at fair value, on the basis of valuations furnished by Trustee-approved independent pricing services. SBIC's consist of investment-grade fixed income securities, owned by the Fund, which are "wrapped" by an insurance company, bank or other financial institution. The underlying securities of SBIC's may be either held-to-maturity or securities that may be bought and sold during the life of the contract. Under specified circumstances, the wrap provides for benefit payments to the Fund for the benefit of plan participants at contract value.

The wrap contracts amortize the realized and unrealized gains and losses on the underlying bonds over the duration of the underlying bonds through adjustments to the future interest crediting rates. The crediting rates are designed to produce a return experience over time equal to the cumulative market return on the covered assets net of fees, but without the day-to-day fluctuations in value typically associated with fixed income securities. Primary variables impacting future crediting rates of the Fund include level of market interest rates over time, amount of timing of plan and participant contributions, transfers and withdrawals into and out of the contract, investment returns generated by the bonds backed by the wrap contracts and the duration of the underlying investments backed by the contracts. Because changes in market interest rates affect the yield to maturity and the market value of the underlying bonds, they can have a material impact on the contracts' crediting rates. To the extent that the Fund has unrealized and realized losses, the future interest crediting rates will be lower over time than the current yield of the portfolio to account for this loss. If the portfolio generated realized and unrealized gains, future crediting rates will be higher over time than the current yield of the portfolio and the investor currently redeeming the Fund's units may forego any benefit related to future crediting rates higher than the current yields of the portfolios. The level and timing of contributions allocated to, and withdrawals from the wrap contracts affect the crediting rates and can result in different crediting rates than would be the case if the level and timing of contributions and withdrawals were different. All wrap contracts provide for a minimum crediting rate of zero percent. In the event that a crediting rate should fall to zero, and participant withdrawals from the contract occur that exhaust the market value of the underlying portfolio that is being wrapped, the wrap issuers will pay the Fund the shortfall needed to maintain the crediting rate at zero. This is intended to protect the participant's principal and accrued interest.

There are no reserves against contract value for credit risk of the contract issuers or otherwise. The contract value of the Fund and the underlying investment contracts at December 31, 2024 and 2023, was \$1,320,519 and \$1,075,616, respectively. All of the contracts that the Fund purchases are benefit responsive at contract value for all plan permitted, participant-directed transactions. There are no exceptions to this stipulation. Due to the size of the Fund and the specific percentage allowances negotiated by the Fund, it is highly unlikely that any event would occur that would limit the Fund's ability to transact at contract value with each issuer.

Participant directed withdrawals from the contracts are paid at the contract value. These events include transfers to other Plan investment options and payments because of retirement, termination of employment, disability and death and in-service withdrawals as permitted by the Plan.

Certain events may limit the ability of the Fund to transact at contract value or may allow for the termination of the wrapper contract at less than contract value. Such events include the following: (a) participant withdrawals based on advice or direction from the plan sponsor, administrator or other agent of the foregoing, (b) changes to the Plan's prohibition on competing investments, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, complete or partial termination of the plan sponsor or merger of plans) that cause a significant withdrawal from the Plan, (d) any plan withdrawal other than a participant-directed withdrawal, (e) a failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (f) the establishment of a defined contribution plan that competes for employees contributions. Furthermore, certain events would allow the issuers to terminate the contracts with the Plan and settle at amounts different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation.
