We have performed audits of the financial statements of **Two Brothers Brewing Company and Affiliates 401(k) Profit Sharing Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### 1. Description of Plan

The following brief description of the Two Brothers Brewing Company and Affiliates 401(k) Profit Sharing Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** – The Plan is a Section 401(k) defined contribution plan with salary deferral provisions which was established on January 1, 2009. The Plan's participating employers are Two Brothers Brewing Company, Two Brothers Coffee Roasters, Two Brothers Restaurant Group, LLC, and Arizona Beer & Cider Co. (collectively known as the Company). Under the Plan, all nonunion, non-leased employees of the Company who are not non-resident aliens, are eligible to participate in the Plan starting on the first day of the Plan quarter following completion of one year of eligibility service and the attainment of age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** – Pre-tax or post-tax deferred savings contributions in the form of salary reductions by participants are allowed. The amount contributed is determined by the participant, subject to statutory limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Participants are automatically enrolled in the Plan with a 6% pre-tax deferral, and their contributions are invested in a designated target fund until changed by the participant.

The Company may make a discretionary matching contribution equal to a uniform percentage or dollar amount of participant elective deferrals each payroll period. The Company will match employee contributions in an amount equal to 25% of the first 4% of participant's eligible compensation per payroll period, for a maximum employer matching contribution of 1% of participant's eligible compensation per payroll period. The Company may also make an annual discretionary profit sharing contribution in an amount determined by its owners. The Company did not make a discretionary profit sharing contribution in 2024.

**Participants' Accounts** – Each participant's account is credited with the participant's contributions, an allocation of the Company's contributions, and gains and losses from the investment funds elected. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – A participant is fully vested in participant contributions, plus actual earnings, gains and losses thereon, at all times. Vesting in the Company's discretionary matching contribution portion of their accounts is as follows:

Number of Completed Years of Service	Portion of Balance of Account Vested
Less than two years	0%
Two years but less than three years	20%
Three years but less than four years	40%
Four years but less than five years	60%
Five years but less than six years	80%
Six or more years	100%

**Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at 1 percent above the prime rate, as defined. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits** – A participant's account balance may be withdrawn upon retirement, death, disability, or termination of employment as defined by the Plan. Benefits are payable in either a single lump-sum amount or installment payments equal to the value of the participant's account. In-service withdrawals from transfer accounts, distributions after age 59½ and hardship distributions are also allowed by the Plan.

**Forfeited Accounts** – At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,832 and \$765, respectively. These accounts will be used to reduce future employer contributions or pay Plan expenses. For the year ended December 31, 2024, \$14,746 of non-vested accounts were used to pay Plan expenses.

**Plan Termination** – Although the Company has not expressed any intent to terminate the Plan, it may do so at any time. The termination of the Plan is subject to the provisions of ERISA. In the event of Plan termination, all account balances as of the date of termination shall be payable to the participants and beneficiaries.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting** – The accompanying financial statements have been prepared on the accrual basis of accounting.

### **2. Summary of Significant Accounting Policies (cont'd)**

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 4 for discussion of fair value measurement).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits** – Benefits are recorded when paid.

**Expenses** – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Plan Amendment** – On March 27, 2020, President Trump signed into law the Coronavirus Aid, Relief, and Economic Security Act, (CARES Act). As a result, changes were made related to Plan withdrawals and loans to participants, for impacted participants, their spouse and dependent(s) who have been diagnosed with virus SARS-CoV-2 or with COVID-19, as well as participants that have experienced adverse financial consequences. The changes applicable to the Plan are summarized below:

- Impacted participants may receive up to \$100,000 in aggregate withdrawals before December 31, 2020.
- 10% penalty tax for early withdrawal is waived before December 31, 2020.
- Mandatory 20% withholding on distributions will not apply before December 31, 2020.
- No limit to the number of withdrawals an impacted participant can make before December 31, 2020.
- Repayment of withdrawal amount is permitted if repayment occurs within three years of the distribution for withdrawals taken before December 31, 2020.
- Impacted participants may borrow up to the lesser of \$100,000 or 100% of their vested balance for 180 days beginning March 27, 2020.
- Impacted participant loan payments due from March 27, 2020 through December 31, 2020, including those due following a severance from employment, may be delayed for one year.
- Required Minimum Distribution (RMD) rules for distributions required for the 2020 calendar year were temporarily waived.

On August 3, 2022, the IRS issued Notice 2022-33, which extends the deadlines for qualified retirement plans to adopt amendments reflecting certain optional and required changes under the SECURE, CARES, and Miners Acts. Plan sponsors of defined contribution plans generally now have until December 31, 2025, to amend their plans if they took advantage of benefit changes permitted by these laws, including changes allowed by the CARES Act as part of COVID-19 relief.

The Plan will formally adopt an amendment to address these changes at a later date in accordance with applicable law and IRS guidance.

**3. Information Prepared and Certified by Custodian**

The Company, acting in its capacity as the Plan administrator, has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **4. Fair Value Measurements**

Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) 820, "Fair Value Measurements and Disclosures," provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

**Level 1** – Valuations are based on unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.

**Level 2** – Valuations are based on quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in markets that are not active; and model-derived valuations whose significant inputs are observable.

**Level 3** – Valuations are based on unobservable inputs for the asset or liability that reflect the reporting entity's own data and assumptions that market participants would use in pricing the asset or liability. These unobservable inputs are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**4. Fair Value Measurements (cont'd)**

Investments recorded at fair value are exclusively mutual funds that are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. These assets are categorized in Level 1 of the fair value hierarchy.

**5. Related-Party and Party-in-Interest Transactions**

Certain Plan investments are managed by American Funds. American Funds is the recordkeeper for the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan made direct payments to the Capital Bank and Trust Company of \$22,446, including \$14,746 from forfeited non-vested accounts as described in Note 1. The Capital Bank and Trust Company is the custodian as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. The Company pays directly any other fees related to the Plan's operations.

**6. Tax Status**

The Plan has adopted a CCH Incorporated Volume Submitter 401(k)/Profit Sharing Plan. The Internal Revenue Service has determined and informed CCH Incorporated, by a letter dated June 30, 2020, that the Volume Submitter 401(k)/Profit Sharing Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving a determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by federal and state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
