### Independent Auditor’s Report

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Sterling Management, Ltd. 401(k) Plan (the Plan), an Indiana employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). ### Note 1: PLAN DESCRIPTION

The following description of Sterling Management, Ltd. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution retirement savings plan, established October 1, 1985. The Plan is sponsored by Sterling Management, Ltd. (the Employer) for the benefit of its employees who have attained 19 years of age and have completed 90 days of service, excluding those employees covered by a collective bargaining agreement, leased employees, and non-resident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - Each year, participants may contribute up to 100% of their eligible wages, as defined in the Plan, not to exceed maximum limits allowed by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified benefit plans (rollovers). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Employer may make matching contributions of participant deferrals at its discretion, as well as discretionary profit-sharing contributions.

For the years ended December 31, 2024 and December 31, 2023, the Employer elected to make matching contributions to the Plan of 25% of employee contributions up to a maximum of 10% of compensation. For the years ended December 31, 2024 and December 31, 2023, the Employer did not elect to make a profit-sharing contribution. Contributions are subject to certain limitations.

The Plan follows Financial Accounting Standards Board's (FASB) Accounting Standards Codification (ASC) Topic 326 – *Financial Instruments – Credit Losses*. The standard requires recognition of an allowance that reflects a current estimate of credit losses expected to be incurred over the life of the asset. As of December 31, 2024 and December 31, 2023, there were no allowances for uncollectible receivables for either year end.

**Participant Accounts** - Each participant's account is credited with the participant's contribution and allocation of the Employer's contribution and Plan earnings and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or contributions or account balances, as defined. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

**Vesting** - Participants are immediately vested in their deferral and rollover contributions and earnings. Vesting in the remainder of their accounts is based on years of continuous service based on a graduated schedule over 6 years of service.

**Plan Benefits** - Upon termination of service due to retirement, death, or disability, a participant is entitled to 100% of his or her account balance regardless of years of service. For termination of service for other reasons, a participant will receive an amount equal to the value of the participant's vested interest in his or her account. Hardship withdrawals are permitted under the Plan from all participant accounts.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. However, the \$50,000 amount in the preceding sentence is reduced by the highest outstanding loan balance the participant had under the Plan during the previous one-year period. Interest income from participant loans was \$9,660 and \$4,651 for the years ended December 31, 2024 and December 31, 2023, respectively. Participant loans are valued at the amortized cost of the loans as the loans are secured by each respective participant's account balances.

**Forfeited Accounts** - During the years ended December 31, 2024 and December 31, 2023, forfeited non-vested amounts of \$52,203 and \$38,104 were used to reduce employer matching contributions. As of December 31, 2024 and December 31, 2023, forfeited non-vested employer account balances were \$-0- for both years.

**Plan Termination** - Although it has not expressed any intent to do so, the Employer has the right to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become fully vested in their accounts.

### Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Significant accounting policies followed by the Plan are listed below:

**Basis of Accounting** - The accompanying financial statements are prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Risks and Uncertainties** - The Plan provides for certain investment options. Investment securities are exposed to various risks, such as interest rate, market, liquidity, and credit risks. Due to the level of risk associated with certain investment securities and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

**Payment of Benefits** - Benefits are recorded when paid.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and December 31, 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Administrative Expenses** - Administrative expenses may be paid by the Employer or the Plan, at the Employer's discretion.

### Note 4: FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation of other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following is a description of the valuation methods and assumptions used by the Plan to estimate the fair values of investments. There have been no changes in the methodologies used at December 31, 2024 and December 31, 2023.

Pooled separate accounts: The fair value of the participation units owned by the Plan is based on the net assets of the underlying pool of securities on the last business day of the Plan year. The net asset value is used as the practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5: TAX STATUS

In a letter dated November 30, 2020, the Internal Revenue Service (IRS) has determined and informed that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is subject for a period of three years from the date the Form 5500 was filed.

**Note 6: PARTY-IN-INTEREST TRANSACTIONS**

Party-in-interest is defined under the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. All professional fees for the administration and audit of the Plan are paid by the Plan or the Employer. Fees paid by the Plan during the years ended December 31, 2024 and December 31, 2023, for services rendered by parties-in-interest, as defined by ERISA, were based on contractual and reasonable rates for their services.

Certain Plan investments were invested in funds managed by John Hancock Life Insurance Company U.S.A (“JH”). JH was the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Additionally, the Plan held notes receivable from participants totaling \$141,877 and \$70,809 at December 31, 2024 and December 31, 2023, respectively, which qualify as party-in-interest transactions.

**Note 7: INFORMATION CERTIFIED BY THE PLAN’S CUSTODIAN**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.
