## Independent Auditor's Report

To the Administrator of the Dartmouth Health 403(b) Plan:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

- the information in the accompanying financial statements related to assets which provide benefits under the plan and certified to by qualified institutions and assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### ***Other Matter - Supplemental Schedule Required by ERISA***

The supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the certified information in the supplemental schedule related to assets which provide benefits under the plan and certified to by qualified institutions and assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**(1) Description of Plan**

The following brief description of the Dartmouth Health 403(b) Plan (the "Plan" or the "403(b) Plan") is provided for general information only. Participants should refer to the plan document for more complete information.

**(a) General**

The Plan is a defined contribution plan sponsored by Dartmouth-Hitchcock Health ("D-HH") covering substantially all employees of the participating employers. Participating employers consist of Mary Hitchcock Memorial Hospital and the Dartmouth-Hitchcock Clinic, Visiting Nurse Association and Hospice of Vermont and New Hampshire, Mt. Ascutney Hospital and Health Center, Cheshire Medical Center, New London Hospital Association, Inc., and Alice Peck Day Memorial Hospital. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

**(b) Eligibility**

All employees of D-HH and participating employers are eligible to participate in the Plan.

**(c) Contributions**

Contributions to the Plan consist of employee voluntary tax deferred and after-tax "Roth" amounts, up to 100% of pay, but not to exceed the annual limits prescribed by the Internal Revenue Service (IRS). All eligible employees and new hires are automatically enrolled in the Plan with a pre-tax deferral contribution of 4% unless they sign a waiver indicating they do not wish to participate in the Plan or elect to contribute a greater percentage. The default percentage will increase annually by 1% up to a maximum of 10%. Participants who have attained the age of 50 are allowed to make catch-up contributions not to exceed the annual limits prescribed by the IRS. Rollover tax deferred balances from a previous employer's 403(b) or 401(k) plan are also permitted.

Employer contributions consist of the following:

Employer Base Contributions – As of the end of each pay period, an employer base contribution is allocated to each participant employed on that date. The amount of contribution allocated to each participant is a percentage of the participant's compensation. Effective January 1, 2020, participants who elected the new plan design and eligible employees who become participants after December 31, 2019, receive an employer base contribution equal to 4% of the participant's compensation, except for participants of Visiting Nurse Association and Hospice of Vermont and New Hampshire, Inc. and Mt. Ascutney Hospital and Health Center who receive a base contribution equal to 2% of the participant's compensation. Participants who elected the old plan design receive a contribution percentage determined by a formula which takes into consideration the participant's age and years of vesting service.

Employer Matching Contributions – Effective January 1, 2020, participants who elected the new plan design and eligible employees who become participants after December 31, 2019, receive an employer matching contribution equal to 50% of each participant’s before tax and after-tax contributions subject to a maximum limit equal to 4% of the participant’s compensation, except for participants of Visiting Nurse Association and Hospice of Vermont and New Hampshire, Inc. who are subject to a maximum limit equal to 2% of the participant’s compensation. Participants who elected the old plan design are not eligible to receive a matching contribution.

**(d) Participant Accounts**

Each participant’s account is credited or charged with contributions, investment income, and investment transaction and redemption fees. Investment income, including realized and unrealized gains and losses, and expenses are allocated to participants’ accounts based on each participant’s account balance within each fund. Participants determine the percentage in which contributions are to be invested in each fund. Participants may change their investment options as set forth in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**(e) Vesting**

*Participant contributions* - Participants are always 100% vested in their own contributions, eligible rollovers, and earnings thereon, to the Plan.

*Employer contributions* - A year of vesting service is one in which the participant works 1,000 hours or more.

Participants employed at Cheshire Medical Center and New London Hospital Association, Inc. become 100% vested in employer contributions and earnings thereon upon completion of three years of vesting service.

Participants employed at Mt. Ascutney Hospital and Health Center and Alice Peck Day Memorial Hospital become 100% vested in employer contributions and earnings thereon upon completion of six years of vesting service at a rate of 20% a year.

Participants employed at Visiting Nurse Association and Hospice of Vermont and New Hampshire are 100% vested in their accounts at all times.

**(f) Forfeitures**

When certain terminations of participation in the Plan occur, the nonvested portion of the participant’s account represents a forfeiture, as defined by the Plan. Forfeited balances are first used to restore re-employed participants’ accounts. Any remaining forfeitures may be used to pay plan expenses or to reduce company contributions. During 2024, \$928,490 of forfeitures were used to reduce company contributions. Unallocated forfeitures at December 31, 2024 and 2023 were \$1,246,261 and \$548,694, respectively.

**(g) *Payment of Benefits***

Upon termination of service (retirement, death or disability), participants may elect to leave their account balance in the Plan or receive a distribution. The following options are available to those electing a distribution: 1) a lump sum or partial distribution; 2) payments in installment amounts over monthly 10, 15, or 20 year intervals; 3) through periodic installments of a specified dollar amount.

A participant may also request a withdrawal upon attainment of age 59 1/2 or upon demonstration by the participant to the plan administrator that the participant is suffering from "hardship", as defined in the plan document. A participant may also request a withdrawal from rollover funds at any time.

**(h) *Notes Receivable from Participants***

Participants may borrow against their own accounts an aggregate amount up to the lesser of \$50,000 or 50% of the participant's vested account balance, subject to plan limitations. All new loans must bear the Prime interest rate plus 1%. Loans transferred into the Plan were set at reasonable rates per their previous plan administrators' policy. All loans must be repaid within five years unless the proceeds are used to acquire a principal residence, in which case a longer repayment period is allowed. Only one loan may be outstanding at any time.

Principal and interest is generally repaid at least quarterly by participants directly to the plan recordkeeper. During the repayment period of a loan, the Plan's recordkeeper reallocates the repayment amounts among the investment funds in the same proportion as current investment allocations.

**(i) *Contributions***

Contributions from plan participants and participating employer contributions are recorded in the year in which the participant contributions are withheld from compensation.

**(2) *Summary of Significant Accounting Policies***

**(a) *Basis of Accounting***

The accompanying financial statements have been prepared using the accrual basis of accounting.

**(b) *Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**(c) *Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**(d) *Payment of Benefits***

Benefits are recorded when paid.

**(e) *Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**(f) *Administrative Expenses***

All expenses of administering the Plan may be paid by the Plan, unless paid by D-HH (Plan Sponsor) or one of its participating employers. Investment transaction and redemption fees are born by plan participants. Expenses that are paid by D-HH (Plan Sponsor) or one of its participating employers are excluded from these financial statements.

**(3) Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- *Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2* - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- *Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used by the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts* - Invested in cash and mutual funds valued at the net asset value of the shares held by the Plan at year end as determined by quoted market prices.

*Variable annuity contracts* - Valued at the net asset value of units of a variable annuity. The net asset value, as provided by the contract issuer, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

- (1) In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

Variable annuity contracts have no restrictions on redemptions for participant initiated transactions for The Variable Annuity Life Insurance Company, however there is a 30 day notification for Metropolitan Life Insurance Company variable annuities. There are no unfunded commitments.

Accounting standards require disclosure of investment strategies for investments valued using net asset value as a practical expedient to estimate fair value if the investment does not file a Form 5500 with the DOL as direct filing entity (“DFE”). The following table discloses investment strategies for such investments:

- (a) The growth variable annuity seeks a favorable long-term rate of return, mainly through capital appreciation, primarily from a diversified portfolio of common stocks that present opportunity for exceptional growth.
- (b) The blend variable annuity pursues long-term capital appreciation by investing in undervalued companies that show strong potential for growth.
- (c) Moderate allocation variable annuities seek maximum aggregate rate of return over the long-term through controlled investment risk by adjusting investment mix among stocks, long-term debt securities and short-term money market securities.
- (d) Bond variable annuities seek total possible returns through current income and capital gains on investments in intermediate and long-term debt instruments and other income producing securities.
- (e) Value variable annuities seek capital growth by investing in common stocks. Income is a secondary objective.
- (f) International variable annuities seek high total return through long-term growth of capital and current income.
- (g) Target date variable annuities seek the highest total return over time consistent with an emphasis on both capital growth and income.
- (h) Health variable annuities pursue long-term capital appreciation by investing in foreign stock, and common stock of companies in health-related industries (a sector fund).

- (i) The money market variable annuity invests in high-quality debt securities and seeks to maximize current income consistent with liquidity and preservation of capital.
- (j) Technology variable annuities seek long-term capital appreciation by investing in foreign securities, and exchange traded funds.
- (k) The long government variable annuity invests primarily in direct government obligations, which are backed by the full faith and credit of the U.S. government.

**(4) Investment At Contract Value**

The Plan has traditional investment contracts with Transamerica Life Insurance Company, Principal Life Insurance Company and Lincoln National Life Insurance Company, The Variable Annuity Life Insurance Company, Metropolitan Life Insurance Company, American General Life Insurance Company and United of Omaha Life Insurance Company.

The contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. With traditional investment contracts, the Plan owns only the contract itself. These contracts are designed to accrue interest based on crediting rates established by the contract issuers.

For the Transamerica Life Insurance Company contracts, participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Interest rates are reviewed on an annual basis for resetting. The minimum crediting interest rate is 1.00%.

For the Principal Life Insurance Company, participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Interest rates are reviewed on an annual basis for resetting. The minimum crediting interest rate is 1.00%.

For the Lincoln National Life Insurance Company, participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Interest rates are reviewed on a quarterly basis for resetting. The minimum crediting interest rate is 1.00%.

For The Variable Annuity Life Insurance Company contracts, participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value ratably over five years. In the event a shorter redemption period is required a participant will receive the lesser of the contract value or fair value of their portion of the investment. Participant level withdrawals may be subject to a 5% surrender fee to any withdrawals that exceed 10% of the account balance. Interest rates are reviewed on an annual basis for resetting. The minimum crediting interest rate is 2.00%.

Metropolitan Life Insurance Company may delay paying any cash withdrawals from the Fixed Interest Account for up to six months. There are no surrender charges for withdrawals. Interest rates are reviewed on a quarterly basis for resetting. The minimum crediting interest rate is 3.00%.

For the American General Life Insurance Company contracts, participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no surrender charges for withdrawals. Interest rates are reviewed on an annual basis for resetting. The minimum crediting interest rate is 3.00%.

The traditional investment contracts held by the Plan are guaranteed investment contracts. The contract issuers are contractually obligated to repay the principal and interest at specified interest rates that are guaranteed to the Plan. The contracts do not have a maturity date. There are no reserves against contract value for credit risks of the contract issuer or otherwise.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that would limit the ability of the Plan to transact at contract value with the participants. The Plan mergers did not impact the ability to transact at contract value.

**(5) Tax Status**

The Plan has adopted a plan document intended to comply with section 403(b) of the IRC. The plan administrator believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for income taxes has been recorded in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(6) Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, and interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company, the trustee of the Plan, and The Variable Annuity Life Insurance Company, Reliance Trust Company, Fidelity Management Trust Company, Metropolitan Life Insurance Company, American General Life Insurance Company and United of Omaha Life Insurance Company, the custodians of the Plan.

**(7) Plan Termination**

D-HH intends to continue the 403(b) Plan indefinitely; however, the 403(b) Plan is voluntary on the part of D-HH, and D-HH reserves the right to modify or terminate the 403(b) Plan at any time. In the event of plan termination, participants will become 100% vested in their account balances.

**(8) Related-Party and Party in Interest**

Section 3(14) of ERISA defines a party in interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, loans to participants and the management of investments held by the trustee and custodians are considered party in interest transactions.

**(9) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of the investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**(10) Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.
