## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of Bell Automotive Network 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Bell Automotive Network 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

***(1) Description of the Plan***

The following description of Bell Automotive Network (the "Company") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

**General** - The Plan is a defined contribution 401(k) plan covering all eligible employees in the New Jersey location who have twelve months of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act ("ERISA"). Effective December 2016, the Vermont locations in the Bell Automotive Network instituted immediate entry in the Plan on day one of employment. The Administrative Committee is charged with oversight of the Plan.

**Contributions** - There are three types of contributions that can be made to the Plan: voluntary salary reductions, employer contributions and rollover contributions. Voluntary salary reductions are limited in accordance with federal tax regulations. Participants may contribute up to fifteen percent (15%) of pretax compensation as defined in the plan, for each plan year payroll period. The Plan permits eligible employees to make voluntary salary reductions not to exceed an amount set by law. The maximum salary reduction allowed for the calendar years 2024 and 2023 is \$23,000 and \$22,500, respectively. Participants of at least 50 years of age may contribute an additional \$7,500 and \$7,500 of compensation for 2024 and 2023, respectively. Participants may also contribute amounts representing rollovers from other qualified plans. These contributions are 100% vested and will automatically be invested in accordance with the participant investment election. For the year ended December 31, 2024, there were no rollover contributions from qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make matching contributions in any plan year based on a percentage declared for that year by the Company. In addition, the Company may make other contributions to the plan, which is totally discretionary, in any plan year. The Company has made elective contributions of \$263,525 for the year ended December 31, 2024.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and an allocation of the Company's contribution and investment earning or losses. Investment earnings or losses are allocated based on the ratio an individual's account bears to the total account balances of all participants in the same investment.

**Vesting** - Funds held in the voluntary reduction account and rollover contribution account belong to the eligible employees and are non-forfeitable. The funds in the employer contribution account are vested fully after six years.

All participants are 100% vested upon retirement, death, or becoming disabled, or if the Plan is terminated.

**Notes Receivable from Participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal or lesser of \$50,000 or 50 percent (50%) of their account balance. The loan term will not exceed five years, with the exception of personal residence loans, which will be determined by the administrator considering the maturity dates quoted by representative commercial banks in the local area for a similar loan. The notes are secured by the balance in the participant's account and bear rates which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions. The interest rate on outstanding notes range from 4.25% to 9.50%. Notes due from participants totaled \$234,888 and \$262,255 as of December 31, 2024 and 2023, respectively.

***(1) Description of the Plan (Continued)***

***Payment of Benefits*** - Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, as described in the Plan provisions. Additionally, the Plan allows for withdrawals of vested amounts prior to termination provided certain criteria are met.

***Forfeitures*** - Upon termination of employment participants forfeit their unvested balances. In the case of death and full disability, the Plan allows for 100% vesting. Forfeited balances of terminated employees' nonvested accounts can be used to reduce future Company matching contributions or to pay administrative expenses of the Plan, as determined by the Company at its sole discretion. Unallocated forfeiture balances for the years ending December 31, 2024 and 2023 were \$94,676 and \$70,111, respectively.

***(2) Summary of Significant Accounting Policies***

***Basis of Accounting*** - The financial statements of the Plan are prepared on the accrual basis of accounting.

***Adoption of New Accounting Standard*** - Effective January 1, 2023, the Plan adopted ASC 326 which changed how entities will measure credit losses for certain financial assets that aren't measured at fair value through changes in net assets available to benefits. The most significant change in this standard is a shift from the incurred loss model to the expected loss model. Under the standard, disclosures are required to provide users of the financial statements with useful information in analyzing the Plan's exposure to credit risk and the measurement of credit losses. The primary financial asset held by the Plan that are subject to the guidance in ASC 326 is employers' contributions receivable. The impact of the adoption was not considered material to the financial statements and primarily resulted solely in enhanced disclosures.

On July 30, 2025, the FASB issued Accounting Standards Update (ASU) 2025-05, Financial Instruments—Credit Losses (Topic 326): Measurement of Credit Losses for Accounts Receivable and Contract Assets. This standard allows entities to elect a practical expedient that assumes that current conditions as of the fiscal year-end do not change for the remaining life of the asset. In addition, the standard provides for consideration of subsequent collections in developing reasonable and supportable forecasts as part of estimating expected credit losses. The Plan elected to early adopt this standard in the reporting period ended December 31, 2024.

***Use of Estimates*** - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedules. Accordingly, actual results could differ from those estimates.

***Investment Valuation and Income Recognition*** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information principally provided by the Plan's trustee, as described in Note 4.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***(2) Summary of Significant Accounting Policies (Continued)***

***Notes Receivable from Participants*** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

***Payment of Benefits*** - Benefits are recorded upon distribution.

***Administrative Expenses*** - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The Plan may charge to the account of an individual participant an amount to offset the cost of making a distribution.

***Subsequent Events*** - The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

***(3) Information Certified and Provided by Nationwide Trust Company (Unaudited)***

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended included throughout the Plan's financial statements and supplemental schedules that was prepared by, or derived from, information provided by Nationwide Trust Company (the "Custodian") and furnished to the plan administrator. The plan administrator has obtained certifications from the custodian that information provided to the plan administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information in Notes 4 and the supplemental schedule which appears throughout the financial statements and supplemental schedule related to the following assets:

***(4) Fair Value Measurements***

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

***(4) Fair Value Measurements (Continued)***

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the methodology used for assets measured at fair value. There have no changes in the methodologies used by December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Transfers Between Levels** - The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

The Plan evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

***(5) Transactions with Related-Parties and Parties-in-Interest***

Certain plan investments are shares of pooled separate accounts managed by Nationwide Trust Company. Nationwide Trust Company is the trustee and custodian of the plan assets as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

***(6) Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested and the total amount in each participants account would be distributed to the participants. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed pursuant to the Plan document.

***(7) Tax Status***

The underlying standardized prototype profit-sharing plan has received an opinion letter from the Internal Revenue Service ("IRS") dated March 1, 2008, stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code (the "IRC") and therefore the related trust is tax exempt. The Plan has been amended since receiving the opinion letter. The plan administrator has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and therefore believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

***(8) Risks and Uncertainties***

***Investment Risk*** - The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

***(9) Delinquent Transactions***

During 2024, the Company failed to timely remit certain employee deferrals to the Plan aggregating \$18,075. The Company subsequently has computed the lost earnings on these deferrals and has deposited the delinquent contributions as well as a contribution for the lost earnings to the Plan.

***(10) Transfer of Net Assets***

During the year ended December 31, 2024, the Plan transferred out \$380,884 of net assets for participants of a division of the Company that was sold in 2023.
