The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Deferred Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Echo, Inc. Deferred Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Echo, Inc. Deferred Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1: Description of Plan

The following brief description of the Echo, Inc. Deferred Savings Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined-contribution plan covering substantially all United States employees of Echo, Incorporated and its subsidiaries (collectively referred to as the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Covered employees of the Company are eligible to participate in the Plan upon completing three months of service, attaining 21 years of age, and enter the Plan at the next January 1st, April 1st, July 1st, or October 1st, following the date on which these requirements are met, as defined by the Plan. Effective January 1, 2024, long-term part-time employees who have not previously entered the Plan, but have attained at least 500 hours of service in at least three consecutive years beginning after December 31, 2020, are eligible to participate in the Plan.

Contributions

Participants may make elective contributions from 0.5% to 100% of eligible compensation, as defined by the Plan, in the form of payroll deductions as a percentage of eligible compensation or a flat dollar amount, not to exceed the maximum amount allowable under applicable income tax regulations. Participants can choose to have their elective contributions made as pre-tax contributions or as after-tax Roth contributions. Employees who meet the eligibility requirements to participate in the Plan and either do not elect to contribute or do not elect to decline to contribute are automatically enrolled in the Plan at a 6% pre-tax elective contribution rate at their entry date and their contributions are invested in PIMCO Horizon Fund based on their age at retirement until changed by the participant. In addition, catch-up contributions may be made by eligible participants who have attained age 50 before the end of the Plan year in accordance with Internal Revenue Service regulations. The Plan also allows for rollover contributions from other qualified plans, as defined by the Plan.

The Plan provides for the Company to make safe harbor matching contributions on a monthly basis to eligible employees in an amount equal to the sum of 100% of the first 4% of eligible compensation, and 50% of the next 2% of eligible compensation, up to a maximum 5% safe harbor matching contribution. For the year ended December 31, 2024, the Company made safe harbor matching contributions of \$2,577,794. In addition, the Plan allows for a Company discretionary non-elective contribution to be made to eligible employees. For the year ended December 31, 2024, the Company made qualified non-elective contributions of \$113,084.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Vesting

Participants are immediately vested in their elective, catch-up and rollover contributions, and earnings thereon.

Participants vest in their Company safe harbor matching contributions upon completing two years of credited service, as defined by the Plan, at which time they become fully vested in those contributions and earnings thereon.

Participants vest in their Company discretionary non-elective contributions on a graduated basis based on years of credited service, as defined by the Plan, and are fully vested after five years of credited service.

Forfeitures

Forfeitures, if any, are used to reduce future Company contributions or pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$11,195 and \$9,732, respectively. During the year ended December 31, 2024, Company contributions were reduced by \$44,752 from forfeited nonvested accounts.

Investments

Participant account balances from all contribution sources are held in a custodial account at Charles Schwab Bank. Participants direct the investment of their account balance into several mutual funds and collective trust funds which are currently offered as investment options by the Plan.

Distribution of Benefits

A participant is entitled to the vested value of his/her account balance at the normal retirement age (65), upon termination of employment, death, or total disability. Benefits are paid to a participant or his/her beneficiary in the form of an annuity or if elected, in a lump sum payment.

Notes Receivable From Participants

The Plan allows each participant to borrow from their elective and rollover contributions and earnings thereon a minimum of \$1,000 and a maximum of \$50,000, reduced as defined in the Plan, or 50% of their vested account balance. The loans bear interest at a reasonable rate and are payable in equal installments by payroll deduction over a period not to exceed five years, unless the participant's loan is for the purchase of a principal residence which can be repaid over a period not to exceed 30 years. Loans are funded by a withdrawal from the participant's own account. Interest rates on notes outstanding at December 31, 2024, ranged from 4.25% to 10.50% with maturities from 2025 to 2054.

Note 1: Description of Plan (Continued)

In-Service Withdrawals

The Plan allows for in-service withdrawals of a participant's rollover contributions limited to once per year and in-service withdrawal by participants who have attained age 65 from their elective contribution accounts. Former TerraMarc participants shall have the right to withdraw all or part of the vested balance in their TerraMarc transferred balance accounts at any time on or after attainment of age 59-1/2. In addition, the Plan allows for hardship withdrawals from a participant's elective contributions for specific situations as defined by the Plan.

Participant Accounts

Each participant's account is credited with the participant contributions, Company safe harbor matching contributions, and allocations of (a) the Company's discretionary non-elective contributions and, (b) Plan earnings or losses. Participant accounts are charged with withdrawals, if any, and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, contributions, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Plan Termination

Although it has expressed no intent to do so, the Company has the right under the Plan, in certain circumstances, to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, participants will immediately become fully vested in their Company contributions.

Secure 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Note 2: Summary of Significant Accounting Policies (Continued)

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of changes in net assets during the reporting period. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. The net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowances for credit losses have been recorded as of December 31, 2024 and 2023. Determination as to when participant loans are considered in default and reclassified as distributions is based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Management fees for investments are deducted from income earned on a daily basis and, therefore, reflected as a reduction of investment income. By agreement with the Plan's Trustee, revenue sharing received by the Trustee from these management fees will be used to pay any fees of the Trustee and the remaining amount will be deposited to the Plan. These amounts will be used by the Plan Administrator to pay other administrative expenses of the Plan. Fees specific to individual participant activity, such as loan fees, are charged directly to the participant's account and are included in administrative expenses. Any expenses incurred in connection with the administration of the Plan which are paid by the Company are excluded from these financial statements.

Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.

Note 3: Information Prepared and Certified by the Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments at fair value and non-interest bearing cash held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained or derived from information and supplied to the Plan Administrator and certified as complete and accurate by Charles Schwab Trust Bank, the Trustee, to the Plan.

Note 4: Fair Value Measurements

The framework for measuring fair value provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable for the asset or liability.

The following is a description of the valuation methodologies used to measure assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Note 4: Fair Value Measurements (Continued)

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds - Fair value is estimated using net asset value (NAV) as provided by the administrator of the fund as a practical expedient. NAV is determined by using the estimated fair values of the underlying assets held in the fund at year-end. The use of NAV as fair value is deemed appropriate since the collective trust funds allow for daily redemption and do not have a finite life, unfunded commitments relating to this type of investment, or significant restrictions on redemptions.

Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023:

Note 5: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.

Note 6: Party-in-Interest Transactions

Certain Plan assets are investments in investment funds managed by Charles Schwab Bank, the Trustee of the Plan, and therefore transactions with respect to these assets qualify as party-in-interest transactions. In addition, the Plan pays certain expenses related to Plan operations and investment activity to various service providers. These transactions also qualify as party-in-interest transactions. Fees paid to the various service providers were \$45,993 for the year ended December 31, 2024 and are recorded as administrative expenses in the accompanying statement of changes in net assets available for benefits.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 7: Tax Status

The Company adopted a non-standard pre-approved Plan document with an IRS notification letter which states the Plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan Administrator believes that the Plan, as amended, is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.
