### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Tri-Star Imports 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note (3) to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### (1) Description of plan

The following description of the Tri-Star Imports 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### (a) General

The Plan is a defined contribution plan which was adopted to provide retirement benefits for employees of Tri-Star Imports, Inc. (the "Employer"). The Plan covers substantially all employees who have completed one year of credited service and are age 21 or older ("participants"). Eligible employees can begin participating in the Plan on the first day of every calendar quarter of the plan year when the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). 401K Safe, LLC, the plan trustee, is responsible for oversight of the Plan.

#### (b) Contributions

Participants may voluntarily make qualified retirement contributions to the Plan which are deductible for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC") or may be made after-tax in the form of a Roth 401(k) contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participant contributions are permitted up to 100% of compensation subject to certain IRC limitations.

The Plan automatically enrolls all employees at a deferral rate of 3%, unless the employee elects not to participate in the Plan or elects otherwise. Each enrolled employee's deferral percentage will automatically increase 1% per year, to a maximum of 10% unless the employee elects otherwise.

During 2024 and 2023, the Employer made discretionary matching contributions equal to 100% of the participant's eligible compensation up to 3%.

The Plan also provides that the Employer may contribute each year a discretionary profit sharing amount; however, such profit sharing contributions by the Employer are not required. No discretionary profit sharing contributions were made by the Employer during 2024 or 2023.

Employer and participant contributions may not exceed the maximum amount allowable for income tax purposes.

(c) Participant accounts

Each participant's account is credited (charged) with the participant's contributions, allocations of Employer contributions, investment earnings (losses) of the investment options elected by the participant, and an allocation of administrative expenses. Allocations are based on participant's compensation or account balances as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

(d) Vesting

Participants are immediately vested in their elective salary deferral contributions plus actual earnings (losses) thereon. Vesting in the Employer's discretionary matching contributions and discretionary profit sharing contributions is based on years of continuous service. Participants are fully vested after six years of credited service under a graded vesting schedule.

Participants may also become 100% vested upon full or partial termination of the Plan, or in one of the following ways, if incurred while employed: (1) death or (2) disability.

(e) Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes receivable from participants are secured by the balance in the participant's account and bear interest at fixed rates ranging from 5.25% to 10.50% as of December 31, 2024, which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are collected ratably through payroll deductions.

(f) Payment of benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum payment equal to the value of the participant's account. For termination of service due to other reasons, a participant will be entitled to receive the value of the vested interest in his or her account as a lump sum distribution.

(g) Forfeited accounts

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Employer contribution portion of their accounts. These accounts will be used to reduce future Employer contributions. Forfeited accounts totaled \$16,496 and \$16,585 as of December 31, 2024 and 2023, respectively. Administrative expenses were reduced by \$44,125 from forfeited nonvested accounts in 2024 Employer contributions were reduced by \$33,145 from forfeited nonvested accounts in 2023.

(h) Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and the processing of distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

(i) Plan changes

Effective January 1, 2025, the Employer restated the Plan. As part of the restatement of the Plan employees become eligible immediately at age 21 or older, and may begin contributions the first of the month following eligibility.

(j) Plan termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Employer contributions.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

(b) Investment valuation and income recognition

Investments are stated at fair value, except for the fully benefit-responsive guaranteed investment contract, which is reported at contract value (see Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note (4) for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan agreement.

(d) Payment of benefits

Benefits are recorded when paid.

(e) Use of estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(f) Events occurring after reporting date

Plan management has evaluated events and transactions that occurred between December 31, 2024 and October 13, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certain information related to investments and notes receivable from participants reported and disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), including the fair value (or contract value) of investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate. The certifications were provided by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company ("Principal") for the period from February 15, 2024 through December 31, 2024 and as of December 31, 2024 and Lincoln Financial Group Trust Company, Inc. ("Lincoln") as of and for the year ended December 31, 2023 and for the period from January 1, 2024 through February 15, 2024.

### (4) Fair value measurements

Fair value is a market-based measurement, not an entity-specific measurement. Therefore, a fair value measurement should be determined based on the assumptions that market participants would use in pricing the asset or liability. As a basis for considering market participant assumptions in fair value measurements, fair value accounting standards establish a fair value hierarchy that distinguishes between market participant assumptions based on market data obtained from sources independent of the reporting entity including quoted market prices in active markets for identical assets (Level 1), or significant other observable inputs (Level 2) and the reporting entity's own assumptions about market participant assumptions (Level 3).

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

- (i) *Mutual funds*: Valued based on the funds' reported closing net asset values of shares held by the Plan as of the last business day of the plan year. The mutual funds are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan holds mutual funds totaling \$6,887,830 and \$7,204,570 as of December 31, 2024 and 2023, respectively, which are classified as Level 1 investments in the fair value hierarchy.

### (5) Investment contract with insurance company

The Plan has entered into a guaranteed investment contract with an insurance company, Principal Life Insurance Company ("Principal Life") as of December 31, 2024. The guaranteed investment contract is considered fully benefit-responsive. Principal Life maintains the Plan's contributions in a general account which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract was \$1,150,366 as of December 31, 2024.

The Plan had entered into a guaranteed investment contract with an insurance company, Lincoln National Insurance Company ("Lincoln National") as of December 31, 2023. The guaranteed investment contract was considered fully benefit-responsive. Lincoln maintained the Plan's contributions in a general account which was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract was \$1,049,259 as of December 31, 2023.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan,) (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Employer or Employer events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

The investment contract does not permit Principal to terminate the agreement prior to the scheduled maturity date.

#### (6) Income tax status

The Employer adopted a pre-approved profit sharing plan which received a favorable opinion letter on June 30, 2020, in which the Internal Revenue service ("IRS") stated that the pre-approved plan was in compliance with the applicable requirements of the IRC. The Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator believes that the Plan is designed, as amended, and is currently being operated, in compliance with the applicable provisions of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Untimely remittance of participant contributions

The Employer is required by the Department of Labor regulations to remit participant contributions as soon as practicable. For certain contributions withheld from payrolls during 2024 and 2023, the funds were not remitted timely. The untimely remittances withheld from 2024 and 2023 payrolls, were remitted during 2024 and 2023, however, imputed lost earnings applicable to these contributions are being calculated and will be contributed to the Plan.

(8) Related party and party-in-interest transactions

The Plan holds a guaranteed investment contract by Principal Life and, therefore, these transactions qualify as party-in-interest transactions under ERISA. As described in Note 1, the Plan paid expenses to various service providers and holds participant notes receivable which also qualify as party-in-interest transactions.
