Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed audit of the financial statements of CCC Retirement Savings Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits – modified cash basis as of December 31, 2024, and the related statement of changes in net assets available for benefits – modified cash basis for the year then ended, and the related notes to the financial statements (2024 Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the 2024 Financial Statements section

- the amounts and disclosures in the accompanying 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of accounting

We draw attention to Note B of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting as described in Note B, and for determining the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements for the 2024 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



Their report dated June 27, 2024, indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, was presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

NOTE A | DESCRIPTION OF PLAN

The following description of the CCC Retirement Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

1. General

The Plan is a defined contribution plan sponsored by Community Counseling Center (Plan Sponsor). The Plan became effective on January 1, 2014, was most recently amended October 19, 2021 to allow for in-service withdrawals for participants that have reached 59.5 years of age. Individual benefits from this plan will be based on the vested portion of the individual account, which is comprised of the portion of the salary which an individual elects to defer, any contributions made by the employer during the years of participation, plus any earnings credited to the individual account. Employees may start participating immediately upon hire in the elective salary deferral provision of the Plan. If the employee does not otherwise make an election they will be automatically enrolled at 3% of compensation escalating 1% per year until reaching 15%. Employees are eligible for employer contributions on the first day of the calendar month after being employed for twelve months and completing 1,000 hours of service within a twelve month period and is switched to a calendar year after the first year of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Contributions

For each plan year, eligible participants may elect to defer 100% of their compensation up to the maximum determined by law on a pretax or after tax/Roth elective deferral basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan Sponsor matching contribution as defined by the Plan is 167% of the participants’ elected deferral percentage not to exceed 3% of covered compensation up to a maximum of \$5,000. In 2024 and 2023, the Company made matching contributions of \$491,228 and \$405,478, respectively. Participants may also contribute amounts representing distributions from other qualified retirement plans.

Participants direct the investment of all contributions into various investment options offered by the Plan and can change their investment allocations daily.

3. Participant Accounts and Allocations

Each participant's account is credited with the participant's contribution, the employer contribution and allocations of plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, or specified participant transactions, as defined, whichever is deemed more appropriate by the plan administrator. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested amount.

4. Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Employees vest 20% per year after completing two years of service until becoming 100% vested after six years of credited service in accordance with the Plan document, or immediately if employment is terminated due to death, disability, or retirement upon the attainment of age 65. A year of service is defined as 1,000 hours of service in a Plan year. Employees hired prior to January 1, 2020 are immediately 100% vested.

5. Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000 less the highest outstanding loan balance during the previous twelve month period. The loan is limited to five years or up to 30 years for a primary residence loan. The loans are secured by the participant's account and bear interest at prime interest rate plus 1 point. Principal and interest is paid ratably through payroll deductions, but not less frequently than quarterly. The maximum number of loans outstanding is two (one general and one residential).

6. Payment of Benefits

Upon termination of service due to death, disability, retirement (65), or other reasons, a participant may elect to receive an amount equal to the value of the participants' vested interest in his or her account. Upon death, disability or reaching normal retirement while employed, a participant's account balance becomes fully vested. The Plan allows for in-service distributions at age 59 1/2 and hardship distributions from certain accounts.

NOTE A | DESCRIPTION OF PLAN

If the participant's total vested account balance does not exceed \$5,000, the participant's vested account balance may be distributed automatically in a lump sum. If the total vested account balance equals or exceeds \$5,000, participants may elect to receive a lump sum equal to the value of their vested account balance or an installment payment. Death benefits paid to beneficiaries must be paid no later than the end of the year that contains the 5th anniversary of the participant's death in a lump sum payment.

7. Forfeiture Accounts

At December 31, 2024 and 2023, forfeited nonvested amounts totaled \$6,827 and \$5,678, respectively. Forfeitures may be used to reduce the employer contributions, reinstate forfeitures or pay Plan expenses. In 2024 and 2023, forfeited accounts were not used to reduce the employer's matching contribution or pay Plan expenses.

8. Ease Account

The ease account is used to pay Plan expenses, including annual audit fees. A portion of participant quarterly investment earnings are credited to the ease account and are based on the Plan's estimation of applicable fees for the Plan during the current year. At December 31, 2024 and 2023, the ease account totaled \$24,150 and \$48,806, respectively. In 2024, \$37,450 was used to reduce Plan expenses.

NOTE B | SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the significant accounting policies applied in the preparation of these financial statements follows.

1. Basis of Accounting

The financial statements are prepared on the modified cash basis of accounting which is a comprehensive basis of accounting other than generally accepted accounting principles. Under the modified cash basis of accounting, revenues are recorded when received as opposed to when earned and expenses are recorded when paid rather than when they are incurred. Investments are stated at fair market value.

2. Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE B | SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

3. Investment Valuation and Income Recognition

The Plan's investments (except for fully benefit responsive investment contract, which is reported at contract value) are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and in the principal and most advantageous market for the asset or liability. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded when declared. Dividends and capital gains paid by the pooled separate accounts are reinvested. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the modified cash basis of accounting. The Plan deems all participant notes receivable to be fully collectable; therefore, no allowance for credit losses is required. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.

5. Payment of Benefits

Benefits are recorded as paid.

6. Administrative Expenses

Administrative expenses are paid for by the Plan and Plan Sponsor. Certain investment related expenses are included in the net appreciation of investments.

7. Reclassifications

Certain reclassifications have been made to the prior year financial statements to conform to current year presentation.

8. Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

NOTE C | SUMMARY OF FINANCIAL INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the Plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Voya Retirement Insurance and Annuity Company the custodian and record keeper for the Plan, except for comparing such information to information included in the Plan’s financial statements and supplemental schedule.

The following is a summary of the unaudited information regarding the Plan at December 31, 2024 and 2023, and for the years then ended, included in the Plan’s financial statements and supplemental schedule that was obtained from data that has been prepared and certified to as complete and accurate by the Plan’s custodian.

NOTE D | FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE D | FAIR VALUE MEASUREMENTS

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. The level of certain investments has changed to reflect management's updated understanding of the investments. See Note K for additional details.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts invest directly in designated mutual funds. The separate account holds the underlying mutual fund which are valued daily at their net asset value (NAV). The Plan and participants hold units of participation in the separate account. The accumulation unit value (AUV) is based on the NAV of the shares of mutual funds held, the fund's dividends less any contract charge. These investments are not deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E | INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan holds a fully benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents participant withdrawals, and administrative expenses. The value of this account was \$700,788 and \$633,564 at December 31, 2024 and 2023, respectively.

NOTE E | INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without consent of the issuer.

NOTE F | PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

NOTE G | PLAN TAX STATUS

The Plan Sponsor has adopted a pre-approved 403(b) plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2017, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

NOTE G | PLAN TAX STATUS

Modified cash basis of accounting requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the U.S. Department of Labor or Internal Revenue Service.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE H | RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan sponsor provides certain accounting and administrative services to the Plan for which no fees are charged. These transactions are exempt party-in-interest transactions.

The Plan auditors are considered a party-in-interest. Audit fees paid by the Plan totaled \$37,450 and \$47,990 for the year ended December 31, 2024 and 2023, respectively.

Voya Retirement Insurance and Annuity Company administers the contract, provides investments to the Plan participants and receives fees and commissions which totaled \$47,606 and \$68,426 for the year ended December 31, 2024 and 2023, respectively. These administrative fees were related to the administration of the Plan and were paid by the Plan. These transactions qualify as party-in-interest transactions.

Plan participants may borrow from their account balances. These loans are classified as notes receivable from participants in the statement of net assets available for benefits. Notes receivable from participants totaled \$106,846 and \$75,241 for the years ended December 31, 2024 and 2023, respectively.

NOTE I | RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I | RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Investments included the following pooled separate accounts representing approximately 47% of the total investments at December 31, 2024 and 45% at December 31, 2023. A significant decline in the market value of these investments could significantly affect the Plan's net assets available for benefits.

NOTE K | CORRECTION OF AN ERROR

During 2024, the Plan identified an error in the previously reported financial statements related to the presentation of certain investments. In prior years, investments held in fully benefit-responsive investment contracts within the general insurance account with Voya Retirement Insurance and Annuity Company should have been reported at contract value, which represents the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The correction of error has been applied retrospective to the prior period financial statements but did not result in a change in previously reported net assets available for benefits as the contract value of the related investments equals the amount that was previously reported as fair value. This correction of error did not affect participants' individual account balances or benefits and removed the related investment from the reporting in the fair value hierarchy in Note C.
