## Independent Auditors' Report

### The Plan Administrator of Grand River Navigation Shoreside 401(k) Plan

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Grand River Navigation Shoreside 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### **1. Description of Plan**

The following description of the Grand River Navigation Shoreside 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering substantially all employees of the Grand River Navigation Company, Inc. and the following related employers: Boland and Cornelius, Inc., Liberty Steamship, Lower Lakes Transportation, and Rand Logistics Inc. (collectively the "Company" or "Employer"). An employee is eligible for participation in the Plan upon attainment of age 21 or older. Leased employees, non-resident aliens, part time employees, temporary employees, seasonal employees and those regularly assigned to shipboard captain or chief engineer positions are not eligible for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### ***Contributions***

Each year, participants may elect to have a percentage deducted on a pre-tax or after-tax (Roth) basis from their eligible compensation as defined by the Plan document. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. A participant may elect to increase, decrease or suspend their contributions according to procedures established by the Company. There is an annual limit as to the amount that can be contributed that is determined by the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified plans.

In addition, the Company will make a safe harbor matching contribution on behalf of each participant in the amount of 100% of a participant's elective deferrals not to exceed 5%. The Company may also make a discretionary matching contribution and a discretionary non-elective contribution. During the year ended December 31, 2024, the Company did not make a discretionary matching contribution or a discretionary non-elective contribution to the Plan.

#### ***Vesting***

A participant is 100% vested in their accounts and Company contributions, including allocated earnings thereon at all times.

#### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum amount of \$500 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. The maximum number of loans that can be outstanding at any time is two. Participant loans are secured by the balance in the participant's account and bear interest at reasonable rate of interest as determined by the Plan Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Principal and interest is paid ratably through payroll deductions.

## 1. Description of Plan (*continued*)

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, employer contribution and allocations of Plan earnings (losses). The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement, age 59 1/2 or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

## 2. Summary of Significant Accounting Policies

### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. The Plan's investments, that were valued at fair value, were valued using Level 1 inputs.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the Net Asset Value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

### ***Investment Valuation and Income Recognition***

All of the Plan's investments are stated at fair value. Mutual funds and the money market fund are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The common/collective trusts are valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

**2. Summary of Significant Accounting Policies (continued)**

***Investment Valuation and Income Recognition (continued)***

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on an accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded upon a distributable event.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the NAV of the respective funds and, consequently, those expenses are not separately reflected but are a component of net appreciation in fair value of investments.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 14, 2025.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

***Common/Collective Trusts***

The Plan offers various common/collective trusts through Putnam and Great Gray Trust Company. The unit values are determined on a daily basis and amounts can be redeemed daily. The Plan has no unfunded commitments related to the common/collective trusts at December 31, 2024 and 2023.

**5. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

### **6. Tax Status**

The Internal Revenue Service (“IRS”) issued an opinion letter to the prototype plan document preparer, FMR LLC, dated June 30, 2020, which states that the form of the prototype plan qualifies under the applicable provisions of the Internal Revenue Code (“IRC”). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### **7. Party-in-Interest Transactions**

Certain Plan investments are managed by Fidelity. Fidelity is the trustee as defined by the Plan document and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants on the statements of net assets available for benefits.

The Plan and Fidelity Management Trust Company entered into a revenue sharing arrangement whereby a portion of the revenue earned from certain funds is passed through to the Plan for payment of permitted Plan expenses. In order for the Plan to receive credits as a result of this revenue sharing arrangement, and to use this credit to pay Plan expenses, the Plan created the Revenue Credit Account under the Plan. The Revenue Credit Account is a cash account within the Plan, similar in design to forfeiture accounts, and is used to record the redistribution of plan-generated fund revenue that exceeds the costs associated with Plan administration. The Revenue Credit Account balance was \$2,893 and \$1,242 at December 31, 2024. During 2024, no amounts were used to pay Plan expenses from the Revenue Credit Account.

### **8. Prohibited Transactions**

During the 2024 and prior Plan years, the Employer failed to remit to the Plan certain participants’ contributions and loan repayments within the period described by the Department of Labor regulations. Delays in remitting the contributions and loan repayments to the Plan were due to administrative oversight. The Employer is in the process of making the necessary corrections for the delinquent participant contributions and loan repayments totaling \$359,124 by calculating and remitting lost earnings to the Plan.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
