Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tinuiti, Inc. Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note 1. Description of Plan

The following description of Tinuiti Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General and eligibility: The Plan is a defined contribution plan established for the benefit of the employees of Tinuiti Inc. (the Company) and covers substantially all full-time employees. Ineligible employees include those that are members of a collective bargaining unit with retirement benefits, leased employees, and non-United States persons with no United States tax ID number. No minimum age or service requirement must be fulfilled to be eligible for the Plan. Eligible employees may enter the Plan at any time. The Investment Committee is responsible for oversight of the Plan investments, determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective April 1, 2023, a new trustee was appointed. The Plan assets transferred to the new trustee, Principal Trust Company, were funds comparable to those offered by the previous trustee, Empower Trust Company, LLC (formerly known as Great-West Trust Company, LLC).

Contributions: Participants may elect to contribute a specific percentage or dollar amount of their annual eligible compensation, as defined, subject to Internal Revenue Code (IRC) limitations. Participants are permitted to make pretax contributions and/or after-tax Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan provides safe harbor matching contributions equal to 100% of the first 4% of compensation deferred.

Investments: Participants may direct their salary deferral contributions plus actual earnings thereon and employer contributions to selected investments as made available and determined by the Investment Committee. Participants may change their investment options at any time.

Participant accounts: Each participant's account is credited with the participant's contributions and, if applicable, rollover contributions, the Company's matching contribution and allocations of any discretionary employer profit-sharing contributions and Plan earnings/losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their elective and rollover contributions plus actual earnings thereon. Participants are immediately vested in the Company's safe harbor matching contributions.

Forfeitures: Forfeited balances of terminated participants' nonvested accounts are used for payment of Plan expenses or to reduce employer contributions to the Plan. At December 31, 2024 and 2023, the amount of forfeited nonvested accounts was \$-0- and \$255, respectively. During 2024, no forfeitures were used to reduce administrative expenses and \$255 was used to reduce expenses related to the employer match.

Notes receivable from participants: Notes receivable from participants are available only to active employees. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000, reduced by the highest outstanding note receivable balance in the previous year, or 50% of their vested account balance, whichever is less. The notes are secured by the balance in the participant's account and bear interest at a fixed rate of prime plus 1%, which is commensurate with local prevailing rates, as determined by the Plan Administrator.

Note 1. Description of Plan (continued)

Notes receivable from participants (continued): Principal and interest are paid ratably through payroll deductions. Notes receivable outstanding at December 31, 2024, bear interest rates from 4.25% to 9.5% and mature through November 2037.

Payment of benefits: Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum distribution amount equal to his or her vested account balance, or an alternative form of payment. Participants with an account balance of less than \$5,000 will receive a mandatory lump-sum distribution upon termination of service. The Plan also provides for special distributions under certain conditions.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The accompanying financial statements are prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of estimates: The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Concentrations of Investments: Included in investments at December 31, 2024 and 2023 are units of the American Funds Target Retirement Date funds of \$58,427,629 and American Funds Target Retirement Date funds of \$49,200,503, respectively. These investments represent 73.33% and 76.27% of total investments at December 31, 2024 and 2023, respectively. A significant decline in the market value of these investments would significantly affect the net assets available for benefits.

Investment valuation and income recognition: Investments are reported at fair value, except for the fully benefit-responsive guaranteed investment contract (GIC) which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 5 for a discussion of fair value measurements. Contract value is the amount Plan participants would receive if they were to initiate permitted transactions under the terms of the Plan (see Note 5).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year. Investment-related expenses are included in net depreciation of fair value of investments.

Management fees and operating expenses charged to the Plan for investments in registered investment companies are deducted from income earned on a daily basis and are not separately reflected.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent and defaulted notes are treated as distributions based upon the terms of the Plan document.

Payment of benefits: Benefits are recorded when paid. There were no participants who elected to withdraw from the Plan, but had not yet been paid at December 31, 2024.

Administrative expenses: Administrative expenses of the Plan are paid by the Plan or the Plan Sponsor, as provided in the Plan document. Investment management fees for investments are included as a reduction of investment return and not reflected separately in the statement of changes in net assets available for benefits. Certain administrative functions applicable to the Plan are performed by officers or employees of the Company. No such officer receives compensation from the Plan. Certain other expenses may be paid by the Plan unless paid by the Company. Management fees and operating expenses are reflected as a reduction of investment returns for such investments.

Note 3. Certified Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 Code of Federal Regulations (CFR) 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. The following is a summary of the information regarding the Plan as of December 31, 2024 and 2023 and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedules that was prepared by or derived from information prepared by Principal Trust Company, trustee of the Plan and furnished to the Plan administrator. Note 4. Fully Benefit-Responsive Investment Contract

The Plan had a fully benefit-responsive investment contract with Empower Life & Annuity Insurance Company of New York (formerly known as Great West life & Annuity Insurance Company of New York). As noted in Note 1, the Plan appointed a new trustee effective April 1, 2023, and transferred all assets to the new trustee. Further, the Plan entered into a fully benefit-responsive investment contract with Principal Trust Company effective April 1, 2023. The issuer (Principal Trust Company) maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal Trust Company, the Principal Guaranteed Fund issuer, is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As the Guaranteed Investment Fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Guaranteed Investment Fund. Contract value, as reported to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the Guaranteed Investment Fund at December 31, 2024 and 2023 was \$382,535 and \$293,898, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Document (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events would limit the Plan's ability to transact at contract value.

Note 5. Fair Value Measurements and Disclosures

ASC 820, Fair Value Measurements and Disclosures, provides a framework for measuring fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Registered investment companies: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5. Fair Value Measurements and Disclosures (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6. Party-in-Interest Transactions

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. The Plan also issues loans to participants, which are secured by the vested balances in the participants' accounts. Participants also pay administrative costs for recordkeeping services, loans and distributions. The remaining expense is paid by the Company and through credits provided by the record keeper for Plan investments. The Company provides certain administrative services at no cost to the Plan. Certain administrative expenses of the Plan may be paid by the Company at its discretion. During the Plan year ended December 31, 2024, \$48,600 in expenses were paid by the Company on behalf of the Plan.

The Principal Guaranteed Fund is managed by Principal Trust Company, which is a trustee of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions. Any fees paid for investment management services were included as a reduction of the return earned on each fund.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to amend, discontinue or terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 8. Tax Status

The Plan is a Non-standardized, Pre-approved Profit-Sharing Plan with CODA developed by Principal Financial Group. The Non-standardized Pre-approved Profit-Sharing Plan with CODA document has received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS. The Plan has not been amended since receiving this determination. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Note 8. Tax Status (Continued)

Management has evaluated the Plan's tax positions and concluded that the Plan maintained its tax-exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision for income taxes has been included in the financial statements.

Note 9. Risks and Uncertainties

The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

Note 10. Non-Exempt Party-In-Interest Transactions

In the prior year, the Company remitted certain 2023 participant contributions totaling \$1,420,747 to the trustee later than required by DOL Regulation 2510.3-102. The Company will file Form 5330 with the IRS and pay the required excise tax on the transactions. However, participant accounts has been credited with the amount of investment income that would have been earned had the participant contribution been remitted on a timely basis.

Note 11. Subsequent Events

The Plan Administrator has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued, there are no subsequent events that require adjustment to or disclosure in the financial statements.
