Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of SMRT, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

2024 Supplemental Schedule Required by ERISA

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the Plan that were certified by a qualified institution. Their report dated October 8, 2024 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with U.S. GAAP, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of Plan

The following description of the SMRT, Inc. 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by SMRT, Inc. (the Company). Employees are eligible for participation in the Plan after obtaining the age of twenty-one years old and completing three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute up to 75% of their eligible compensation, as defined, to the Plan subject to certain Internal Revenue Code (the Code) limitations. In addition, participant contributions may consist of rollovers from other qualified retirement plans.

The Company is required to make safe-harbor non-elective contributions equal to 3% of eligible compensation, as defined.

The Company may elect to make discretionary matching and profit sharing contributions. A profit sharing contribution of \$164,000 was declared during 2024.

All participant and Company contributions are invested at the direction of each participant in any of the available investment options.

Vesting

Participants are immediately vested in their contributions and safe-harbor non-elective employer contributions plus actual earnings thereon. Participants become vested in all other employer contributions based on a graded vesting schedule over a period of one to three years.

Notes Receivable from Participants

Participants may borrow from their accounts a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable are secured by the balance in the participants' account and bear fixed interest at local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investments

Investments are recorded at their fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

Benefit Payments

Benefit payments are recorded when paid.

Administrative Expenses

Record-keeping, plan administration, investment advisor and, occasionally, audit fees are paid by the Plan. The Company pays most other administrative costs.

Subsequent Events

Management has considered transactions or events occurring through October 14, 2025, which is the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Fair Value Measurement

The fair value measurement accounting literature establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for the identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There were no changes in methodology used at December 31, 2024 and 2023.

Mutual funds and money market fund: Valued based on quoted market prices of shares held by the Plan at year-end.

Collective trusts: Valued at net asset value (NAV) of units held by the Plan at year-end. The NAV is used as a practical expedient to estimate fair value and is excluded from the fair value hierarchy. The NAV is based on the fair value of the underlying investments in the collective trusts.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Advisor Stable Value Fund (the Stable Value Fund), is managed by Fidelity Management Trust Company (Fidelity) as a commingled pool, seeking to preserve principal while earning a level of interest income consistent with principal preservation. The Fund strives to maintain a stable net asset value of \$1 per share although there is no guarantee it will be able to do so. The Stable Value Fund yield will fluctuate. The Stable Value Fund is invested in benefit-responsive investment contracts issued by insurance companies and other financial institutions, fixed income securities and money market funds. Under the terms of the contracts, the assets are invested in fixed income securities, including U.S. Treasury and agency bonds, corporate bonds, mortgage-backed securities, commercial mortgage-backed securities, asset-backed securities, and money market funds. The Stable Value Fund is redeemable monthly. The terms of the Stable Value Fund prohibit the Plan from making a direct exchange from this fund to a competing fund. Instead, the Plan must first exchange the funds to a non-competing fund for 90 days.

The International Equity Fund R1 (the International Equity Fund) is managed by Great Gray Trust Company, LLC (Great Gray Trust) as a collective investment trust (CIT), seeking capital appreciation by investing in the Fidelity Institutional AM International Core CIT (the Underlying Fund), for which Great Gray Trust is the trustee and FIAM LLC is the subadvisor. The Underlying Fund has a broad geographic equity mandate to invest in an equity portfolio of mostly non-U.S. companies.

4. Tax Status

The Plan is part of a prototype plan designed by Fidelity, the trustee. The Internal Revenue Service has determined and informed the trustee by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Code. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan continues to be operated in compliance with the applicable requirements of the Code.

5. Information Certified by the Trustee

The Plan's investments, notes receivable from participants and related investment transactions and interest from notes receivable were obtained by management and agreed to or derived from the information certified by Fidelity, trustee, as complete and accurate. This information is included in the following areas:

- Statements of Net Assets Available for Benefits
- Statement of Changes in Net Assets Available for Benefits
- Supplemental Schedule – Schedule of Assets (Held at End of Year)

6. Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds, a money market fund, and collective trusts managed by Fidelity which serves as the trustee to the Plan. Therefore, transactions with Fidelity qualify as party-in-interest transactions. Fidelity reimbursed the Plan for the fees and expenses associated with services provided to the Plan through revenue credits and the net amount credited back to the Plan through administrative expenses was \$36,877 for the year ended December 31, 2024.

Additionally, investment advisor fees of \$32,000 and third-party administrator fees of \$7,139 were paid by the Plan during 2024 and are included in administrative expenses.

7. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants become fully vested in their employer contributions.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
