## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator of  
MDU Resources Group, Inc. Retiree Health and Welfare Benefits Program

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of MDU Resources Group, Inc. Retiree Health and Welfare Benefits Program (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we

have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter – Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1 - Description of Plan**

The following description of the MDU Resources Group, Inc. Retiree Health and Welfare Benefits Program (the Plan) provides only general information.

**General**

The Plan provides health and certain other benefit protection for eligible retirees of MDU Resources Group, Inc. and any of its affiliates that participate in the Plan (collectively, the Company). The Plan is funded through the MDU Resources Group, Inc. Retiree Benefit Trust (the Trust) and general assets of the Company. The Trust was formed under a trust agreement dated December 30, 1993. Delaware Charter Guarantee & Trust Company, conducting business as Principal Trust Company or Principal Bank, is the Trustee for the Trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is sponsored and administered by the Company. The Company's Employee Benefits Committee (the Committee) controls and manages the operation and administration of the Plan. The Committee consists of the Chief Financial Officer of the Company and other individuals appointed by the Chief Executive Officer of the Company who are employed by the Company or an affiliate of the Company.

The Board of Directors of the Company may, at any time, amend or modify the Plan. The Company has delegated to the Committee the authority to amend or modify the Plan; however, certain amendments identified in the Plan document are subject to approval by the Board of Directors of the Company.

Although it has not expressed any intent to do so, the Board of Directors of the Company has the right under the Plan to discontinue its contributions, at any time, and to terminate the Plan subject to the provisions of ERISA. The Board of Directors or governing entities of the affiliates may, at any time, terminate participation in the Plan with respect to such affiliate. In the event of a Plan termination, the Company will contribute the necessary amounts to fund all claims incurred prior to the termination of the Plan.

At certain of the Company's businesses, employees hired after December 31, 2009, were not eligible for retiree medical benefits.

Employees who retired on or after January 1, 2011, were not eligible for Company-sponsored life insurance or accidental death and dismemberment (AD&D) insurance.

**Subsidiary Spinoffs**

On May 3, 2023, the Board of Directors of the Company voted to approve the separation of its subsidiary, Knife River Corporation (Knife River), from the Company by means of a tax-free spinoff transaction, which was completed on May 31, 2023. As a result of the spinoff, Knife River's participation in the Plan terminated effective May 31, 2023. Accordingly, the Plan re-measured the benefit obligation as of May 31, 2023 in order to transfer Knife River's actuarially determined share of the Plan's benefit obligation, totaling \$1.5 million, to the Knife River Corporation Health and Welfare Plan.

On October 2, 2024, the Board of Directors of the Company voted to approve the separation of its subsidiary, Everus Construction Group, Inc. (Everus), from the Company by means of a tax-free spinoff transaction, which was completed on October 31, 2024. As a result of the spinoff, Everus' participation in the Plan was terminated effective October 31, 2024. Everus' share of the Plan's benefit obligation was retained by the Company.

**Benefits**

The Plan provides medical, prescription, life insurance and AD&D insurance to eligible retired employees and, in some instances, eligible dependents. Medical and prescription benefits are provided through self-insured plans. The self-insured claims are processed and paid through independent claims processors. Life and AD&D benefits are fully insured through independent insurance companies.

Effective January 1, 2010, eligibility to receive retiree medical benefits at certain of the Company's other businesses was modified. Eligible employees who attained age 55 with 10 years of continuous, full-time service by December 31, 2010, will be provided the current retiree medical insurance benefits or can elect the new benefit, if desired, regardless of when they retire.

Effective January 1, 2013, the post-65 plan for post-1993 retirees of MDU Resources Group, Inc., Montana-Dakota Utilities Co., WBI Energy, Inc., and WBI Energy Transmission, Inc. was replaced by a fixed-dollar Health Reimbursement Arrangement (HRA) annual subsidy for retirees to purchase individual coverage through an exchange. MDU Resources Group, Inc., Montana-Dakota

Utilities Co., WBI Energy, Inc., and WBI Energy Transmission, Inc. retirees who retired between 1989 and 1993 were given the option of choosing the fixed dollar HRA.

All other eligible employees must meet the new eligibility criteria of age 60 and 10 years of continuous, full-time service at the time they retire. These employees will be eligible for a company funded Retiree Reimbursement Account (RRA) at \$3,000 per year (\$6,000 per year for retiree and spouse) for five years following retirement. Retirees can use this money to help pay for an eligible health insurance plan or any eligible out-of-pocket medical expenses. After five years of RRA funding, retirees will be eligible to receive \$125 per month (\$250 per month for retiree and spouse) to purchase a Medicare supplement or pay for eligible out-of-pocket medical expenses. Any R.M. Heskett Station or Lewis & Clark Station employee affected by the end of coal operations announced March 1, 2019, who is at least 55 years of age as of the last day of coal operations or by the date released by the Company, was hired prior to January 1, 2010, and otherwise qualifies for retiree medical eligibility, will be granted eligibility for the RRA upon attaining age 60.

**Contributions**

All costs to provide the benefits related to noncontributory life insurance are paid by the Company. Participant contributions for contributory life insurance, with the exception of certain retirees, are based upon the actual costs to provide the benefits of the Plan. Participants of MDU Resources Group, Inc. and Montana-Dakota Utilities Co. who retired prior to January 1, 2004, and the respective companies paid \$2.80 and \$.50, respectively, per \$1,000 face value in 2024. Retired participants of MDU Resources Group, Inc. and Montana-Dakota Utilities Co., who retired on or after January 1, 2004, paid the entire life insurance premium of \$3.30 per \$1,000 face value in 2024. Retired participants of WBI Energy, Inc. and WBI Energy Transmission, Inc. paid the entire life insurance premium of \$3.30 per \$1,000 face value in 2024.

Grandfathered retirees of Cascade Natural Gas Corporation (Cascade) who were older than age 65 on March 1, 2004, and retired prior to March 1, 1999, receive coverage at no cost to the retiree. Effective January 1, 2010, contributions for Intermountain retirees, who retired in 1992 or later, will reflect no more than a three percent increase from the prior year.

## **Note 2 - Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Risks and Uncertainties**

The Trust invests in various securities including U.S. Government securities, corporate debt instruments and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the amounts reported in the financial statements.

The actuarial present value of benefit obligations is reported based on certain estimates and assumptions, including interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumption process, it is reasonably possible that changes in these estimates and assumptions could materially affect the amounts reported.

### **Concentration of Investments**

The following presents investments that represent 10 percent or more of the Plan's net assets available for benefits at December 31. A significant decline in the market value of this investment would significantly affect the net assets available for benefits.

### **Investment Valuation and Income Recognition**

The Plan's investments are held by the Trust and reported at fair value as reported by the Trustee. Fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for description of valuation methods.

The fair value of the Plan's assets held in the Trust is based on the beginning of year value of the Plan's interest in the Trust plus actual contributions and investment income less actual distributions and administrative expenses. Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on an accrual basis.

#### **Administrative Expenses**

The Plan pays all investment fees related to the Plan and most other administrative costs, such as actuarial, audit, third-party administration and trust administration fees. Certain management and administrative services are provided by the Company to the Plan without a charge.

#### **Rebates and Refunds**

Refunds due from the Plan's pharmacy benefits manager are recorded when earned. Refunds due as of the financial statement date are reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling approximately \$138,000 have been netted with claims paid in the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

#### **RRA**

Unused RRA balances are carried over to subsequent years but are not funded until claims are incurred and presented to the administrator for payment.

#### **HRA**

Unused HRA balances are carried over to subsequent years but are not funded until claims are incurred and presented to the administrator for payment.

#### **Stop-Loss Coverage**

Effective January 1, 2021, the Company entered into a stop-loss insurance arrangement in an effort to limit its aggregate exposure to all pre-65 retiree claims. The Company pays the stop-loss insurance premiums and the Plan's financial statements do not reflect any amounts associated with the Company's stop-loss insurance arrangement.

#### **Contributions**

Contributions are recorded as additions to Plan assets when received or determined to be receivable by the Plan. Participant contributions to the Plan represent the amounts withheld from the retired employees' pension benefit payments or amounts contributed by retired employees to cover the cost of certain benefits.

#### **Payment of Claims**

Claims are recorded as paid when paid by the third-party claims processor. Amounts due to claims processors that have been approved but not reimbursed by the Plan are disclosed in Note 4 as Claims payable.

#### **Insurance Premiums**

Premiums paid by the Plan are recorded as insurance premiums in the accompanying Statement of Changes in Net Assets Available for Benefits.

### **Note 3 - Fair Value Measurements**

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (an exit price) in an orderly transaction between market participants at the measurement date. The Financial Accounting Standards Board (FASB) Accounting Standards Codification establishes a hierarchy for grouping assets and liabilities, based on the significance of inputs. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There are three levels of inputs that may be used to measure fair value:

- Level 1 – quoted prices (unadjusted) in active markets for identical assets or liabilities that the reporting entity can access at the measurement date;
- Level 2 – inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly; or
- Level 3 – unobservable inputs for the asset or liability.

Following is a description of the specific valuation methodologies used for assets and liabilities measured at fair value. There have been no changes in the methodology used at December 31, 2024.

*Interest-bearing cash* - Valued at cost which approximates fair value.

*Equity Securities* - Valued at the closing price reported on the active market on which the individual securities are traded.

*Insurance contract* - Investment in the insurance contract is valued based on contractual cash surrender values that are determined primarily by investments in managed separate accounts of the insurer. These amounts approximate fair value. The managed separate accounts are valued based on other observable inputs or corroborated market data.

Though the Company believes the methods used to estimate fair value are consistent with those used by other market participants, the use of other methods or assumptions could result in a different estimate of fair value.

## **Note 4 - Benefit Obligations**

### **Postretirement Benefit Obligations**

The postretirement benefit obligations represent the actuarial present value of those estimated future benefits that are attributed to employee service rendered through December 31, reduced by the actuarial present value of contributions expected to be received in the future from current retirees of the Plan. The Plan's postretirement benefit obligation in these financial statements does not reflect the Medicare Part D subsidy. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired employees and their beneficiaries and dependents (as applicable), and (2) active employees and their beneficiaries and dependents (as applicable) after retirement from service with the Company. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligations for health benefits is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment, and to reflect the portion of those costs expected to be borne by Medicare, the retired participants and other providers.

The actuarial present value of the expected postretirement benefit obligations for life benefits is determined by an actuary and is the amount that results from applying actuarial assumptions to age-based expected mortality costs to estimate future benefit costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of

payment (by means of decrements such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

The postretirement benefit obligations at December 31, 2024 and 2023, represent health and life benefits. The obligation for postretirement benefits is funded by employer contributions to the Trust.

Health care trend rate assumptions as of December 31 were as follows:

The accounting for the health care plan anticipates future cost-sharing changes that are consistent with the Company's expressed intent to generally increase retiree contributions each year by the excess of the expected health care cost trend rate over six percent.

The weighted-average health care cost trend rate assumption (noted previously) has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of December 31, 2024, by approximately \$312,000.

The following were other significant assumptions used in the valuations at December 31, 2024 and 2023:

- An assumed discount rate for obligations of 5.43 percent and 4.85 percent in 2024 and 2023, respectively.
- Life expectancy of participants and mortality costs for both 2024 and 2023 were determined by reference to the Pri-2012 Total dataset base rate mortality table projected generationally using MP-2021.
- Average retirement age of 63.

The foregoing assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations.

#### **Note 5 - Income Tax Status**

The Internal Revenue Service (IRS) has informed the Company by a letter dated June 20, 1995, that the Trust is qualified under Section 501(c)(9) of the Internal Revenue Code. Generally, the Trust's investment income is exempt from taxation; however, the Trust may be subject to tax on unrelated business income.

GAAP requires Plan management to evaluate tax positions taken by the Plan. The effects of an uncertain tax position are recognized in the financial statements when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 - Exempt Party-In-Interest Transactions**

The Plan's investments include an interest-bearing cash bank deposit sweep program and shares of commingled funds managed by Principal Trust Company or Principal Bank, as the case may be, who is the Trustee of the Trust. The Plan's investments also include an insurance contract managed by Metropolitan Life Insurance Company and common stock of MetLife Inc., who is the qualified institution. These arrangements qualify as exempt party-in-interest transactions that are exempt from the Department of Labor's prohibitions.

**Note 8 - Certification by Trustee and Qualified Institution**

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Principal Trust Company or Principal Bank, as the case may be, the Trustee of the Plan, and MetLife, the qualified institution, have certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023 and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

**Note 9 - Subsequent Events**

The Plan has evaluated subsequent events for matters requiring adjustment or disclosure in these financial statements through October 14, 2025, the date on which these financial statements were available to be issued.
