### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Indiana Internal Medicine Consultants Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

### **Basis for Opinion**

#### Note 1. Plan Description

The following description of the Indiana Internal Medicine Consultants Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Indiana Internal Medicine Consultants (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was established on January 1, 1998 and was amended effective January 1, 2002, to adopt the provisions of the Economic Growth and Tax Relief Reconciliation Act of 2001. The Plan was most recently restated January 1, 2022, to comply with all applicable law changes.

**Eligibility conditions:** To become a participant in the Plan, an employee must be 21 years of age, have completed one year of service and worked 1,000 hours. Enrollment in the Plan is quarterly.

**Plan entry dates:** An employee is eligible to enter the Plan on January 1, April 1, July 1, or October 1 immediately following completion of the eligibility requirements.

**Contributions:** Participants may contribute a percentage of their annual pre-tax compensation, or post-tax compensation, as defined, up to the maximum amount allowed by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

The Company contributes a non-elective safe-harbor contribution equal to 3% of the participant's annual compensation. In addition, the Company may make additional discretionary matching contributions or profit-sharing contributions to the Plan at the option of the Company's Board of Directors. For the year ended December 31, 2024, the Company made discretionary profit-sharing contributions of \$2,805,468 and safe-harbor contributions of \$1,021,863. Company contributions are invested in a manner that is consistent with participant contributions. All contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant accounts:** Each participant's account is credited with the participant's contributions, the Company's safe-harbor contribution, the Company's discretionary matching contribution, if any, an allocation of the discretionary Company profit-sharing contributions, if any, plan earnings and administrative expenses. Allocations are based on account balances or compensation, as defined by the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their voluntary contributions and the Company safe-harbor contributions, including the actual earnings thereon. Vesting for the Company discretionary matching and profit-sharing contributions is based on a graded vested scale based on years of service, as defined. A participant is 100% vested after six years of credited service.

**Investment options:** Upon enrollment in the Plan, participants may direct the investment of their contributions into a variety of investment options, as more fully described in the Plan's literature. Participants may change their investment options at any time.

**Notes receivable from participants:** The Plan does not allow for participant loans.

**Payment of benefits:** Upon termination of employment for any reason including retirement, the participant may elect to receive a lump-sum amount equal to the vested value of his or her account, leave the amounts in the Plan if greater than \$1,000, or rollover the amounts to another qualified account. In addition, participants may make withdrawals upon reaching a normal retirement age of 59½ or by determination that a financial hardship, as defined by the Plan agreement, has been incurred.

**Forfeited accounts:** Forfeitures of the employer's contributions will be used for the payment of Plan expenses or to reduce future employer matching contributions. At December 31, 2024 and 2023, unallocated forfeiture amounts were \$144,337 and \$50,715, respectively. No forfeitures were used to offset employer contributions during the year ended December 31, 2024. Interest and dividend income generated from unallocated forfeitures during the year ended December 31, 2024 was \$4,567, and \$296 of forfeitures were used to pay administrative expenses.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual method of accounting.

**Accounting estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines its valuation policies utilizing information provided by the Plan's investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

**Payment of benefits:** Benefits are recorded when paid.

**Administration of plan assets:** Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative expenses are paid by the Company and therefore, are not reflected in the Plan's financial statements.

#### **Note 4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Registered investment companies (mutual funds):** Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Stable value fund:** Valued at NAV of shares of a collective trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund. This practical expedient is not used when it is determined to be probable that the fund will sell the investments for an amount different than the reported NAV. Participant transactions (purchase and sales) may occur daily. Were the Plan to initiate a full redemption of the stable value fund, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly manner.

**Self-directed brokerage accounts:** Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

**Changes in fair value levels:** To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers between levels.

For investments in certain entities that calculate the NAV per share as the investment's fair value measurement, the following table provides an overview of the nature and risk associated with such investments as well as whether it is probable these investments are being sold at amounts different from their reported NAV per share based on redemption restrictions, if any.

#### Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

#### Note 6. Party-in-Interest Transactions

Certain Plan investments are managed by Empower. Empower is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions as defined under ERISA guidelines. Administrative expenses presented on the statement of changes in net assets available for benefits totaling approximately \$92,157 were paid to the custodian for the year ended December 31, 2024.

#### Note 7. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

The Plan Administrator has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require adjustment to the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

#### Note 8. Nonexempt Transactions

During 2024, the Plan Sponsor inadvertently failed to deposit \$32,666 of participant contributions within the required time frame as stated by the United States Department of Labor (DOL) regulations. The Plan Sponsor deposited the lost interest in the amount totaling approximately \$80 to correct this failure in 2025. The Plan Sponsor filed Form 5330 and intends to pay the applicable excise tax to the IRS. The correction and any excise taxes, if applicable, will be made from the Plan Sponsor's assets and not from assets of the Plan.
