Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Vertex Companies, LLC 401K Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.



The following description of The Vertex Companies, LLC 401K Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for more complete information regarding the terms of the Plan.

General: The Plan is a defined contribution, 401(k) plan covering substantially all full-time employees of The Vertex Companies, LLC and Subsidiaries (the Plan Sponsor). The Plan was established on January 1, 2006, to provide a systematic savings plan and retirement benefits for eligible employees (the Participants). Employees become eligible for participation in the Plan upon attaining the age of 21. During the year ended December 31, 2013, certain wholly owned subsidiaries were rolled into the parent company and their plans were merged into the Plan. The plan was amended for the plan year 2014, to include the employees of Vertex TCS, LLC, and Vertex McGlamery, Inc. The plan was amended for the plan year 2017 to include employees of Optistar Technology Consultants, Inc. and in year 2020 to include employees of Compass Project Management, Inc. and in the year 2021 to include employees of Lockwood Kessler and Bartlett, Inc. The plan has adopted various amendments to reflect changes included in certain pension acts through the date of these financial statements.

Contributions: Participants may contribute up to 80% of their pre-tax compensation, subject to limitations under Federal law. Rollover contributions from other qualified plans are allowed. During the year ended December 31, 2021, the Plan Sponsor terminated their Employee Stock Ownership Plan (ESOP). As a result, \$7,126,640 was rolled over from the ESOP into the Plan during the year ended December 31, 2022. Additionally, during the year ended December 31, 2022, employees from Lockwood Kessler and Bartlett, Inc. rolled over both funds and loans to the Plan.

The Plan Sponsor has elected to operate the Plan as a safe harbor 401K plan. The Plan Sponsor will make matching contributions to the individual account of each eligible participant equal to 100% of the participant's elective deferral not to exceed 4% of the participant's compensation for the plan year.

Participant Accounts: Each Participant's account is credited with the Participant's contribution, Plan Sponsor's contribution, and an allocation of Plan earnings. Allocations are based on total investment earnings and average Participant investment balances, as defined.

Expenses: The Plan Sponsor pays for all expenses incurred by the Plan, except for certain transaction fees, loan charges, and budget accounts which are paid by the Plan.

Vesting: Participants are immediately vested 100% in their voluntary contributions (including rollover contributions) and the Plan Sponsor's safe harbor matching contribution, plus actual earnings thereon.

Benefits and Withdrawals: Upon reaching the normal retirement age, or upon death or disability of a Participant (or beneficiary) prior to retirement or upon termination of employment, benefits become available for disbursement. All benefits payable under the plan are paid in a lump-sum cash payment.

Hardship withdrawals are allowed under the provisions of the Plan and cannot exceed the amount required to meet the immediate financial need created by the hardship.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Participants may borrow from their plan accounts in amounts attributable to the Participant's contributions, for a maximum term of five years, unless used for purchase of principal residence. A Participant may borrow a maximum of 50% of their vested balance up to \$50,000. The minimum loan amount is \$500. The interest rate is fixed at the inception of the loan in an amount equal to the rate offered by a qualifying financial institution for a similar type of loan. The interest rates charged on loans outstanding as of December 31, 2024 amount to 4.25% to 9.50%, per annum. As of December 31, 2024 and 2023, an allowance was not established for loan losses as it was not deemed necessary.

Plan Investments: The Plan's investments are held in various securities accounts of Reliance Trust Company. Participants have the option to allocate their contributions and the Plan Sponsor's contributions, if any, in their individual accounts among various investment alternatives and to make transfers as specified in the plan document.

2. Significant Accounting Policies:

Basis of Accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Accounting Guidance: The Plan has adopted the provisions of FASB Accounting Standards Update (ASU) 2015-12 (Part II), "Plan Accounting (Topics 960, 962 and 965): Plan Investment Disclosures." This ASU eliminates the disclosure of individual investments that represent 5 percent or more of net assets available for benefits, eliminates the net appreciation or depreciation for investments by general type, and requires that investments be grouped only by general type, eliminating the need to disaggregate the investments by nature, characteristics, and risks. The Plan has adopted this standard as Plan management believes this presentation is more relevant to the users of the financial statements.

Investment Valuation and Income Recognition: Investments are valued at their fair market value. Fair market value is determined by using quoted market prices. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid balance. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Interest income is on the accrual basis and dividend income is recorded on the ex-dividend date. Purchases and sales of securities are reflected on a trade date basis. The net appreciation (depreciation) in the fair value of the Plan's investments consists of realized gains (losses) and unrealized appreciation (depreciation) on those investments.

Recent Accounting Standards: The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

Participant Salary Deferrals: Participant contributions are recorded in the period in which the Participants' payroll deductions are made.

Payment of Benefits: Benefits are recorded when paid.

Use of Estimates: Management has used estimates and assumptions relating to the reporting of assets and liabilities and the disclosure of contingent assets and liabilities in its preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America. Actual results experienced by the Plan may differ from those estimates.

Subsequent Events: For the year ended December 31, 2024, the Plan has evaluated subsequent events for recognition and disclosure through October 8, 2025, the date of financial statement issuance.

3. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

4. Party-In-Interest Transactions:

Certain Plan investments are in funds managed by Reliance Trust Company. Reliance is the trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services amounted to \$27,485 and \$25,294, for the years ended December 31, 2024 and 2023, respectively.

5. Plan Termination:

While it is the intention of the Plan Sponsor to continue the Plan indefinitely, the Plan Sponsor reserves the right to terminate or amend the Plan at any time subject to the provisions of ERISA. In the event of termination, the accounts of all Participants shall become vested and plan assets shall be distributed in accordance with the terms of the Plan.

6. Tax Status:

The Internal Revenue Service has issued an opinion letter dated July 8, 2014 stating that the prototype plan adopted by the Plan Sponsor was designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the IRS opinion letter, however, the Plan administrator believes that the Plan is currently being operated in compliance with the applicable provisions of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, that there are no uncertain positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to December 31, 2021.

7. Fair Value Measurements:

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability and inputs that are derived principally from or corroborated by observable market data by correlation of other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset and liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Registered Investment Companies - Valued using publicly available quoted market prices. The separate accounts investing in mutual funds or equity securities are measured using quoted prices in active markets (Level 1).
