Notes to Financial Statements

December 31, 2024

**1. Description of the Plan**

**General**

The 401(k) Plan for Hourly Employees of Mississippi Lime Company at Ste. Genevieve (the Plan) is a defined contribution plan that was established on June 1, 2009, with a 401(k) feature covering all collective bargaining hourly employees of Mississippi Lime Company (the Company) located in Ste. Genevieve, Missouri. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions**

Each year, participants may contribute an amount of 2% to 50% of pretax annual compensation, as defined in the Plan document. The Plan also has a Roth feature whereby participants may elect to make after-tax contributions. In addition, participants may also make a non-Roth after-tax contribution of up to 10% of annual compensation. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). The Company contributes a 50% match up to 3% of employee annual compensation in addition to a non-match contribution of 4% of annual compensation to all eligible employees.

All contributions are subject to applicable limitations. All contributions are participant-directed to any of the Plan's investment options.

Each participant's account is credited with the participant's and the Company's contributions and allocation of the Plan's earnings and is charged with an allocation of administrative expenses. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

**Administrative Expenses**

All administrative expenses that are not allocated to participants are paid directly by the Company.

**1. Description of the Plan (continued)**

**Participant Loans**

Certain participants may borrow up to one-half of the balance in their hourly deferral account up to \$50,000. Loan terms extend up to five years or over a reasonable period of time that may be longer than five years if the loan is used to acquire a principal residence. The loans are secured by the balance of the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through a minimum of quarterly payroll deductions. Terminated employees may pay their loan in full at the time of separation, or they may receive a deemed distribution.

**Vesting**

Participants are fully vested in their contributions and the earnings thereon. The Company contributions vest ratably after one year and are fully vested after five years. Forfeitures of non-vested amounts are used to reduce future Company contributions and for corrective distributions. Unallocated forfeited balances as of December 31, 2024 and 2023, were approximately \$259,000 and \$165,000, respectively. No forfeitures were used to reduce Company contributions or for corrective distributions for the years ended December 31, 2024 and 2023.

**Payment of Benefits**

Participants may make withdrawals of non-Roth after-tax contributions subject to minimum withdrawal amounts and are limited to a maximum of two withdrawals per year. In addition, participants may make qualifying financial hardship withdrawals of before-tax, Roth, and vested company contributions.

Upon termination of employment, participants may receive the vested interest in their accounts as a lump sum or in the form of an installment payment or, subject to certain rules, may leave the balance in the Plan.

**Plan Termination**

The Plan is voluntary on the part of the Company. The Company may terminate the Plan in whole or in part subject to the provisions of ERISA. Upon termination or complete discontinuance of all contributions to the Plan, participants' accounts become fully vested. Currently, the Company has no intention to terminate the Plan.

**2. Significant Accounting Policies**

**Accounting Basis**

The financial statements of the Plan are presented on the accrual basis of accounting.

**Investment Valuation and Income Recognition**

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date (an exit price). See Note 7 for further discussion and disclosures related to fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year. All investments are participant-directed.

**Payment of Benefits**

Benefits are recorded when paid.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles (U.S. GAAP) requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

**Notes Receivable from Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance, plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024, or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

**3. Related-Party and Party-in-Interest Transactions**

The Plan invests in shares of mutual funds and units of a common/collective trust managed by an affiliate of its trustee, a party-in-interest with respect to the Plan. These transactions are covered by an exemption from the prohibited transaction provisions of ERISA and the Internal Revenue Code of 1986 (the Code), as amended.

**4. Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the years then ended, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Vanguard Fiduciary Trust Company, the trustee of the Plan.

**5. Income Tax Status**

The Plan has received a determination letter from the Internal Revenue Service (the IRS) dated September 28, 2022, stating that the Plan is qualified under Section 401(a) of the Code and, therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan, as amended, is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

**7. Fair Value Measurements**

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:
  - Quoted prices for similar assets and liabilities in active markets
  - Quoted prices for identical or similar assets or liabilities in markets that are not active
  - Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

**7. Fair Value Measurements (continued)**

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level of input that is significant to the fair value measurement in its entirety.

The following is a description of the valuation techniques and inputs used for each general type of asset measured at fair value.

**Mutual Funds**

Shares of mutual funds are valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

**Common/Collective Trust**

Units in the common/collective trust are valued at the NAV provided by the administrator of the fund.
