Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of VLS Environmental Solutions LLC 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). 1. Description of Plan

The following description of the VLS Environmental Solutions LLC 401(k) Profit Sharing Plan (the Plan), formerly VLS Recovery Services LLC 401(k) Plan, provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of VLS Parent, Inc. and its subsidiaries (collectively, the Company, Plan Sponsor, Employer, or Plan Administrator). The Plan qualifies as a salary reduction plan under Section 401(a) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the IRC, and any subsequent amendments.

Trustee and Administration of the Plan

The trustee of the Plan is ADP Retirement Trust Services (ADP) and the recordkeeper is Pentegra Retirement Services. The administrator of the Plan is the Company. The trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

Employees are eligible to participate in the Plan upon completing three consecutive months of service and attainment of age 18. Nonresident aliens and employees of certain subsidiaries, as defined in the Plan document, are not eligible to participate in the Plan.

Contributions

The Employer makes qualified safe harbor matching contributions to the Plan for all participants on a uniform basis equal to 100% of the participants' elective deferrals up to 5%. Furthermore, the Employer may make additional discretionary matching contributions and/or a discretionary profit-sharing contribution to the Plan. Eligible employees will receive the discretionary profit-sharing contribution if they are employed on the last day of the Plan year. The Employer made no additional discretionary matching or profit-sharing contributions to the Plan during 2024.

The Plan allows participants to contribute up to 90% of their eligible annual compensation on a pre-tax or after-tax basis, subject to certain limits prescribed by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Eligible participants are automatically enrolled in the Plan, unless they affirmatively decline to participate, at a rate of 3%. Annually on the first day of each Plan year, participants' deferral rates will automatically increase by 1% up to a maximum of 6%. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions subject to annual Internal Revenue Service (IRS) limitations. The Plan provides for participant-directed investment programs for individual participants as provided by the trustee.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Employer's qualified safe harbor matching contributions; (b) the Employer's discretionary matching and/or profit-sharing contributions, if any; and (c) Plan earnings and certain administrative expenses. Allocations are based on participant compensation or account balances as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may change their investment options daily and invest in various mutual funds.

Vesting

Participants are immediately 100% vested in their entire account balances, including their salary deferral contributions, rollover contributions, Employer safe harbor matching contributions, and discretionary matching and/or profit-sharing contributions, as well as the earnings thereon.

Notes Receivable from Participants

Participants are allowed to borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. The notes are secured by the balance in the participant's vested account and bear interest at a rate commensurate with local prevailing rates as determined appropriate by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. Note terms range from one year to 54 months or up to 30 years for the purchase of a participant's primary residence. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

A participant's entire interest in the Plan is payable upon death, attainment of normal retirement age, becoming disabled (as defined), or termination of service. A participant may elect to receive a lump-sum amount equal to the vested portion of the participant's account, or annual installments.

Participants may elect to roll over their vested balance to another qualified retirement plan or individual retirement account (IRA). Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$5,000 or less. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan. Participants may also withdraw an amount at age 59½ if certain criteria are met.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a menu of mutual funds and common collective trust fund options for investment.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred.

No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If participants cease to make loan repayments and the Plan Administrator deems the participant loan to be a default, the participant loan balance is reduced and recorded as a benefit payment.

Payment of Benefits

Benefits are recorded as a deduction to net assets available for benefits when paid.

Administrative Expenses

To the extent not paid by the Plan, fees and expenses incurred in the administration of the Plan are paid by the Employer. Expenses that are paid directly by the Employer are excluded from these financial statements. Any participant-directed expenses, including the administration fee of notes receivable and distributions, are charged directly to the participant's account and are included in expenses of the Plan. Investment-related expenses are included in net appreciation in fair value of investments.

3. Certified Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by ADP.

At the request of the Plan Administrator, the Plan's independent auditor did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information in the financial statements, including reading the disclosures related to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP, and in the ERISA-required supplemental schedule, including assessing whether the ERISA-required supplemental schedule is in conformity with the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA.

4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 - This level consists of inputs that are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - This level consists of inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the assets or liability.

Level 3 - This level consists of inputs that are unobservable inputs for the asset or liability.

In some cases, certain inputs used to measure fair value may be categorized into different levels of the fair value hierarchy. For disclosure purposes, the lowest level that contains significant inputs used in valuation should be chosen. The Plan has classified its investments into these levels depending upon the data relied on to determine fair values.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily fair value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust - The fair value of participation units held the collective trust is based on the net asset value (NAV) reported by the fund managers as of the financial statement date, which is the NAV available to investors and the basis for transactions as of that date. The investment objective of the collective trust is to provide preservation of capital and provide relatively stable returns consistent with a low-risk profile. The collective trust provides for daily redemptions by the Plan at reported NAV per share, with no advance-notice requirement.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

6. Income Tax Status

The Plan uses a volume-submitter plan sponsored by ADP as adopted by the Employer. The volume-submitter plan obtained its latest advisory letter on October 6, 2020, in which the IRS stated that the form of the volume-submitter plan is acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. The Plan has not requested its own determination

letter from the IRS. The Plan has since been amended; however, the Employer believes that the Plan is currently designed in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Transfer from Other Qualified Plan

Following VLS Environmental Solutions acquisition of Texas Molecular Holdings, LLC during 2023, the Texas Molecular 401(k) Retirement Plan merged into the Plan effective January 1, 2024. Net assets available for benefits transferred to the Plan totaled \$7,114,653.

8. Party-in-Interest Transactions

Certain transactions are executed and managed by the trustee and recordkeeper of the Plan; therefore, certain transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. The Plan's management has approved these activities and transactions.

9. Subsequent Events

The Plan has evaluated all subsequent events and transactions through October 14, 2025, the date the financial statements were available for issuance, and has determined that no events have occurred that required disclosure or recognition in these financial statements.
