Independent Auditor's Report

Opinion

Plan Description

Burgess & Niple Employee Benefit Trust (the Trust) was created for the purpose of providing and maintaining Burgess & Niple Employee Benefit Plan's (the Plan) program through self-funding, policies issued by a licensed insurance carrier or any combination thereof. The following description of the Trust and the Plan provides only general information. Participants should refer to the plan agreements for a complete description of the Plan's provisions.

General

The Plan provides health, life, supplemental and disability insurance benefits for full-time employees (minimum of 30 hours per week), their beneficiaries and covered dependents of Burgess & Niple, Inc. (the Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Employees contribute specified amounts based on applicable bi-weekly premiums for elected health benefits. Employees also make contributions to pay the full cost of elected supplemental and dependent life insurance program premiums. The Sponsor contributes amounts needed to fund claims in excess of participants' contributions for health and disability benefits. The Sponsor also makes contributions to pay administrative expenses.

Benefits

The Plan provides health benefits (medical, dental, vision and prescription drugs), life insurance benefits, short-term (STD) and long-term (LTD) disability benefits and accidental death and dismemberment benefits (AD&D). The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Life, supplemental insurance, and LTD benefits are provided through insurance contracts. Premiums for such insurance contracts are paid from the general assets of the Sponsor.

Aetna Life Insurance Company (Aetna) provides the processing of health and STD claims, along with stop loss coverage for certain benefits. Third party administrator fee expenses for the years ended December 31, 2024 and 2023 were \$82,628 and \$110,370, respectively. The amount is included in administrative expenses in the accompanying statements of changes in net assets available for benefits – cash basis.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies and procedures. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Plan Description (continued)

Plan Termination

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and non-discriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Summary or be used for purposes other than for the exclusive benefit of the Plan's participants.

Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with another comprehensive basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and disclosure of contingent assets at the date of financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Basis of Accounting

The financial statements of the Plan are prepared using the cash basis of accounting. Therefore, contributions from participants and the employer are recognized as income when cash is received and claims, premiums, administrative and other expenses are recognized when paid. The financial statements of the Plan are not intended to be a presentation in conformity with generally accepted accounting principles in the United States of America (GAAP). However, certain information is presented in accordance with GAAP.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Premiums paid by either the Sponsor or the Trust are recorded as insurance premium payments on the accompanying statements of changes in net assets available for benefits-cash basis.

Claim payments are recorded when paid by the third-party claims processor. STD payments are processed through the Sponsor's payroll system and paid from the general assets of the Sponsor. These payments are recorded as claims paid in the accompanying statements of changes in net assets available for benefits-cash basis.

Summary of Significant Accounting Policies (continued)

Income Taxes

The Plan, established to hold the Plan's net assets, is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code, and accordingly, the Plan's net investment income is exempt from income taxes.

The Sponsor has obtained a favorable tax exemption letter from the Internal Revenue Service dated September 16, 1989 stating that the Plan is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code and the Sponsor believes that the Plan, as amended, continues to qualify and to operate as designed.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by applicable taxing authorities. The plan administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

Reclassification

Certain amounts in the 2023 statements of net assets available for benefits have been reclassified to conform to current year presentation.

Concentration of Investments

As December 31, 2024, 11% of net assets available for benefits are made up of SPDR Exchange Traded Fund. As of December 31, 2023, 12% of net assets available for benefits are made up of the PIMCO Total Return Fund.

Cash is held in a non-interest bearing checking account at one financial institution. The Plan occasionally maintains cash deposits in excess of federally insured limits.

Fair Value Measurements

GAAP established a fair value hierarchy that prioritizes the inputs to measure the fair value of the assets or liabilities being measured. Fair value is defined as the exchange value that would be received on the measurement date to sell an asset or to value the amount paid to transfer a liability in the principal or most advantageous market available to the entity in an orderly transaction between market participants. The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs are unadjusted quoted market prices in active markets for identical assets or liabilities that the entity has the ability to access at the measurement date. Level 1 inputs provide the most reliable measure of fair value as of the measurement date.

Level 2 Inputs are based on significant observable inputs, including unadjusted quoted market prices for similar assets and liabilities in active markets, unadjusted quoted prices for identical or similar assets or liabilities in markets that are not active, or inputs other than quoted prices that are observable for the asset or liability.

Level 3 Inputs are significant unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level or any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the closing price reported on the active market on which the individual securities are traded.

Equities: Valued at the closing price reported on the active market on which the individual stock is traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan's net assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Deposit – Third Party Administrator

A deposit of \$68,030 is being held by Aetna, as specified within the contract. This deposit may be used in the event the Plan fails to perform its payment and funding obligations.

The Sponsor self-funds the short-term disability. For the years ended December 31, 2024 and 2023, the Sponsor paid employees \$154,707 and \$155,254, respectively. The amount is included in benefits paid to participants in the accompanying statements of changes in net assets available for benefits – cash basis.

Stop Loss

Under agreement with Aetna, the Plan paid Aetna for specific and aggregate stop loss insurance for the years ended December 31, 2024 and 2023. The specific stop loss limit is \$175,000. For the year ended December 31, 2024, there were six participants who exceeded the specific stop loss limit and Aetna refunded \$385,547. For the year ended December 31, 2023, the specific stop loss limit was \$175,000 and there were two participants who exceeded the specific stop loss limit and Aetna refunded \$454,338. These amounts are presented as reductions of Benefits Paid to Participants within the accompanying statements of changes in net assets available for benefits – cash basis.

The aggregate stop loss is set by Aetna based on anticipated claims. The claims did not exceed the aggregate stop loss during 2024 or 2023.

Estimated Benefits Incurred

At December 31, 2024 and 2023, it is estimated that the Plan would be responsible for approximately \$237,000 and \$215,000, respectively, for coverage of health benefits incurred prior to year-end, but to be paid after year-end. Estimated benefits are based on claims data provided by Aetna.

Related Party

As the Plan is closely associated with the Sponsor, it is the policy (of the Sponsor) not to charge for such costs as office space, utilities and administrative expenses incurred by the Plan. It has been determined that the Sponsor provided primarily two employees to handle the Plan administrative activities for the years ended December 31, 2024 and 2023. Estimated annual payroll and expenses paid by the Sponsor for these employees for 2024 and 2023 was \$30,000.

Party-in-Interest Transactions

The Plan holds certain investments with U.S. Bank, the custodian of the Plan. Aetna holds a deposit on the Plan's behalf in the event the Plan cannot perform a payment or funding obligation. The Plan pays Aetna certain third party administrator fees. Therefore, these transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

Commitments

Administrative Fees

The Trustees have signed a one-year contract with Aetna, effective January 1, 2025, to provide administrative services at an estimated cost of \$215,976 for the year.

Stop Loss

The Trustees have signed a one-year contract, effective January 1, 2025, to provide stop loss coverage at an estimated cost of \$1,406,993 for the year.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying 2024 statement of net assets available for benefits-cash basis.

Subsequent Events – Date of Management's Evaluation

The Plan evaluated subsequent events through the date of the Independent Auditor's Report, which is the date the financial statements were available to be issued.
