## INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of  
Fisher Companies 401(k) Plan and Trust

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of Fisher Companies 401(k) Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Fisher Companies 401(k) Plan and Trust financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Voya Retirement Insurance and Annuity Company as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note B to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Fisher Companies 401(k) Plan and Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

#### **NOTE A - DESCRIPTION OF PLAN**

The following description of the Fisher Companies 401(k) Plan and Trust ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering full-time employees after 60 days of elapsed time or part-time employees working at least 1,000 hours, who are age 18 or older and are employed by one of the companies that have adopted this Plan ("the Employers"). Employees covered under a collective bargaining agreement are generally not covered unless coverage under the Plan is specifically bargained for. The Employers that have adopted the plan are as follows:

Central Asphalt, Inc.	Fisher Construction Aggregates, Inc.
Fisher Transportation Company	Buck's Run Golf Club, LLC
Mt. Pleasant Central Concrete Products Co., Inc.	Fisher Sand and Gravel Company

#### **Contributions**

Each year, participants may contribute up to the maximum allowed by the Internal Revenue Service. Participants may also contribute rollover amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Under this Plan, the Employers have the right to make discretionary contributions. The Employers contribute a 4% safe harbor match for each dollar the employee defers up to a maximum of 4% of the employee's annual salary. Additionally in the year ended December 31, 2020, Central Asphalt, Inc. opted to pay additional amounts for operators and laborers to make employee compensation and benefits similar to that paid under the Davis-Bacon Act. These employer discretionary contributions are invested using the same allocation as the participant directed deferrals.

#### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Safe harbor match contributions are 100% vested immediately. Eligible participants hired on or after January 1, 2022 have their employer discretionary contributions 100% vested after two or more years of vesting service.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and employer's matching contributions, as well as Plan earnings. Participant accounts are charged with fees for specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Participant Loans**

Participants may borrow from their vested account balance a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and interest shall be charged at a rate to be fixed by the plan administrator and, in determining the interest rate, the plan administrator shall take into consideration interest rates currently being charged on similar loans by persons in the business of lending money. Principal and interest is paid ratably through payroll deduction. Loans must be repaid within five years.

#### **NOTE A - DESCRIPTION OF PLAN (CONTINUED)**

##### Payment of Benefits

Upon termination of service due to death, disability, retirement or obtaining age 65, a participant may elect to receive either a lump-sum amount equal to the value of their vested interest in their account, annual installments not to exceed ten years, an annuity over the remainder of their lifetime, or any kind of single consideration annuity available. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

##### Fees

Asset based fees charged to the Plan include fees for recordkeeping and administrative services, trustee and custodial services and investment management expenses, and are reflected as a component of net appreciation (depreciation) in fair value of investments in the Statement of Changes in Net Assets Available for Benefits.

##### Forfeited Accounts

Amounts forfeited from a participant's account shall be used to restore forfeitures or reduce Employer contributions (or reallocate as Employer contributions), or to pay reasonable Plan expenses to the extent specified in the Adoption Agreement.

At December 31, 2024 and 2023, forfeited non-vested accounts had a balance of \$14,563 and \$3,385, respectively. These accounts will be used to reduce future employer contributions. During the years ended December 31, 2024 and 2023, employer contributions were reduced as a result of forfeitures by \$12,111 and \$6,449, respectively.

##### Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances.

##### Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

##### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### Investment Valuation and Income Recognition

Most of the Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note G for a discussion of fair value measurements. See Note H for investments reported at contract value.

Appreciation (depreciation) in fair value of investments represents the difference between the values of the investments at the end of the Plan years plus any gains or losses from sales of investments during the Plan year. Also, interest and/or gain (loss) information for the Voya Retirement Insurance and Annuity Company ("Voya") fixed account is shown under net appreciation/(depreciation) in fair value of investments. Contract holders and plan participants do not hold shares of the mutual funds under the contract. Instead, contributions to the contract are held in separate accounts, which in turn purchase shares of the mutual funds or CITs. There are no dividends or realized and unrealized gains with respect to separate account units of participants. Instead, the dividends and realized and unrealized gains for the underlying funds are factored into the value of the separate account funds per Voya Retirement Insurance and Annuity Company.

#### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

##### Payment of Benefits

Benefits are recorded when paid.

##### Operating Expenses

All expenses of maintaining the Plan are paid by the plan sponsor.

##### Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate. All amounts were certified as complete and accurate by the Voya Retirement Insurance and Annuity Company from January 1, 2023 through December 31, 2023 and from January 1, 2024 through December 31, 2024.

##### Excess Contributions Payable

Excess contributions payable consists of amounts deferred by participants in excess of IRS limits, as well as income earned from those excess deferrals.

#### **NOTE C - PLAN AMENDMENTS**

During 2021, the Plan was amended to not restrict loans to be for hardship only from September 16, 2021 through April 20, 2022. The Plan was amended again effective January 1, 2022 for updating participant eligibility requirements to include: part-time employees that work 1,000 hours in any period, the age limit was reduced to 18 from 21, employees are now eligible the first day of the month following a 60-day waiting period versus one year and all eligible employees will be automatically enrolled. Additionally, the elective deferrals of affected automatic enrollment participants will initially be 3% of compensation and increased by 1% each year until deferral reaches 6% or the participant elects a different percentage (including 0%).

Effective July 27, 2022 there was a restatement of the previously adopted plan to incorporate the effects of the prior plan amendments. The restated plan document did not result in significant changes to the Plan's operations or requirements.

#### **NOTE D - PLAN TERMINATION**

Although they have not expressed any intent to do so, the Employers have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

#### **NOTE E - RELATED PARTY TRANSACTIONS**

The administrative fees recorded in the years ended December 31, 2024 and 2023 were for transaction fees charged by Voya. Voya is the trustee, as defined by the Plan, therefore these transactions qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE F - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statement of Net Assets Available for Benefits.

**NOTE G - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of inputs of the fair value hierarchy are: Level 1 - quoted prices in active markets for identical assets; Level 2 - significant other observable inputs; and Level 3 - significant unobservable inputs. As of December 31, 2024 and 2023, the Plan had no assets which were required to be measured using Level 2 and 3 inputs.

#### **NOTE H - INVESTMENT CONTRACT**

As of July 1, 2021, the Plan's management entered into a contract with Voya. Voya maintains the contributions in a general account ("the Voya Fixed Account"). The account is credited with earnings on the underlying assets. The contract is included in the financial statements at contract value as reported to the Plan by Voya. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfers of all or a portion of their investment at contract value.

The Voya Fixed Account guarantees a minimum rate of interest and may credit interest that exceeds the guaranteed minimum rate. Daily credited interest becomes part of principal and the investment increases through compound interest. All amounts invested by the Plan in the Voya Fixed Account receive the same credited rate.

#### **NOTE I - TAX STATUS**

The Internal Revenue Service has determined and informed the Companies by a letter dated September 18, 1995 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). A subsequent favorable determination letter was received June 30, 2020. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or other applicable taxing authorities. Management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Tax returns for the prior three years remain subject to examination.
