Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Serrallés Hotel, Inc. The following description of the Serrallés Hotel, Inc. Retirement Savings Plan (“the Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Serrallés Hotel, Inc. (the Sponsor) after completing one year of service and attaining a minimum age of 21 years old. Effective on December 1, 2020, the Sponsor adopted the Popular Master Defined Contribution Retirement Plan Master Trust (the Master Trust) managed by Banco Popular of Puerto Rico (the Trustee). The Trustee also became the Plan’s custodian and recordkeeper.

The Plan is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA) and the Puerto Rico Internal Revenue Code (the Code).

Contributions

Employee contributions

Each year, participants may contribute up to \$15,000 of pretax annual compensation as established by the Code, as amended. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$1,500 per year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

Employer contributions

The Sponsor matches 100% of the first 3% of base compensation that a participant contributes to the Plan.

Participant accounts

Each participant's account is credited with the participant's contributions and the Sponsor's matching contributions, as well as, allocations of the Sponsor's profit sharing and additional contributions, if any, plan earnings (losses) and administrative expenses. Allocations are based on participants' earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1 - Description of the plan – (continued)

Vesting

Participants are immediately vested in their voluntary contributions and the Sponsor's matching contributions, plus actual earnings thereon.

Payment of benefits

On retirement, death, disability or termination of service, a participant or the participant's beneficiaries may elect to receive the vested interest in their account in either a lump-sum amount or periodic installments. In addition, the Plan provides for in-service distributions in certain circumstances, including financial hardship withdrawals, subject to certain limitations. Also, in-service distributions may be available to participants as special disaster distributions, as determined by the Puerto Rico Treasury Department.

Forfeitures

Upon termination from employment or withdrawal from the Plan for any reason other than death, retirement or disability, the Sponsor's contributions on behalf of the participants not then vested are forfeited. As of December 31, 2024, forfeited nonvested accounts amounted to \$1,935. There were no forfeited nonvested accounts as of December 31, 2023. These accounts will be used to reduce future Sponsor contributions. No forfeited nonvested account balances were used during the year ended December 31, 2024.

Notes receivable from participants

Notes receivable from participants are not permitted.

Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA and the Code. In the event of the Plan's termination, participants will become fully vested in their account balances.

Note 2 - Summary of significant accounting policies

Basis of accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Note 2 - Summary of significant accounting policies – (continued)

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments consist of its interest in the Master Trust, which is reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments, includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Excess contribution payable

Amounts payable to participants for contributions in excess of amounts allowed by the Code are recorded as a liability in the accompanying statements of net assets available for benefits, with a corresponding reduction to contributions.

Benefit payments

Benefits are recorded when paid.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. In addition, certain investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Note 2 - Summary of significant accounting policies – (continued)

Benefits payable

The Plan accounts for benefits payable in accordance with guidance provided by the American Institute of Certified Public Accountants (AICPA), *Audit and Accounting Guide, Audits of Employee Benefit Plans*. This guidance requires that benefits payable to persons who have withdrawn from participation in a defined contribution plan be disclosed in the notes to the financial statements rather than recorded as a liability of the Plan. Benefits payable as of December 31, 2024 amounted to \$3,133. There were no benefits payable as of December 31, 2023.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Reclassifications

Certain reclassifications have been made to the prior year financial statements to conform them to the current year presentation.

Note 3 - Certified investments information

Certain information in the accompanying financial statements and ERISA required supplemental schedule, related to investments held in the Master Trust as of December 31, 2024 and 2023, and the related net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Banco Popular de Puerto Rico, a qualified institution.

Note 4 - Interest in the Master Trust

The Plan's investment consists of its interest in the Master Trust, which was established for the investment of the assets of plans sponsored by those single employers or groups of employers under common control that execute the corresponding adoption agreement. The Plan has a divided interest in the Master Trust. The assets of the Master Trust are held by the Trustee.

Note 4 - Interest in the Master Trust

The value of the Plan's interest in the Master Trust is based on the beginning of year value of the Plan's specific interest in the Master Trust, plus actual contributions and allocated investment income, less actual distributions and allocated administrative expenses. Total investment income (including net appreciation (depreciation) in the fair value of investments) of the Master Trust is allocated to the Plan based upon the specific investments comprising the Plan's interest in the Master Trust.

Note 5 - Fair value measurement

Financial Accounting Standards Board, Accounting Standards Codification (ASC) No. 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for the Plan's interest in the Master Trust that is measured at fair value:

Money market funds and deposits - Money market funds and deposits are valued at cost, plus accrued interest, which approximates fair value. These investments are classified as Level 1.

Mutual funds - Mutual funds are valued at the daily closing price as reported by the funds. Mutual funds held by the Master Trust are open-end mutual funds that are registered with the Securities Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Master Trust are deemed to be actively traded and classified as Level 1.

Note 5 - Fair value measurement – (continued)

The preceding valuation methods may result in fair values that may not be indicative of net realizable values. The use of different methodologies or assumptions to determine the fair value of certain investments could have resulted in different fair value measurements at the reporting date. The Plan management believes such valuation methods are appropriate and consistent with other market participants. There were no changes in the Plan’s valuation methodologies used at December 31, 2024 and 2023.

Note - 7 Non-discrimination test

During the year ended December 31, 2023, the Plan failed the Average Deferral Percentage (non-discrimination) test required by the Code. For the year ended December 31, 2023, the Sponsor elected to refund excess contributions to highly compensated employees amounting to \$5,049, which have been recorded as a liability in the accompanying 2023 statement of net assets available for benefits. Excess contributions for the year ended December 31, 2023, were reimbursed to the corresponding participants in February 2024.

During the year ended December 31, 2024, the Plan complied with the non-discrimination test.

Note - 8 Tax status

The Plan constitutes a qualified plan, exempt from income taxes under the provisions of the Code. The Plan obtained a favorable determination letter on November 22, 2021, in which the Commonwealth of Puerto Rico tax authorities stated that the Plan was in compliance with the applicable requirements of the Code. The Plan has been amended since receiving its determination letter, however, the Plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Code and the Plan and related trust continue to be tax-exempt.

Management has evaluated the tax positions taken by the Plan and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that will require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements.

Note 9 - Subsequent Events

The Plan has evaluated subsequent events through September 30, 2025, which is the date the financial statements were available to be issued. No events have occurred subsequent to the statement of net assets available for benefits date and through the date the financial statements were available to be issued, that would require additional adjustments to, or disclosure in, the financial statements.
