### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Gino's Distributing, Inc 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits-modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits-modified cash basis for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Gino's Distributing, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis of Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Gino's Distributing, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Gino's Distributing, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 - DESCRIPTION OF PLAN:**

The following description of the Gino's Distributing, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

***General:***

The Plan is a defined contribution plan covering all employees of the Company who have one year of service and are age eighteen (18) or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participants may direct the investments of their accounts among alternative investment funds provided by the Plan.

***Contributions:***

Each year, participants may contribute to 90% of their pretax annual compensation, as defined in the Plan, and subject to certain annual limitations. Catch-up contributions are not permitted. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a common collective trust as investment options for participants. Contributions are automatically invested in a designated balanced fund until changed by the participant. The Company contributes matching contributions to the Plan and can make additional discretionary profit sharing contributions. The required Company matching contribution is 50% of the first 5% of base compensation that a participant contributes to the Plan.

***Participant Accounts:***

Each participant's account is credited with the participant's contribution and an allocations of (a) the Company's matching contribution (b) Plan earnings (losses), and (c) personal employee voluntary contributions, transfer contributions and rollover contributions, and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled to is the benefit that can be provided from the participant's vested account.

***Vesting:***

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service, as follows:

***Payment of Benefits:***

Upon retirement (normal retirement age is 65 and early retirement is age 59.5), death, disability or other termination of employment, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annuity payments. Lump sum distributions will be made to terminated participants when the vested account balance is less than \$5,000.

***Payment of Benefits: (Continued)***

On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account, or annual installments over his or her life expectancy recalculated annually.

***Forfeited Accounts:***

Forfeitures of nonvested balances remain in the Plan to reduce either Company matching contributions or Plan expenses. During 2024 and 2023, \$26,251 and \$7,808 of forfeitures were used to offset employer contributions, respectively. Additionally, during 2024 and 2023, \$26,431 and \$6,493, respectively, were forfeited from nonvested accounts. Forfeited nonvested accounts available to reduce future company contributions or plan expenses totaled \$563 and \$264 at December 31, 2024 and 2023, respectively.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

***Basis of Accounting:***

The accompanying financial statements have been prepared on the modified cash basis of accounting. Under that basis, contributions and earnings are recorded when received rather than when earned, and distributions and expenses are recorded when paid rather than when incurred. Accordingly, the accompanying financial statements are not intended to present financial position and results of operations in conformity with generally accepted accounting principles.

***Investments Valuation and Income Recognition:***

Investments held by a defined contribution plan are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividend income is recorded on the modified cash basis of accounting. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits:***

Benefits are recorded when paid.

***Date of Management's Review of Subsequent Events:***

Subsequent events were evaluated through the date of the auditors' report, which is the date the financial statements were available to be issued.

***Operating Expenses:***

A portion of the operating expenses of the Plan are paid by the Company and therefore excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

**NOTE 3 - FAIR VALUE MEASUREMENTS:**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets having the highest priority. Level 2 inputs consist of observable inputs other than quoted market prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the years presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

***Level 1 Fair Value Measurements:***

***Mutual Funds:***

The fair value of mutual funds is based on quoted net asset values of the shares held by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

***Level 2 Fair Value Measurements:***

***Common/Collective Trust***

The Plan's NAV funds are primarily composed of Common Collective Trust (CCT's) which are measured daily and may be redeemed daily with no restrictions related to the redemption notice period.

**NOTE 4 - PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

**NOTE 5 - TAX STATUS:**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

**NOTE 6 - CERTIFIED INVESTMENTS:**

*Investment Information Certified by the Plan Trustee:*

For the period ended January 1, 2023 through September 30, 2023, American Funds Retirement Plan Services, custodian of the Plan, held the assets of Plan participants and executed transactions therein. For the period October 1, 2023 and the year ended December 31, 2024, Reliance Trust Company, trustee of the Plan held the assets of Plan participants and executed transactions therein. Information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by the trustees. **NOTE 8 - RELATED PARTY TRANSACTIONS:**

ADP Retirement Services is the Plan's recordkeeper. Fees paid to ADP Retirement Services for the years ended December 31, 2024 and 2023 were \$57,666 and \$5,364, respectively. These transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 10 - PLAN CUSTODIAN AND RECORDKEEPER:**

The Plan Sponsor changed the trustee custodian and recordkeeping services from Capital Bank & Trust and American Funds to Reliance Trust Company and ADP Retirement Services in 2023. The Plan assets were transferred to Reliance Trust Company in September 2023 and there was a required "blackout period" during which plan participants could not make changes to their investments.

**NOTE 11 - PLAN RESTATEMENT AND AMENDMENT**

The Plan was amended and restated effective October 1, 2023 to allow participants to make Roth elective deferrals and to allow participants to enter into the plan the first day of the month following the month that age and service requirements are met.
