### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Dressman, Benzinger & Lavelle, P.S.C. 401(K) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certification from a qualified institution as of and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### Opinion on the 2024 Financial Statements

- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion on the 2024 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. **NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Dressman, Benzinger & Lavelle, P.S.C. 401(K) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan Adoption Agreement, which is available from Dressman, Benzinger & LaVelle, P.S.C. (the "Company"), for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan. It was adopted by the Company on July 1, 1984 and was restated January 1, 2024. The Plan's assets are held in a trust and are administered by the Plan's trustees. The Company appoints trustees to administer the Plan.

**Eligibility**

The Plan is a defined contribution plan covering substantially all employees of the Company who have attained the age of twenty-one and completed two months of credited service.

**Contributions**

Each participant may make voluntary contributions to the Plan by an employee salary reduction election up to the annual maximum amount permitted by the Internal Revenue Service ("IRS") through payroll deductions. Eligible employees who fail to make an affirmative plan election will be automatically enrolled into the Plan at a "default" contribution rate of 2% of compensation. The Company will make a discretionary match contribution of no less than 3% of eligible pay contributed each pay period. The Company can also elect to make additional discretionary contributions.

The Company makes a non-elective safe harbor contribution to the Plan. During 2024, the Company contributed 3% of compensation for all eligible participants. The contribution for 2024 was \$371,367.

The Company may elect to make a profit sharing contribution to the Plan of a discretionary amount. The profit sharing contribution for 2024 was \$397,827.

**Participants' Accounts**

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's matching contribution, (b) the Company's discretionary contribution, and (c) plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants can change their deferral percentages four times a year, January 1, April 1, July 1, and October 1. Participants may designate investment of the amount held in their account and earnings thereon in various funds. Participants may change their investment options daily.

**Vesting**

Participants are immediately vested in their contributions and employer matching contributions plus actual earnings thereon. Vesting in the Company's discretionary portions of their accounts plus actual earnings thereon is based on years of continuous service. Participants are fully vested upon completion of six years of credited service.

**NOTE 1 - DESCRIPTION OF THE PLAN (Continued)**

**Forfeitures**

Forfeitures may be used in succeeding years to reduce employer contributions or pay plan expenses. The balance in the forfeiture account at December 31, 2024 was \$1,833 and December 31, 2023 was \$29,911. Forfeitures of \$29,911 were used to reduce plan expenses and employer contributions for the year ended December 31, 2024.

**Payment of Benefits**

Upon termination of service due to death, disability, retirement, other termination of employment with the Company, a participant may elect to receive a cash, in-kind, lump-sum, or installments amount equal to the value of the participant's vested interest in his account. Participants with a vested account balance of \$5,000 or less may be automatically distributed.

In-service distributions are permissible for participants that have attained the age of 59 ½. Participants electing in-service distribution may elect to receive all or a portion of their vested balance. A participant who makes a withdrawal after age 59½ will not be subject to penalty and can remain an active participant in the Plan.

In conditions of "financial hardship," a participant may apply to the plan administrator for approval to withdraw that portion of their 401K retirement account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code ("IRC").

**Notes Receivable From Participants**

Effective January 1, 2024, the Plan was restated to allow participant loans. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested participant account balance. The maximum loan period cannot exceed five years. Loans bear interest at the Prime Rate plus 1% per year as determined by the plan administrator. Interest is charged until the loan is repaid and loans are not placed on nonaccrual status. Loans are always fully collected and are not charged off as uncollectible. Loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recognized at the time payment is made. Principal and interest is paid ratably through payroll deductions and is credited to each participant's account balance. Loans are considered past due when scheduled payments are more than 30 days behind the original loan agreement payment schedule.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and such amounts will be distributed pursuant to the terms of the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP") and conform to the accounting requirements of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**Notes Receivable from Participants**

Participant loans are classified as notes receivable from participants and measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans, if material, are reclassified as distributions based on the terms of the Plan document.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Fees for investment management and plan administration services are included in administrative expenses and allocated to participants' accounts by the Plan's recordkeeper. Fees for the administration of notes receivable from participants and participant distributions are included in administrative expenses and are charged directly to the participant's account.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value, except for the unallocated insurance contract and life insurance policy, which are reported at contract value and cash surrender value, respectively. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Units of pooled separate accounts are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payments of Benefits**

Benefits are recorded when paid.

**Reclassifications**

Certain reclassifications of prior year figures were made in order to be comparative with the current year.

**NOTE 3 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 4 - FAIR VALUE OF FINANCIAL INSTRUMENTS**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts which are reported at contract value) in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 1 or Level 3 inputs were available to the Plan.

*Level 2 Fair Value Measurements*

The fair value of pooled separate accounts is based on the unit price reported by the sponsoring insurance company. Generally, the unit price is based on quoted market prices of the underlying investments owned, less any accrual of fees and expenses borne by the account, and divided by the number of shares outstanding.

The fair value of the life insurance policy's cash surrender value is based on observable inputs provided by the insurance carrier, including the underlying contract value and credited interest rates, as described under ASC 820, *Fair Value Measurement*

The Plan maintains a life insurance policy as part of its investment portfolio. The policy is held for the benefit of participants and provides both an investment component and a death benefit feature. The policy is carried at its cash surrender value, which approximates fair value and is reported as an investment of the Plan in the accompanying financial statements.

As of December 31, the life insurance policy had the following values:

The investment in life insurance represents a funding vehicle permitted under the Plan and complies with applicable provisions of the Internal Revenue Code. The cash surrender value reflects the amount that would be realized upon surrender of the policy as of the plan year-end, net of any surrender charges or outstanding policy loans.

Premiums paid and changes in the cash surrender value during the year are included in Plan contributions and investment income, respectively. Policy loans, if any, are considered a reduction of the policy's cash surrender value and accrue interest at the rate specified in the policy agreement.

No amounts are due from or payable to the insurance carrier as of the report date other than those reflected above.

Gains and losses (realized and unrealized) included in changes of net assets available for benefits for the year-ended December 31, 2024 are reported in net appreciation (depreciation) in fair value of investments.

During 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$3,537,547.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are units of pooled separate accounts managed by John Hancock Life Insurance. John Hancock Life Insurance is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management and administrative services amounted to \$71,549 for the year ended December 31, 2024.

Certain employees of Dressman, Benzinger & LaVelle, P.S.C. (the "Company") provide administrative and executive oversight services to the Plan. The Plan is not charged by the Company for the services.

**NOTE 6 - INCOME TAX STATUS**

The Plan obtained its latest determination letter on June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended, the plan administrator and the Plan's tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date and no provision for income taxes has been included in the Plan's financial statements.

The Plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021. There are currently no audits for any tax periods in progress.

**NOTE 7 - INFORMATION CERTIFIED BY THE TRUSTEES**

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by John Hancock Life Insurance Company for December 31, 2024 and for December 31, 2023, the trustee.

**NOTE 8 - GAURANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

In 2023, the Plan entered into a fully benefit-responsive contract with John Hancock Life Insurance Company. John Hancock Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by John Hancock Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value, which is an appropriate determination of fair value, of the investment contract at December 31, 2024 and 2023 was \$1,672,053 and \$1,681,217, respectively. The crediting interest rate is based on a formula agreed upon by the issuer, but may not be less than 1.00%. Such interest rates are reviewed on an annual basis for resetting.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact a contract value with John Hancock Life Insurance Company. Such events include the following: amendments to the plan documents (including complete or partial plan termination or merger with another plan), changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that causes significant withdrawal from the Plan, or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the ERISA.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value.

**NOTE 9 - PROHIBITED TRANSACTIONS**

During 2023, the Plan engaged in certain transactions with parties-in-interest that are considered prohibited transactions under ERISA. These transactions consisted of delays in the remittance of participant contributions totaling \$53,741. The Plan Sponsor has remitted these contributions during 2023 and remitted related lost earnings to the Plan in 2024 totaling \$92. Management has evaluated the impact and determined that no additional corrective action is required.

**NOTE 10 - SUBSEQUENT EVENT REVIEW**

In July 2025, the Plan was amended and restated to modify the eligibility provisions, allowing employees to become eligible to make elective deferrals immediately upon their date of hire.

The Plan has evaluated all other subsequent events through October 14, 2025, the date the financial statements were available to be issued.
