Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Osborn 403(b) Defined Contribution Retirement Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1. Description of the Plan

General

The following description of The Osborn 403(b) Defined Contribution Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a contributory defined contribution plan covering all eligible employees of the controlled group of employers of the Miriam Osborn Memorial Home Association and Sterling Home Care, Inc. dba Osborn Home Care (collectively referred to as the Osborn) (the Sponsor). The Plan was originally adopted on July 1, 2011, and it is a contributory defined contribution plan covering all employees. It is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Effective December 31, 2019, the Plan became a volume submitter 403(b) tax deferred annuity plan.

Contributions

The Plan is a contributory defined contribution plan covering all eligible employees. An employee becomes eligible to participate in the Plan upon reaching age 21. The Osborn shall make a contribution equal to 3% of compensation for all eligible employees. Employees have the opportunity to add additional funds on a pretax basis and the Osborn will match 50% of the first 3% that the employee contributes to the fund. New employees are eligible for the safe harbor and employer match contributions after 90 days of employment.

The total contribution to the Plan may not exceed the dollar limit for tax-deferred contributions set by the Internal Revenue Code. Participants age 50 or more may make additional "catch-up" contributions.

Participant Investment Account Options

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options at any time.

The plan document also includes an automatic deferral feature whereby a participant is treated as electing to defer 5% of eligible compensation unless the participant made an affirmative election otherwise.

Participant Accounts

Each participant's account is credited with the participant contribution and allocations of (a) the Osborn's contribution, and (b) the participant's share of plan earnings. Plan income and expenses are credited or debited to participant accounts based on the pro rata share of the participant's individual account balance to total plan assets. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Additionally, participants are immediately vested in The Osborn's non-elective, safe harbor contribution. Vesting in the Osborn's matching contributions to participants' accounts is based on continuous years of service. A participant is 100% vested in the Sponsor's matching contributions after three years of service provided the employee works 1,000 hours or more each year.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$239 and \$312, respectively. These accounts will be used to pay plan expenses or reduce future employer contributions. Forfeitures of \$35,600 were used to reduce employer contributions in 2024. During 2024, there were \$35,296 of forfeitures incurred.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons and if the vested benefit in the Plan does not exceed \$5,000, then benefits may only be distributed in the form of a lump-sum payment. If the vested benefit in the Plan exceeds \$5,000, distribution in a form other than an annuity payment requires the annuity form of payment to be waived.

Notes Receivable from Participants

Participant loans are available to all participants. The interest rates at December 31, 2024 and 2023, were 5.25% to 10.5%. The loans to participants are in accordance with the terms and conditions specified in the plan document. The Plan has determined that an allowance for doubtful accounts was not necessary as of December 31, 2024 and 2023.

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance of \$50,000 reduced by the highest outstanding loan balance in the past year. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 2% above the prime rate, as defined. Principal and interest are paid directly by employees to Transamerica Retirement Solutions, LLC.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's investments in the group fixed annuity contracts with Lincoln Financial Group and Transamerica Financial Life Ins. Co. as of December 31, 2024 and 2023 are recorded at contract value. Contract value represents contributions made under the contract, plus a minimum rate of interest earned, at a rate determined by Lincoln Life & Annuity Company of New York and Transamerica Financial Life Ins. Co., less withdrawals and transfers to other accounts. This account does not have any liquidity restrictions, is fully benefit-responsive, and has been classified as a group fixed annuity contract and fixed interest account (see Note 6 for a further discussion of the group fixed annuity contracts).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Money market fund and mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. As applicable, interest income is recorded on the accrual basis and dividend income is accrued on the ex-dividend date. The income or loss of each investment option, including the change in market value of investments, is allocated to participant accounts based on each participant's proportionate interest in the investment option. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are deemed distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Certain administrative expenses are paid for by the Plan. Audit fees are paid by the Plan Sponsor. Fees paid to Transamerica Retirement Solutions, LLC for investment management services are paid by the Plan as a reduction of investment returns.

Note 3. Certification of Plan Custodians

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, State Street Bank and Trust Company and Transamerica Financial Life Insurance Company, qualified institutions, have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Related-Party Transactions and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain plan investments are shares of mutual funds held by State Street Bank and Trust Company, the custodian, and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Sponsor directly pays any other fees related to the Plan's operations. The Sponsor provides certain administrative services at no cost to the Plan.

The Plan paid \$84,942 of management fees to Transamerica Retirement Solutions, LLC during the year ended December 31, 2024.

Note 5. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, investments are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of investments with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such investments are

classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 6. Group Fixed Annuity Contract with Lincoln Financial Group and Transamerica Financial Life Ins Co.

The Plan has a fully benefit-responsive group fixed annuity contract with Lincoln Financial Group. at December 31, 2024 and 2023 totaling \$2,259,829 and \$3,344,767, respectively. During 2024, the Plan entered into Transamerica Financial Life Ins Co. fully benefit-responsive group fixed annuity contract at December 31, 2024 totaling \$717,904. These contracts are credited an interest rate, which generally varies with each deposit. There is no specific formula used to credit interest rate and the interest rate is not tied to the performance of a set of assets. The interest rate is credited based upon a number of factors, including, but not limited to, the level of net investment income that the company can earn on its newly purchased general account assets, the absolute level of interest rates, the shape of the yield curve, how interest rate has moved since the inception of the contract, and the minimum guaranteed interest rate. The contract has a minimum guaranteed interest rate of 2.0% with Lincoln Financial Group. The contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Effective June 1, 2024, Lincoln Stable Value Account is no longer offered to participants for new contributions and transfers in. The contract with Transamerica Financial Life Ins Co. has a minimum guaranteed interest rate of 3.0%. At December 31, 2024, the interest rate was 4.75%.

The group fixed annuity contracts meet the fully benefit-responsive investment contract criteria, and, therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligation. The issuer's ability to meet its contractual obligation may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuers. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
- Premature termination of the contracts
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the Plan Sponsor or other Plan Sponsor events (e.g., divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

In addition, certain events allow the issuers to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

Management believes no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

The group fixed annuity contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Osborn has the right under the Plan to discontinue its contributions at any time and/or to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will remain 100% vested in their accounts, including employer contributions, which will be distributed in a lump sum.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Plan's statements of net assets available for benefits.

Note 9. Tax Status

The Plan operates under a volume submitter 403(b) plan document sponsored by Transamerica Retirement Solutions LLC. This volume submitter plan document has obtained an advisory letter from the IRS stating that the volume submitter satisfies the requirements under Section 403(b) of the Internal Revenue Code. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
