Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Basis for Opinion

Responsibilities of Management for the Financial Statements

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – DESCRIPTION OF PLAN

Allied Fire Protection, LP 401(k) Profit Sharing Plan and Trust (the Plan) is a qualified plan adopted by Allied Fire Protection, LP and participating employers: AFP Alarm & Detection, L.P. and Allied Fire Protection-SA, L.P. (collectively, the Company) for the purpose of enabling eligible employees to save for retirement. The Plan was originally effective on March 1, 2002. The Plan was amended and restated effective January 1, 2024. The Plan is administered by the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The summary of significant provisions of the Plan presented below provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Eligibility: All non-excluded employees of the Company who have reached age 18 and completed three months of consecutive service are eligible to participate in the Plan. Participants will enter the Plan immediately after they have met all the age and service requirements.

Contributions: The Plan provides for voluntary participant contributions expressed as a percentage or a flat dollar amount of the participant's eligible pre-tax compensation. The Internal Revenue Code (IRC) limits the annual amount of salary deferrals that can be made by any participant. Participants who have attained or will attain age 50 by the end of the calendar year may make additional catch-up contributions. Rollovers are also permitted from distributions received from other qualified retirement plans.

The Company will contribute an amount equal to the sum of 100% of the participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the amount of the participant's elective deferrals that exceed 3% of the participant's compensation but do not exceed 5% of the participant's compensation.

The Company may also make a discretionary matching contribution equal to a uniform percentage of the participant's contributions. The Company will determine the amount of the discretionary matching percentage each year. The Company may also make a discretionary profit-sharing contribution, which is allocated based on the ratio of individual participant eligible compensation to total eligible compensation paid to all eligible participants.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and losses and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are immediately vested in their contributions and rollovers and the actual earnings thereon. A participant is vested in the employer contributions and earnings thereon based on a 5-year vesting schedule.

NOTE 1 – DESCRIPTION OF PLAN (Continued)

Payment of Benefits: Participants whose employment terminates for any reason are entitled to receive the vested account balance in the form of a lump sum distribution payable in cash, net of applicable tax, or a direct rollover distribution to a qualified plan or IRA, or a combination of a cash distribution and direct rollover distribution. If a participant's vested balance at the time they terminate from employment is \$1,000 or less, they must take it out of the Plan when they terminate employment. If a participant's vested account balance is between \$1,000 and \$5,000, they must take it out of the Plan or roll it over to an IRA. If a participant's vested account balance is greater than \$5,000, even if they terminate service, they are not required to take a distribution from the Plan until the required minimum distribution rules apply. In the event of a participant's death, the beneficiary or beneficiaries will be entitled to receive the participant's account balance.

Participants may take in-service distributions while still employed with the Company if they are age 59½ or older at the time of the distribution. Hardship distributions may also be made to satisfy certain immediate and heavy financial needs that a participant may have.

Notes Receivable from Participants: Participants are permitted to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are generally repaid within five years. Principal and interest payments are paid ratably through payroll deductions. Participant loans are evidenced by promissory notes, which are adequately secured by the balance in a participant's account and bear interest at a rate commensurate with local prevailing rates.

Forfeited Accounts: If a participant terminates employment and takes a distribution from the Plan, the nonvested portion of their account will be forfeited. Forfeitures will be used to offset employer contributions to the Plan. At December 31, 2024 and 2023, forfeited accounts totaled \$30 and \$4, respectively. During 2024, approximately \$44,357 of forfeitures were used to offset employer contributions.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, all participants become 100% vested.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 14, 2025, which is the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participant's account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits were recorded when paid.

Excess Contributions: Refunds of excess participant deferral contributions may be required to satisfy the relevant nondiscrimination provisions of the Plan. Such refunds are accrued as a liability and reduction in contributions in the Plan year in which the excess deferrals were made to the Plan.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – CERTIFIED INFORMATION

Except for net appreciation in fair value of investments of \$115,840, substantially all information related to the investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (as of December 31, 2024 and for the period from January 18, 2024 to December 31, 2024) and Ascensus, LLC as agent for Ascensus Trust Company (as of December 31, 2023).

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Money Market Mutual Fund: The fair value of money market mutual fund investments is determined using quoted market prices for the fund's net asset value per share (Level 1 inputs).

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trust Fund: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company.

ADP Retirement Services, Reliance Trust Company, Ascensus, LLC and Ascensus Trust Company are service providers to the Plan and, therefore, the Plan's payment of fees to the service providers qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated October 6, 2020 indicating that the non-standardized pre-approved profit sharing plan with CODA adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original non-standardized pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
