INDEPENDENT AUDITOR'S REPORT

To the Participants and Administrator
Ubiquity Global Services, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Ubiquity Global Services, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 — DESCRIPTION OF THE PLAN

The following description of the Ubiquity Global Services, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan, covering all employees, except nonresident aliens, leased employees and those covered by a collective bargaining agreement, of Ubiquity Global Services, Inc (the “Company”). Eligible employees are able to participate in the Plan upon attainment of 6 months of service and be age 21. Employees will become participants on the first day of the month coinciding with or next following date the eligibility requirement is satisfied. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

In 2024, the Company acquired Conner Enterprises Inc (“Conner”) and effective June 1, 2024, Conner became a participating employer of the Plan.

Contributions

Participants may make voluntary pretax and Roth contributions subject to certain limitations under the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan under a qualified automatic enrollment arrangement (“QACA”). Automatically enrolled participants have their deferral rate set based on the Plan year. In Plan year 1 to 2 the deferral rate will be at 3% of eligible compensation and will increase by 1% every year thereafter until Plan year 6, where the maximum deferral will be 6% of their contributions invested in a designated balanced fund until changed by the participant.

The Company will make a QACA safe harbor matching contribution equal to 100% of salary deferrals that do not exceed 1% of compensation plus 50% of salary deferrals between 1% and 6% of compensation. The Company may also make discretionary matching contributions equal to a uniform percentage of salary deferrals and discretionary profit sharing contributions. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Participant Accounts

Each participant account is credited with participant contributions, QACA safe harbor matching contributions, Company matching contributions and Company profit sharing contributions, if any, and investment earnings and are charged an allocation of administrative expenses. Allocations of investment earnings and administrative expenses are based on a participant’s account balance relative to the total account balances of all participants in the same investment. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of credited service. A participant is 100% vested after six years of credited service as detailed below for both the discretionary matching and discretionary profit sharing contributions:

Payment of Benefits

Participants may be entitled to in-service distributions, which are made at the participants election. In-service distributions are permitted when a participant has reached age 59½ and is 100% vested. The Plan allows for qualified reservist distributions, which may be made if the participant meets the following requirements 1) a reservist or national guardsman 2) called to active duty after September 11, 2001 and 3) called for at least 180 days or for an indefinite period. The Plan also allows for hardship withdrawals, in accordance with provisions specified in the Plan. Upon termination of service for any reason, participants with a vested account balance that does not exceed \$5,000, will receive a distribution of their account balance. The Plan allows participants to delay distributions if their balance is over \$5,000. If a participant is a 5% owner, distributions are required to begin no later than April 1st following the end of the year in which the participant reaches age 70½. If the participant is not a 5% owner, distributions are required no later than April 1st following the later of the end of the year in which the participant reaches age 70½ or retires.

Notes Receivable from Participants

Participants may borrow from their retirement accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in a participant's account. The loan interest rate, determined by reviewing interest rates charged for similar types of loans by other lenders, will be fixed for the duration of the loan. Principal and interest is paid ratably through payroll deductions.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6,840 and \$11,889, respectively. These accounts may be used to reduce Plan expenses or fund amounts otherwise required to be contributed to the Plan. Forfeitures of \$11,209 were used during the year ended December 31, 2024 to fund QACA safe harbor matching contributions. Any forfeited nonvested accounts are held in an interest-bearing cash account by the custodian.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees for the administration of notes receivable from participants and benefits paid to participants are included in administrative expenses and charged directly to the participant's account. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.

On September 18, 2025, the Company acquired Peak Support and effective September 22, 2025, Peak Support became a participating employer of the Plan.

In 2025, the Board of Directors approved the merger of the Plan into a United Pooled Employer Plan (PEP) effective November 10, 2025. At this time, all Plan assets will be transferred to the PEP.

NOTE 3 — FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 inputs consist of unadjusted quoted prices in active markets, that the Plan has the ability to access, for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices of identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or 2 were not available.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Pooled separate accounts: The pooled separate accounts are invested in mutual funds listed on national securities exchanges are valued daily at the unit value of shares held by the Plan in the separate investment accounts based on the underlying mutual funds and their quoted net asset value (NAV). The Plan has concluded that the NAV as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company, denotes readily determinable fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 — INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company of New York ("John Hancock"), the custodian of the Plan, has furnished certain financial information to the Plan administrator and certified as to its completeness and accuracy. These certifications as of December 31, 2024 and 2023 and for the year ended December 31, 2024, and include investment information related to fair value of investments, notes receivable from participants, interest and dividend income, interest income on notes receivable from participants and net appreciation (depreciation) in fair value of investments that are included in the Plan's financial statements and supplemental schedule.

NOTE 5 — PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are shares of pooled separate accounts managed by the John Hancock Life Insurance Company of New York, the custodian of the Plan. Therefore, these transactions qualify as party-in-interest transactions.

The Plan allows participants to take loans against their account balances, which are also considered party-in-interest transactions. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 6 — PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their accounts.

NOTE 7 — RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 — TAX STATUS

The underlying non-standardized prototype plan has received an opinion letter from the IRS dated June 30, 2020, stating that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
