To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the AFC 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedules, Schedule H, Line 4a – Schedule of Delinquent Participant Contributions and Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the AFC 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

On January 1, 2000, Advanced Fresh Concepts Corp. (“AFC”) established the Plan as a defined-contribution and profit sharing retirement plan qualifying under Section 401(k) of the Internal Revenue Code (“IRC”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). In November 2018, AFC was acquired by Zensho Holdings Co., Ltd. (“Zensho Holdings”); in April 2019, Zensho Holdings transferred its ownership in AFC to Zensho USA Corporation (a wholly-owned subsidiary of Zensho Holdings).

The Plan covers eligible employees of AFC and participating companies, Advanced Fresh Concepts Franchise Corp. and AFC Distribution Corp. (collectively, the “Employer” or “Company”).

Administration

The Plan is administered by AFC. Effective January 1, 2024, the trustee of the Plan was changed to ADP Retirement Trust Services, LLC (“ADP”) and the recordkeeper of the Plan was changed to ADP, Inc. In addition, effective January 1, 2024, the Plan was restated to utilize a Defined Contribution Pre-Approved Plan sponsored by ADP, Inc. Before January 1, 2024, John Hancock Trust Company LLC (“John Hancock”), was the Plan’s trustee and John Hancock Retirement Plan Services, LLC was the Plan’s recordkeeper.

Eligibility

All employees of the Employer, with certain exceptions, who have completed one year of eligibility service, may participate in the Plan. A year of eligibility service is generally fulfilled after completing 1,000 hours of service during a twelve-consecutive-month eligibility period requirement. Employees are eligible to participate in the Plan on the first day of the month that coincides with or next follows the date the service requirement is satisfied.

Participant Contributions

Participants may elect to contribute up to a maximum of the lesser of 100% of eligible compensation or, as limited by Section 402(g) of the IRC, \$23,000 in 2024. Eligible employees may also roll over distributions from eligible retirement plans pursuant to the terms of the Plan.

The Plan provides that participants who are projected to be age 50 or older by the end of the calendar year are eligible to also make a catch-up contribution of up to \$7,500 in 2024.

Employer Contributions

The Company will make matching contributions in an amount equal to 50% of a participant’s elective deferrals subject to a maximum of 6% of a participant’s eligible compensation contributed to the Plan. The Company made matching contributions of \$337,304 for the year ended December 31, 2024. The Company, at its discretion, may make additional contributions; no additional contributions were made for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings and/or losses, and (c) an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of their contributions and any Employer contributions into various investment options offered by the Plan. The Plan offered registered investment companies and one stable value fund (common collective trust) as investment options. Participants may change their investment options at any time via ADP website.

Vesting

Participants in the Plan are fully vested in their contributions, including rollovers, and the actual earnings on these contributions. Participants become vested in the Company's matching contributions and related investment earnings/appreciation or depreciation based on years of service. Company matching contributions and related earnings/appreciation or depreciation shall be vested in accordance with the following schedule:

<u>Completed Years of Service</u>	<u>Vested Percentage</u>
Less than two	0%
At least two years, but less than three	20%
At least three years, but less than four	40%
At least four years, but less than five	60%
At least five years, but less than six	80%
Over six years	100%

Forfeitures

Upon termination of employment, the non-vested portion of the participant's account will be forfeited. Forfeitures retained in the Plan are used for the reduction of Plan administrative expenses or future Employer contributions. The Employer contributions were reduced by \$14,924 for the year ended December 31, 2024. As of December 31, 2024 and 2023, forfeited accounts totaled \$2,013 and \$6,555, respectively.

Notes Receivable from Participants

Loans are available in the Plan. The minimum loan amount is \$1,000. The maximum amount is the lesser of \$50,000 (reduced by the highest outstanding loan balance in the account during the prior twelve-month period) or one-half of the participant's vested account balance. The participant is allowed one loan outstanding at a time; loans bear interest at the Wall Street Journal (or similar financial publication) prime lending rate + 1%. Loan payments are made through payroll deductions typically over a period of five years; however, if the loan is for the purchase of a participant's principal residence, the Administrator may permit up to a thirty-year payment term (previous to July 1, 2022, a ten-year term may have been permitted). Each loan is secured by the balance in the participant's account.

Notes Receivable from Participants (Continued)

Outstanding notes receivable at December 31, 2024 and 2023 mature through 2028 and carry interest rates ranging from 4.25% to 9.50%.

Payment of Benefits

Withdrawals are permissible upon participant's reaching age 59½, termination of employment, death, disability, retirement or certain financial hardships. Vested benefits due to the participant or, in the event of death, to the participant's beneficiaries, in most events will generally be distributed in a lump sum payment, installments or can be rolled over into another qualified retirement plan. Accounts of terminated participants with balances less than \$7,000 but greater than \$1,000 will receive a lump sum payment, or if elected by the participant, to be rolled to another qualified retirement plan or to an individual retirement account (IRA). Participants with a balance less than \$1,000 will receive a lump sum payment unless otherwise elected.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate, discontinue making contributions to, amend, or modify the Plan at any time. In the event of a termination of the Plan, all participants will become fully vested in their accounts and the Company will arrange for distribution of all participants' accounts to the participants in accordance with the Plan.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits and changes therein. Actual results could differ from those estimates.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are to be recorded at their unpaid principal balance plus any accrued interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Excess Contributions Payable

The Plan, as required by the IRC, performs annual tests comparing participant data for highly compensated participants with data for non-highly compensated participants to ensure that highly compensated participants are not disproportionately favored by the Plan. If the Plan initially fails the tests, it will refund the excess contributions in the amount necessary to pass the tests. Excess contributions for 2024 amounted to \$26,086 and were refunded in the following year. This amount and \$34,810 have been recorded as excess contributions payable to participants as of December 31, 2024 and 2023, respectively, in the Statements of Net Assets Available for Plan Benefits.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 – CERTIFIED INFORMATION

The Plan's management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, ADP, the trustee of the Plan, has certified the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying Statements of Net Assets Available for Plan Benefits, as of December 31, 2024; Investments and notes receivable from participants reflected on the accompanying Statements of Net Assets Available for Plan Benefits, as of December 31, 2023 was certified by John Hancock.
- Net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants reflected on the accompanying Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024;
- Assets reflected on the Supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

NOTE 4 – FAIR VALUE MEASUREMENTS

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value valuation hierarchy under the standard are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Registered investment companies:

Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Common collective trust:

The common collective investment trust (Goldman Sachs Stable Value Collective Trust I) is valued at the NAV of units of the fund which is based on the estimated market value of the underlying investments less its liabilities. The NAV, as provided by ADP as of December 31, 2024 and John Hancock as of December 31, 2023, is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were managed by ADP or its affiliates. ADP is the trustee and, therefore, these transactions qualified as party-in-interest transactions. Fees incurred and paid directly by the Plan for administrative and management services was \$44,819 for the year ended December 31, 2024.

NOTE 6 – INCOME TAX STATUS

The Plan has adopted a non-standardized pre-approved plan document with an Internal Revenue Service (IRS) opinion letter dated June 30, 2020 which states the document, as then designed, is in compliance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan’s management has not identified any uncertain tax positions that would require recognition of a liability or asset or disclosure as of December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
