We have performed audits of the financial statements of the Apple Bank for Savings 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Basis for Opinion

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Notes to Financial Statements

Note 1. Description of Plan

The following description of the Apple Bank for Savings 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Apple Bank for Savings (the Bank or Plan Sponsor). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The annual compensation of each employee taken into account under the Plan shall not exceed the pretax annual compensation up to the maximum dollar limit imposed by the Internal Revenue Service (IRS).

Eligibility: Employees of the Bank are eligible to participate in the Plan immediately upon hire. There are no minimum age or minimum service requirement for participation in the Plan.

Auto-enrollment: The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until changed by the participant

Auto-escalation: The Plan also includes an auto-escalation provision whereby participants are subject to an annual automatic deferral rate increase of 1% until their deferral rate reaches 5% of eligible compensation. Participants may elect to discontinue their participation in the automatic deferral rate increase at any time.

Contributions: Participating employees may contribute a percentage of pretax annual compensation up to the maximum dollar limit imposed by the IRS. Participating employees may also elect to make Roth contributions (after-tax). At any time, a participant may change their contribution percentage.

A newly hired employee previously participating in an IRS-approved defined contribution plan of their former employer may transfer their funds from the former plan as rollover contributions to the Plan.

The Plan Sponsor will make a matching contribution to participating employees' account equal to 100% of the amount of their payroll deferral contributions up to 3% of their compensation, plus 50% of their payroll deferral contributions on the next 2% of compensation.

Participant accounts: Each participant's account is credited with the participant's contribution and Plan Sponsor's matching contribution. Plan earnings are allocated based on participant account balances, as defined.

Participants' investment options: Participants must direct their salary deferral contributions to one or a combination of 30 investment funds available through the Plan.

Employer matching contributions are invested in the same manner as the participant has elected to direct their contributions.

Vesting: Participants vest immediately in their elective contributions plus actual earnings thereon. Participants are immediately vested 100% in the Bank's matching contribution and cannot be forfeited even if the participant terminates employment.

Notes to Financial Statements

Note 1. Description of Plan (Continued)

Notes receivable from participants: Loans receivable are from participants who borrow against their vested amounts in an amount up to the lesser of 50% of the net value of the participant's account or \$50,000. Repayment of principal and interest is made over a period not to exceed five years unless the loan is for the purpose of acquiring a primary residence, in which case the term is not to exceed 15 years. Repayments are made through payroll deductions and are credited to participants' accounts and allocated to the investment funds in the same portion as the participant's contributions.

Interest on loans is accrued at 1% above the prime rate as published by *The Wall Street Journal* at the commencement of the loan. Repayments are made at employment termination by either payment in full by the participant or as forfeiture in the vested balance up to the outstanding loan amount.

Payment of benefits: When Plan participants terminate for any reason, a lump-sum distribution will be made if the vested interest of the participant's account does not exceed \$5,000. If the participant's vested account balance exceeds \$5,000, the participant may elect to receive a lump-sum distribution.

While an employee of the Bank, a participant may generally make Plan withdrawals from amounts attributable to the participant's contributions and from the vested portion of the Bank's matching contributions that have been in the Plan for at least 24 months (the 24-month rule does not apply to participants who are age 59½ or have been in the Plan for at least five years). Withdrawals may be made not more than twice during any plan year.

Participants who make hardship withdrawals are restricted from making additional contributions for the next six-month period following the withdrawal date.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment valuation and income recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Plan Sponsor and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable from participants that are charged to the participant's account. Investment-related expenses are included in net appreciation in fair value of investments.

Benefit payments: Benefits are recorded when paid.

Contributions: Contributions from the Plan participants and the matching contributions from the employer are recorded in the year in which participant compensation is earned.

Note 2. Summary of Significant Accounting Policies (Continued)

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent notes receivable from participants are treated as distributions, based on the terms of the Plan agreement.

Subsequent events: The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by Vanguard Fiduciary Trust Company (Trustee)

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by the trustee and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Vanguard Fiduciary Trust Company, the trustee, that the information provided to the Plan Administrator by the trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and ERISA required supplemental schedule related to the following assets:

Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

Note 4. Fair Value Measurements (Continued)

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

All transfers between fair value hierarchy levels are recognized by the Plan at the end of each reporting period. There were no significant transfers between Levels 1, 2 and 3 during the year.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund: The Vanguard Retirement Savings Trust III (the Trust) uses a stable value investment strategy. The fund primarily invests in investment contracts issued by insurance companies, banks, or other financial institutions. These contracts are backed by highly fixed securities. The fund aims to maintain a constant NAV of \$1.00 per share. This is achieved by diversifying among high-credit-quality investments and structuring the investments contracts to smooth out the market gains and losses over time. This approach helps provide stability of principal and consistent income.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (a) The fund employs a stable value investment strategy. The key elements of its strategy are:

Investment contracts: The fund primarily invests in synthetic investment contracts issued by insurance companies, banks, or other financial institutions. These contracts are backed by high-quality fixed-income securities.

Stability of principal: The main objective is to provide stability of principal while generating consistent income. This is achieved by maintaining a stable NAV of \$1.00 per share.

Diversification: The fund diversifies its investments among high-credit-quality fixed-income securities and investment contracts. This helps to smooth out market gains and losses over time.

Income generation: The fund seeks to provide current and stable income, making it suitable for retirement savings.

This strategy aims to offer a balance between preserving capital and providing steady returns, which is ideal for long-term investors focused on retirement.

Note 5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 6. Tax Status of the Plan

The Plan is a nonstandardized defined contribution preapproved plan and an opinion letter was received dated June 30, 2020, stating that the Plan is acceptable under Section 401(a) of Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan, as amended, is designed, and being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

The Plan Sponsor's management evaluated the Plan's tax positions and concluded the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that required adjustments to the financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024. Therefore, no provision or liability for income taxes has been included in the financial statements.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Bank reserves the right at any time to terminate the Plan, in whole or in part. In the event of Plan termination, distribution of the Plan's assets will be made to the participants and beneficiaries in the order prescribed by ERISA.

Note 8. Exempt Party-in-Interest Transactions

Vanguard Fiduciary Trust Company is the record keeper and trustee of the Plan. Certain Plan investments are shares of various funds managed by the trustee; therefore, any transactions between the Plan and the trustee are considered party-in-interest transactions.
