Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed an audit of the accompanying financial statements of Vantage Systems, Inc. 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Opinion

Basis for Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Vantage Systems, Inc. 401(k) Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined-contribution plan covering all employees of Vantage Systems, Inc., (the Plan sponsor or the Company), excluding union employees and non-resident aliens starting on the first day of the first month following their hire date. The Plan Administrator is responsible for oversight of the Plan including determining the appropriateness of the Plan's investment offerings and monitoring investment performance. ADP Retirement Trust Services served as the Plan's trustee and ADP, Inc., served as the Plan's record keeper and third party administrator. The Plan is subject to the provisions of the Employee Retirement Income Act of 1974 (ERISA).

Effective June 1, 2024, the Plan was amended and restated to bring the Plan into compliance with legislative and regulatory changes. In the restatement, Plan provisions were amended to a) modify the eligibility criteria to allow employees who are age 18 or older and b) increased the company safe harbor matching contribution to 100% of the participant's contribution not to exceed 4% of eligible compensation and c) increased the company safe harbor matching contribution to 50% of the participants contributions that exceed 4% not to exceed 5% of eligible compensation.

Income Tax Status

The Internal Revenue Service has determined and informed the Company by letter dated January 1, 2003, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Subsequent to this issuance of the determination letter, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan, as amended, is qualified and the related trust is tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan's informational return filings are subject to audit by the Internal Revenue Service, generally for three years after filing.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Contributions

Eligible participants may elect to make salary reduction contributions up to 90% of eligible compensation, as defined by the Plan, subject to the limitations of the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and a money market fund as investment options for participants. Participants may change their investment allocations daily. The Company makes profit-sharing and safe harbor matching contributions in an amount determined by the calculations stated in the Plan document for eligible participants. For the years ended December 31, 2024 and 2023, the Company made matching contributions of \$741,219 and \$723,149, respectively. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is participant-directed and is credited with the participant's and Company contributions. The investment of their contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested immediately in their contributions, Company safe harbor matching plus actual earnings, and Company profit sharing contributions.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance, or 100% of the balance in their account attributable to rollover contributions. The vested account balance available for loan is limited to the participant's pre-tax contributions. Loan terms range from one to five years or up to 15 years for the purchase of a primary residence. The loans are secured by the vested portion of the participant's account and bear interest at a rate that is commensurate with local prevailing rates, as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Payment of Benefits

The Plan provides for distribution of accumulated benefits upon death, separation of service, financial hardship, in-service at age 59 ½, disability, and retirement of participants. If the total benefit is \$1,000 or less, the entire amount is paid in a lump sum distribution. If the total benefit is greater than \$1,000, but less than \$5,000, the balance may be automatically rolled into an individual retirement account, unless the participant elects otherwise.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Financial Statements

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual amounts could differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's management determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant contributions and Company safe harbor contributions are recognized on the pay date to which they relate. Company profit-sharing contributions are recognized in the year as designated by the Partners of the Company.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent Events

The Plan evaluated subsequent events through the date that the financial statements were available to be issued. The Plan is not aware of any significant events that occurred subsequent to the statement of net assets available for benefits date but prior to October 8, 2025 that would have a material impact on the financial statements.

NOTE 3 - CERTIFIED INVESTMENTS

All investment data contained in the statement of net assets available for benefits as of December 31, 2024, the change of changes in net assets available for benefits for the year ended December 31, 2024, and the Schedule H, line 4i – schedule of assets (held at end of year) as of December 31, 2024 was summarized from information provided by ADP Retirement Trust Services, the Trustee of the Plan, and furnished to the plan administrator. The plan administrator has obtained a certification from the Trustee that the information provided to the plan administrator by the Trustee is complete and accurate.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows.

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Registered Investment Companies

The fair value of shares of registered investment companies are valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common-Collective Trust Funds

Valued on a daily basis using the amortized cost of the securities held in the fund.

Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.

NOTE 5 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by affiliates of the Plan trustee, and therefore, the transactions qualify as party-in-interest transactions. Personnel and facilities of the Company have been used to perform administrative functions for the Plan at no charges to the Plan. Notes receivable from participants also qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

NOTE 6 - PLAN TERMINATION

Although it is not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - PROHIBITED TRANSACTIONS

The accompanying schedule of delinquent participant contributions reflects participant contributions that were not remitted timely to the Trustee. The effect to the financial statements was an understatement of earnings. The amount is deemed material and has been recorded in the financial statements.

The delinquent contributions to the plan occurred due to the black out period from changing plan record keeper and plan administrator. Following the Company's internal review, the missing contribution was identified in December 2024 and submitted shortly after discovery.

NOTE 9 - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The financial statements are prepared on the accrual basis of accounting and include employer and employee contributions receivable and loss recovery receivable as of year-end that are recognized based on formal commitments or legal requirements. Form 5500 is prepared on a modified cash basis and does not include these contributions receivable unless they were received by the plan within the period specified by Form 5500 instructions. As a result, net assets available for benefits reported on Form 5500 differ from those reported in the financial statements by the amount of contributions and loss recovery receivables at year-end.
