(1) Description of Plan

The following brief description of the Dartmouth-Hitchcock Retirement Plan (the "Plan" or the "401(a) Plan") is provided for general information only. Participants should refer to the plan document for more complete information.

(a) General

The Plan is a defined contribution plan sponsored by Dartmouth-Hitchcock Health ("D-HH") covering certain employees of Mary Hitchcock Memorial Hospital and the Dartmouth-Hitchcock Clinic ("D-H"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Effective December 31, 2023, Dartmouth-Hitchcock Health assumed sponsorship of the Plan and as of that date all participants were covered by the Dartmouth Health 403(b) Plan. The Dartmouth-Hitchcock Retirement Plan was frozen to new participants and contributions as of that date.

(b) Eligibility

Employees, age 21 and older, who have either completed at least one year of eligibility service or are scheduled to work at least twenty hours or more per week, were eligible to participate in the Plan.

(c) Participant Accounts

Each participant's account is credited or charged with contributions, investment income, and investment transaction and redemption fees. Investment income, including realized and unrealized gains and losses, and expenses are allocated to participants' accounts based on each participant's account balance within each fund. Participants determine the percentage in which contributions are to be invested in each fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants may change their investment options as set forth in the plan document. Participants select the investments in which their contributions will be allocated. If a participant does not direct the contributions, they are invested in a target date retirement fund where the allocation strategy is consistent with the participant's date of retirement.

(d) Vesting

Participant contributions – Participants are always 100% vested in their own contributions, and earnings thereon.

Employer contributions – All D-H contributions are 100% vested upon completion of three years of vesting service. A year of vesting service is one in which the participant works 1,000 hours or more. Employees leaving the D-H organizations prior to satisfying the three-year vesting requirement will forfeit all D-H contributions and earnings thereon.

(e) Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents a forfeiture, as defined by the Plan. Forfeited balances are first used to restore re-employed participants' accounts. Any remaining forfeitures may be used to pay plan expenses or to reduce employer contributions. Forfeitures in the amount of \$1,020,436 were used to reduce employer contributions in 2024 and \$249,881 were used to pay plan expenses. Unallocated forfeitures at December 31, 2024 and 2023 were \$2,348,460 and \$747,772, respectively.

(f) Payment of Benefits

Upon termination of service (retirement, death or disability), participants may elect to leave their account balance in the Plan or receive a distribution. The following options are available to those electing a distribution: 1) a lump-sum or partial distribution; 2) deferral of the receipt of distribution until age 70; 3) rollover of a lump-sum distribution into an IRA if done so within 60 days of the distribution; or 4) election of payments in installment amounts over monthly 5, 10, 15, or 20 year intervals.

Participants may withdraw their voluntary after-tax contributions, subject to certain restrictions, while still actively employed by D-H. A participant may request a withdrawal of their pretax contributions or any of D-H's contributions upon attainment of age 59 1/2 or upon demonstration by the participant to the plan administrator that the participant is suffering from "hardship", as defined in the plan document.

(g) Notes Receivable from Participants

Participants may borrow against their own accounts an aggregate amount up to the lesser of \$50,000 or 50% of the participant's vested account balance, subject to plan limitations. Loans must bear the Prime interest rate plus 1%. All loans must be repaid within five years unless the proceeds are used to acquire a principal residence, in which case a longer repayment period is allowed. Only one loan may be outstanding at any time. Participants with loans prior to the Plan's inception were allowed to have two loans outstanding at one time.

Principal and interest is generally repaid at least quarterly by participants directly to the plan recordkeeper. During the repayment period of a loan, the Plan's recordkeeper reallocates the repayment amounts among the investment funds in the same proportion as current investment allocations.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation (depreciation) includes gains and losses on investments bought and sold as well as held during the year.

(d) Payment of Benefits

Benefits are recorded when paid.

(e) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

(f) Administrative Expenses

All expenses of administering the Plan may be paid by the Plan, unless paid by D-HH, the Plan sponsor, Mary Hitchcock Memorial Hospital or Dartmouth Hitchcock Clinic. Investment transaction and redemption fees are born by plan participants. Expenses that are paid by D-HH, the Plan sponsor, Mary Hitchcock Memorial Hospital or Dartmouth Hitchcock Clinic are excluded from these financial statements.

(3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- *Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- *Level 2* - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- *Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used by the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Variable annuities - Valued at the net asset value of units of a variable annuity. The net asset value, as provided by the contract issuer, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

Common collective trust - A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities.

Guaranteed insurance contracts (non benefit-responsive) - The TIAA Traditional Annuity is valued at fair value by TIAA by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. Since participants transact at contract value, fair value is determined annually for financial statement reporting purposes only. In determining the reasonableness of the methodology, a variety of factors are used in the evaluation, including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms (for example, minimum crediting rate, duration or payout date) while others are substantiated utilizing available market data (for example, discount rate).

Pooled separate account - Valued at the net asset value of units of a pooled separate account. The net asset value, as provided by the contract issuer, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

Self-directed brokerage accounts - Invested in cash and mutual funds valued at the net asset value of the shares held by the Plan at year end as determined by quoted market prices.

(1) In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

Pooled separate account - There are no unfunded commitments. Although the underlying assets of the account cannot be quickly sold and converted to liquid assets, the TIAA general account provides the account with a liquidity guarantee which ensures the account has the funds available to accommodate participant redemption requests. Redemptions are limited to one per calendar quarter.

Common collective trust - There are no unfunded commitments. Redemptions are allowed daily for participants; however, the Plan may be subject to a twelve-month redemption notice period.

Variable annuities - There are no unfunded commitments. There are no restrictions on redemptions of these investments for participant-initiated transactions.

Accounting standards require disclosure of investment strategies for investments valued using net asset value as a practical expedient to estimate fair value if the investment does not file a Form 5500 with the DOL as direct filing entity ("DFE"). The following table discloses investment strategies for such investments:

- (a) The stock variable annuity seeks a favorable long-term rate of return through capital appreciation and investment income by investing primarily in a broadly diversified portfolio of common stocks.
- (b) The money market variable annuity invests in high-quality debt securities and seeks to maximize current income consistent with liquidity and preservation of capital.
- (c) The social choice variable annuity seeks a favorable long-term rate of return that reflects the investment performance of the financial markets while giving special consideration to certain social criteria.
- (d) The bond market variable annuity seeks a favorable long-term rate of return, primarily through high current income debt securities consistent with preserving capital.
- (e) The global equity variable annuity seeks a favorable long-term rate of return through capital appreciation and income from a broadly diversified portfolio that consists primarily of foreign and domestic common stocks.
- (f) The growth variable annuity seeks a favorable long-term rate of return, mainly through capital appreciation, primarily from a diversified portfolio of common stocks that present opportunity for exceptional growth.
- (g) The equity variable annuity seeks a favorable long-term rate of return from a diversified portfolio selected to track the overall market for common stocks publicly traded in the U.S., as represented by a broad stock market index.
- (h) The inflation variable annuity seeks a long-term rate of return that outpaces inflation, primarily through the investment in inflation-indexed bonds and fixed-income securities whose returns are designed to track a specified inflation index over the life of the bond.

The guaranteed investment contracts are with Teachers Insurance and Annuity Association of America (“the contract issuer”). Participants individually contract with TIAA to establish an account within the TIAA Traditional Annuity. The TIAA Traditional Annuity is offered through group retirement annuities (“GRA”) as determined by the contract between TIAA and the participant. GRA contracts are non-benefit-responsive due to certain illiquidity features discussed below and are valued at fair value measured using a discounted cash flow methodology.

Participant accumulations are available for pre-retirement withdrawal in 10 annual installments upon separation of service under a GRA contract. Lump-sum cash withdrawals are available only within 120 days after termination of employment and are subject to a 2.5% surrender charge. The minimum crediting interest rates are contractually guaranteed to be not less than 3 percent for the GRA.

(4) Tax Status

The IRS has determined and informed D-H by a letter dated September 18, 2017 that the Plan qualifies under Section 401(a) IRC and is, therefore, not subject to tax under the present income tax law. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(5) Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, and interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company and TIAA and CREF, the custodians of the Plan.

(6) Plan Termination

D-HH intends to continue the 401(a) Plan indefinitely; however, the 401(a) Plan is voluntary on the part of D-HH, and D-HH reserves the right to modify or terminate the 401(a) Plan at any time. In the event of Plan termination, participants will become 100% vested in their account balances.

(7) Related-Party and Party In Interest Transactions

Section 3(14) of ERISA defines a party in interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, loans to participants and the management of investments held by the custodians are considered party in interest transactions.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of the investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(9) Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.
