### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of OVS 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of OVS 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### Opinion

## 1. Plan Description

The following description of OVS 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan initially effective January 1, 2000 and restated January 1, 2023, covering substantially all employees of Wilson Orchard and Vineyard Supply, LLC (OVS) (the Employer), as well as employees of Oregon Vineyard Supply and Results Partners (Companies acquired by the Employer). Employees are eligible for elective deferrals and non-elective Employer contributions after completing six months of service in which they complete 500 hours of service and attainment of at least 18 years of age. The Plan Sponsor acquired Clearwater Irrigation Supply, LLC during the year ended December 31, 2022. Employees hired by Clearwater Irrigation Supply, LLC were entered into the plan based on their prior service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan Administrator oversees the governance of the Plan.

### Contributions

*Participant contributions* – Each year, participants may contribute compensation up to the limits provided by the Internal Revenue Code (IRC). Individuals who attain age 50 by the end of the Plan year are eligible to make additional “catch-up” contributions. Participants may elect their deferrals be treated as pre-tax or after-tax (Roth), which are accounted for separately. Participants may also contribute amounts representing rollover distributions from other qualified retirement plans. All participant contributions shall be fully vested at all times.

The Employer has implemented an automatic enrollment policy. Participants becoming eligible are automatically enrolled to contribute 4 percent of their eligible compensation. Participants have the option to elect out of the automatic enrollment prior to the first contribution. The Plan has no clause for automatic escalation.

*Employer match contributions* – The Employer may make a discretionary matching contribution or nonelective contribution. The Employer matched 80 percent of participant contributions, up to a maximum of \$8,000 for the years ended December 31, 2024 and 2023. Total Employer matching contributions were \$658,012 and \$626,086 for the years ended December 31, 2024 and 2023, respectively. There was no nonelective contribution for the years ended December 31, 2024 and 2023.

Contributions are subject to regulatory limits.

### Participants' Accounts

Each participant's account is credited with the participant's contribution and allocations of the Employer's contribution, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**1. Plan Description, continued**

**Vesting**

Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Employer's discretionary contribution portion of their accounts are based on years of service, participants are 50 percent vested after one year, and 100 percent vested after two years. Prior to January 1, 2023, participants were vested in the Employer's discretionary contribution portion of their accounts based on years of service on a six-year graded schedule. Participants were 20 percent vested after two years, 40 percent vested after three years, 60 percent vested after four years, 80 percent vested after five years, and 100 percent vested after six years of service. Employees hired from Oregon Vineyard Supply and Results Partners before January 1, 2020 are 100 percent vested in all contribution types.

**Forfeited Accounts**

Amounts that are not fully vested when participants terminate from the Plan are forfeited. These amounts are used to pay Plan administrative expenses or offset future Employer contributions. There were \$6,253 and \$-0- of forfeitures used to pay plan expenses for the years ended December 31, 2024 and 2023, respectively. There were \$18,004 and \$6,986 of unused forfeitures at December 31, 2024 and 2023, respectively.

**Payment of Benefits**

Upon retirement, disability, death, or termination of employment, a participant may elect to receive the vested value of their account in a lump-sum payment. Participant's age 59½ or older may take in-service distributions of all or part of their vested account balance at any time. Hardship distributions are not permitted.

**Notes Receivable from Participants**

The Plan allows participants to borrow from their accounts at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of 5 years, unless the loan is used to purchase a principal residence, in which case the loan must be repaid within a reasonable period of time at the discretion of the plan administrator when the loan is made. The loans bear interest at a commercially reasonable rate of interest established by the Plan Administrator. A participant may only have a maximum of two loans outstanding at any one time.

## 2. Summary of Significant Accounting Policies

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

### **Contributions**

Participant and employer contributions are recorded in the year in which participant contributions are withheld and underlying compensation paid.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Administrative Expenses**

Administrative expenses of the Plan are paid from Plan assets or from the balance of available forfeitures. Administrative expenses may also be paid by the Employer and are therefore excluded from these financial statements. Investment related expenses are included in net change in fair value of investments and as a component of investment income. Fees for the administration of notes receivable from participants and for the benefits paid to participants are included in administrative expenses and charged directly to the participants' accounts.

**Recent Accounting Standard Adopted**

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments – Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments, and all related amendments* (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are participant and employer contributions receivable.

The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

**3. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**3. Fair Value Measurements, continued**

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

*Registered investment companies:* Quoted market prices are used to value each fund based on the net asset value (NAV) of shares held by the Plan at year end. All mutual funds held by the Plan are open-end mutual funds held within a group annuity contract that are registered with the SEC and are deemed to be actively traded.

**4. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants would become 100 percent vested in their Employer contributions.

**5. Tax Status**

The Plan is a non-standardized pre-approved defined contribution plan. Associated Pension Consultants, the sponsor of the prototype plan, has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 that the basic Plan document satisfies IRC Section 401. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

**5. Tax Status, continued**

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**6. Information Certified by the Plan Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company, acting as the custodian of the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedules is complete and accurate as of and for the years ended December 31:

**7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**8. Related Party Transactions**

The Plan has investments which are shares of registered investment companies managed by John Hancock Life Insurance Company, the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Total fees paid by the Plan to John Hancock Life Insurance Company for the years ended December 31, 2024 and 2023 were \$6,711 and \$6,351, respectively. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**9. Non-Exempt Transactions**

During the year ended December 31, 2023, participant contributions totaling \$49,805, were not remitted to the Plan within the appropriate time period by the Employer. During the years ended December 31, 2022 and 2021, participant contributions totaling \$1,220 and \$10,709, respectively, were not remitted to the Plan within the appropriate time period by the Employer. These transactions constitute prohibited transactions as defined by ERISA. During the year ended December 31, 2024, the Employer corrected all of the non-exempt transactions by calculating lost earnings and interest and has implemented procedures to ensure that all future remittances are made within the prescribed time period. There were no non-exempt transactions during the year ended December 31, 2024.

**10. Subsequent Events**

Management evaluates events and transactions that occur after the statement of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.
