**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Consolidated Machine & Tool Holdings LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a contributory, defined contribution plan covering substantially all employees of Consolidated Machine & Tool Holdings LLC; Murphy Machine Products Inc; Mill Creek Machining Inc; Waiteco Machine LLC; Astro-Tek Industries LLC; Delva Tool and Machine Corporation; and RLS Machining Inc (collectively referred to as the "Company"), who have at least six months of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was established to provide the Company's employees with a savings plan which provides for periodic employee contributions matched in whole or in part by the employer in accordance with the provisions of the Plan.

**Contributions** - A participant may contribute to the maximum that is allowed by law of compensation, as defined, as an authorized payroll deduction. The Plan also allows participants to designate a portion or all of their deferral contribution as a Roth deferral contribution. Participants who have attained age 50 are eligible to make "catch up contributions" before the end of the plan year. The Plan also includes an automatic enrollment provision whereby when participants become eligible 3% of their compensation will be deferred unless otherwise elected by the participant. The Company contributes a safe harbor match in an amount equal to the sum of 100% of the amount of the participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the amount of the participant's elective deferrals that exceed 3% of the Participant's compensation but do not exceed 5% of the participant's compensation. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make matching contributions equal to a discretionary percentage, to be determined by the Company, of the participant's salary reductions. In addition, the Company may, at its discretion, make a profit-sharing contribution to the Plan. The Company elected to make no discretionary match or profit-sharing contribution for the year ended December 31, 2024. Contributions from Plan participants and the matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Participant accounts** - Each participant's account is credited with the participant's contribution and Company matching contributions as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account.

**Notes receivable from participants** - Employees who have participated in the Plan may borrow against the vested portion of their account balance. The minimum amount of any loan is \$1,000, and the loan cannot exceed 50% of the vested portion of the participant's account balance or \$50,000, whichever is less. One residence related loan and one other loan per participant may be outstanding at any time. Payments of principal and interest are made weekly through payroll deduction. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 10.50% which are commensurate with local prevailing rates as determined by the Plan administrator.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Vesting** - Participants are immediately vested in their contributions and the employer's safe harbor match plus actual earnings thereon. Vesting in the Company's discretionary matching and profit-sharing contribution portions of their accounts plus actual earnings thereon are based on years of continuous service. A participant is 100% vested after five years of credited service.

**Payment of benefits** - On termination of service due to death, disability or retirement, a participant, or their beneficiary, may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

**Forfeitures** - Amounts that are forfeited due to a participant's termination of employment prior to vesting in company contributions made on the participant's behalf are used to reduce the required company contribution in subsequent periods or to pay plan expenses. The balance in the forfeiture account totaled \$42,559 and \$3,334 as of December 31, 2024 and 2023, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of accounting** - The financial statements of the Plan are prepared using the accrual method of accounting.

**Investment valuation and income recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Payment of benefits** - Benefits are recorded when paid.

**Plan fees** - The Company paid substantially all of the Plan fees in the current year. These expenses are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid monthly principal balance. Interest income is recorded monthly. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**NOTE 3 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Plan participants are 100% vested in their accounts at all times including in the event of plan termination.

**NOTE 4 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

There are no reconciling differences between net assets available for benefits on the financial statements and the Form 5500 at December 31, 2024 and 2023.

There are no reconciling differences in benefits paid between the financial statement and the Form 5500. Amounts allocated to withdrawing participants are recorded in the Form 5500 for benefits claims that have been processed and approved for payment prior to December 31 but not yet paid as of that date. No approved benefit claims existed at December 31, 2024, which were not paid.

**NOTE 5 TAX STATUS**

The Company has adopted the Plan based on a volume submitter plan document sponsored by Empower Retirement LLC. Empower Retirement LLC has received an opinion letter from the Internal Revenue Service (“IRS”) dated November 14, 2022, that states that the form of the volume submitter plan is acceptable under Section 401 of the Internal Revenue Code (“IRC”). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant’s account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 7 INFORMATION PREPARED AND CERTIFIED BY TRUSTEE**

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Empower Trust Company, the trustee of the Plan, at December 31, 2024 and 2023, as complete and accurate, except for comparing such information certified by the trustee to information included in the Plan’s financial statements and supplemental schedule.

For the year ended December 31, 2024, the trustee certified to the completeness and accuracy of the Plan’s net appreciation in the fair value of investments of \$905,844 and interest and dividends related to the aforementioned Plan assets of \$259,238.

**NOTE 8 RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

Empower Trust Company performs services for, sells products to, manages, and maintains certain investments of the Plan for which fees are charged to the Plan. Both the Plan Sponsor and the Plan can pay these fees. Such transactions, while considered party in interest transactions under ERISA, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party in interest transactions under ERISA. Administrative fees paid by the Plan Sponsor were \$80,363 for the year ended December 31, 2024.

Empower Trust Company provides certain administrative services to the Plan pursuant to a Master Plan Service Agreement (“MSA”) between the Plan and Empower Trust Company. Empower Trust Company receives revenue from mutual fund service providers for services Empower Trust Company provides to the funds. This revenue is used to offset certain amounts owed to Empower Trust Company for its administrative services to the Plan.

If the revenue received by Empower Trust Company from such mutual fund service providers exceeds the amount owed under the MSA, Empower Trust Company remits the excess to the Plan’s trust. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During the year ended December 31, 2024, there were no excess amounts. The Plan or Plan Sponsor may make a payment to Empower Trust Company for administrative expenses not covered by revenue sharing.

**NOTE 9 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2** Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Mutual funds:*** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

***Collective trust funds:*** Valued based on the share prices/net asset values ("NAV") reported on the plan summary reports for collective trust funds which are obtained directly from the fund house or other investment provider.

***Fixed annuity:*** Valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 10 INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan entered into a benefit responsive investment contract with Empower Annuity Insurance Company of America (“Empower”) totaling \$55,450 and \$14,375 for the years ended December 31, 2024 and 2023, respectively. Empower maintains the contributions in a general account. Stability of principal is the primary objective of this investment option. The fixed account guarantees a minimum rate of interest for the life of the annuity contract but may credit a higher interest rate from time to time. Interest is credited to the principal and the investment increases through compound interest to create a book value amount to the participant. The account is charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The contract is included in the financial statements at contract value which approximates fair value at all times during the life of the contract. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may transfer their account balance to any other investment option offered under the plan at any time with no restrictions or penalties.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 11 SUBSEQUENT EVENTS**

The Plan evaluated all subsequent events through October 10, 2025, the date the financial statements were issued.

On September 1, 2025, the Plan name was amended to Delva Tool & Machine 401(k) Plan. This change had no impact on the Plan's operations, provisions, or participants' account balances.
