## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Audit Committee  
R Bank Texas 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of R Bank Texas 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the R Bank Texas 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## **Responsibilities of Management for the Financial Statements**

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.



We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedules Required by ERISA**

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the R Bank Texas 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**GENERAL**

The Plan is a defined contribution plan adopted on July 29, 2011 covering all employees of R Bank Texas (the “Company”) who have satisfied eligibility requirements. Eligible employees are permitted to make tax-deferred contributions and after-tax (Roth) contributions under Section 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Securities Act of 1974 (ERISA). The Plan Administrator and the Company's Audit Committee oversee governance of the Plan, determine the appropriateness of the Plan's investment offerings and monitor investment performance. The Plan was restated effective September 13, 2021.

**ELIGIBILITY**

Employees become eligible for participation at the age of twenty-one and upon completion of three months of service. Employees of the Company are eligible to participate in the Plan as soon as administratively possible following the completion of eligibility requirements. Eligibility provisions apply to participant and Company contributions.

**CONTRIBUTIONS**

Participant contributions are made on a voluntary basis and directly withheld from the participant's eligible compensation, as defined in the Plan agreement. The Plan allows participants to contribute a minimum of 1% up to 80% of eligible compensation subject to certain maximum limitations imposed by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, subject to the maximum limitation imposed by the IRC. Rollover contributions from qualified plans are allowed.

Under the safe harbor matching contribution provision of the Plan, employee contributions are matched by the employer at a rate of 100 percent of the first 3 percent of eligible participant compensation and 50 percent of the next 2 percent. For the year ended December 31, 2024, the Company made safe harbor matching contributions totaling \$325,748. No other Company contributions are allowed, as defined by the Plan agreement.

**PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contributions and safe harbor Company contributions. Allocations of plan earnings and administrative expenses are based on participant account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**INVESTMENT OPTIONS**

Upon enrollment in the Plan, a participant may direct employee and employer contributions to any options provided by Mid Atlantic Trust Company. Investment options include money market funds and various mutual funds. The Plan does not guarantee any rates of return or investment results.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their participant accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The notes are secured by the balance in the participant's account and bear interest at one percent above the USA Today prime rate posted at the time of loan funding. Participants may only have two loans outstanding at any point in time and they will be charged \$100 per loan annually as a annual loan maintenance fee. Principal and interest is paid ratably through payroll deductions. Loans may be renegotiated in an effort to keep a loan current in the allowable repayment period.

**NOTE 1 - DESCRIPTION OF PLAN - CONTINUED**

**VESTING**

Participants are immediately vested in their elective deferral contributions, rollover contributions and Company safe harbor contributions, plus actual earnings thereon. Therefore, there were no forfeited non-vested accounts at December 31, 2024 and 2023.

**PAYMENT OF BENEFITS**

Participants are entitled to the benefits that can be provided from their individual account balances upon death, disability, termination of service or normal retirement, as defined by the Plan agreement. Hardship withdrawals are permitted for employee contributions, plus actual earnings thereon. In-service withdrawals up to the vested balances for the participants are permitted, as described within applicable sections of the IRC. Distributions can be made in the form of lump-sum payments or partial lump sum payments as cash distributions or direct rollover to another qualified plan.

The Plan provides for an automatic rollover into an individual retirement account with a vested balance of \$5,000 or less if the participant does not elect to have such distributions paid directly into another eligible retirement plan or account, or to receive the distribution directly.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**BASIS OF ACCOUNTING**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**USE OF ESTIMATES**

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**INVESTMENT VALUATION AND INCOME RECOGNITION**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**CONTRIBUTIONS**

Contributions from Plan participants and employer contributions are recorded in the year in which the contributions are withheld from compensation.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Participant loans are classified as notes receivable and are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant fails to comply with the terms of a loan and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment, a deemed distribution, or a combination of the two.

**PAYMENT OF BENEFITS**

Benefits are recorded when paid.

**ADMINISTRATIVE EXPENSES**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**SUBSEQUENT EVENTS**

Plan Management has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation method include
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the assets or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market funds:* Valued at the per unit price as quoted by the financial institution.

*Mutual funds:* Valued at the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor (DOL) regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. As such, Mid Atlantic Trust Company, the trustee, is considered a party-in-interest. The Plan holds certain money market funds issued, held or managed by the trustee. Therefore, these investments qualify as party-in-interest transactions. Fees paid to the trustee and other service providers are party-in-interest transactions and are included in administrative expenses or net appreciation of fair value of investments in the statement of changes in net assets available for benefits. All such party-in-interest transactions are covered by an exemption from the "prohibited transactions" provisions of ERISA and the IRC.

**NOTE 7 - TAX STATUS**

The Plan has adopted a non-standardized pre-approved profit-sharing plan with the IRC Section 401(k) Cash or Deferred Arrangement (CODA) which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the form of the plan is acceptable under Section 401 of the IRC, not subject to tax under present income tax law. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and tax counsel believe the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investments in general are exposed to various risks such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 - DELINQUENT PARTICIPANT CONTRIBUTIONS**

During the Plan year ending December 31, 2024, participant contributions and loan repayments totaling \$79,682 were not remitted to the Plan on a timely basis. The deposit of lost earnings will be made as soon as administratively possible within the DOL and IRS guidelines.
