Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 30, 2024 and December 31, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Maryland Food Bank, Inc. 403(b) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter—Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the board of directors of Maryland Food Bank, Inc. approved a plan of liquidation on April 4, 2024, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Maryland Food Bank, Inc. 403(b) Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Maryland Food Bank, Inc. 403(b) Retirement Plan's internal control. Note 1: Description of Plan

The following description of Maryland Food Bank, Inc. 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Plan Termination: Effective November 1, 2024, Maryland Food Bank, Inc. 403(b) Retirement Plan was terminated. The Plan sponsor, The Maryland Food Bank, Inc., made this decision in order to eliminate costs related to the Plan administration. As of October 1, 2024, a new plan was created, Maryland Food Bank, Inc. 401(k) Retirement Plan, and all current employees had the option to rollover their current balances into the new Plan. Participant balances of current and non-current employees held in investment funds were liquidated in December 2024. All other participant balances were held in annuity contracts and deemed distributed as of December 30, 2024 whereby The Lincoln National Life Insurance Company will continue to administer the recordkeeping of those investments as they are now individually-owned annuity contracts. Participants had the option to leave the funds in the existing accounts, rollover the assets to an IRA or the new retirement plan, or take a distribution in the form of a lump sum or annuity.

General: The Plan is a defined contribution retirement plan established by The Maryland Food Bank, Inc. (the Organization) under a plan sponsored by The Lincoln National Life Insurance Company (Lincoln), which was adopted effective August 1, 1996. The Plan generally covers all employees of the Organization. The plan qualifies under Section 403(b) of the Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions: The Plan generally allows eligible employees to contribute a percentage of their compensation, not to exceed the maximum limitation on annual additions, to a participant's account under applicable provisions of the Internal Revenue Code. Participant contributions are made through payroll deductions. Each participant designates the percentage of his/her contributions which are to be invested in one or more of the available fund options. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants are also allowed to contribute distributions received from other qualified retirement plans.

Employer Contributions: The Organization has a safe-harbor provision where the Organization is required to contribute 3% of each eligible employee's compensation, as defined in the plan document. The Organization may also make matching contributions at a specified percentage of the eligible employees' compensation, but no more than 5%. To receive a match, an eligible employee must be 18 years of age and have completed one year of service, as defined in the agreement.

Participants Accounts: Each participant's account is credited with the participant's contributions, allocations of the Organization's contributions and Plan earnings and losses and administrative fees. Employer matching contributions are allocated to participants based on the participants' contributions during the year. Plan earnings, losses and any administrative expenses are allocated based on the account balances of the participants. The benefit to which a participant is entitled is that which can be provided from the participant's vested account. All Plan assets as of December 30, 2024 and December 31, 2023 have been allocated to participant accounts.

Vesting: Participants are immediately vested in their contributions and any employer contributions plus investment earnings thereon.

Note 1: Description of Plan (Continued)

Forfeitures: As all contributions are 100% vested, there are no forfeitures in the plan.

Payment of Benefits: Upon termination of service due to death, disability, retirement, or termination, a participant may elect to receive either a lump sum, a partial payment, annual installments over a set number of years, or purchase an annuity contract equal to the value of the participant's vested interest. Participants are generally required to take minimum distributions upon reaching the age of 73. In-service withdrawals are permitted for participants who have attained 59½ years of age. Hardship withdrawals by a participant are permitted if specified criteria are met.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. The loans bear interest at prevailing rates for similar loans as determined by the plan administrator and carried at their outstanding principal balance. Repayments are generally made through payroll deductions. A participant may have only one loan outstanding at any time.

Note 2: Summary of Significant Accounting Policies

Following is a description of the significant accounting and reporting policies of the Plan:

Basis of Presentation: The financial statements of the Plan as of December 31, 2023 are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

In accordance with accounting principles generally accepted in the United States of America, the financial statements of the Plan as of and for the year ended December 30, 2024 are prepared under the liquidation basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan trustees are responsible for oversight of the Plan, determine the appropriateness of the Plan's investment offerings and monitor investment performance. Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Note 2: Summary of Significant Accounting Policies (Continued)

Contributions: Contributions from participants are recorded in the period the employer withholds payroll deductions from Plan participants. Matching contributions and safe harbor contributions are recorded monthly and any other discretionary contributions from the employer are recorded in the period the board of directors can reasonably estimate and approve the amount determined and collectability is reasonably assured.

Payment of Benefits: Benefit payments are recorded when paid to participants.

Subsequent Events: In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 10, 2025, the date the financial statements were available to be issued. During the period from December 31, 2024 through October 10, 2025, the Plan, did not have any material recognizable subsequent events.

Note 3: Fair Value Measurements

Generally Accepted Accounting Principles (GAAP) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. As of December 30, 2024 and December 31, 2023, the Plan did not own any investments that are required to be measured under the fair value hierarchy.

Note 3: Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for measuring plan investments:

Investment in Pooled Separate Accounts: Investments in pooled separate accounts are valued at fair value based on net asset value, which is derived from the fair value of the underlying mutual funds held in a subaccount minus the fund's liabilities, which are the contract charges imposed by Lincoln, divided by the number of participation units outstanding. The participants' accounts are invested in group variable annuity products. Each investment option is invested exclusively in a sub-account of Lincoln's separate accounts, which in turn invests in an underlying mutual fund or other investment contracts. While the assets of the separate accounts purchase shares of the underlying investments, neither the Plan nor participants own shares of the mutual funds or other investment contracts, instead participants own "accumulation units" in the variable investment options.

Investment in Fully Benefit-Responsive Contracts: The Plan has investments in contracts that are fully benefit-responsive and reported at contract value (see Note 5). Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the methodologies used at December 30, 2024 and December 31, 2023.

In determining the appropriate levels, the Plan performs a detailed analysis of the assets and liabilities that are to be reported at fair value.

Investments Measured Using the Net Asset Value per Share Practical Expedient: The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as December 31, 2023. As of December 30, 2024 the plan has liquidated or distributed all plan assets.

Note 4: Information Certified by the Plan's Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, the plan administrator has instructed the Plan's independent auditors not to perform any auditing procedures with respect to information certified as complete and accurate by The Lincoln National Life Insurance Company (Lincoln), the custodian of the Plan, except to compare such information to information included in the Plan's financial statements and supplemental schedule.

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 30, 2024 and December 31, 2023, and net appreciation in fair value of investments, interest and interest income on notes receivable from participants for the years ended December 30, 2024 and December 31, 2023, was derived from information certified as complete and accurate by the Plan's custodian.

Note 5: Investment Contracts with Insurance Company

The Plan has investments in fully benefit-responsive contracts with Lincoln. Lincoln maintains the contributions in a fixed account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The account meets all of the standards currently required by the Financial Accounting Standards Board (FASB) in order to be considered fully benefit-responsive, and therefore, is reported at contract value. The account has no stated maturity dates and the interest rate is reset monthly. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events may limit the Plan's ability to transact at contract value with Lincoln. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption under the Employee Retirement Income Security Act of 1974. The plan administrator does not believe that the possibility of any events that would limit the Plan's ability to transact at contract value with plan participants to be probable.

The investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date. As of December 30, 2024 these contracts were considered deemed distributions by the plan. The Lincoln National Life Insurance Company will continue to administer the recordkeeping of those investments as they are now individually-owned annuity contracts.

Note 6: Notes Receivable from Participants

As of December 30, 2024 there were no outstanding notes as they are considered deemed distributions as part of the plan termination. As of December 31, 2023, 30 participants were indebted to the Plan in the total amount of \$122,948, as a result of loans made to them by the Plan. The loans were evidenced by promissory notes bearing interest ranging from 4.50% to 7.00% per annum and were payable in installments, the latest of which was due in November 2035. The notes were fully secured by the participants' vested account balances.

Note 7: Income Tax Status

The Organization has adopted a standardized form of a prototype plan sponsored by The Lincoln National Life Insurance Company, the custodian of the Plan. The Plan is intended to comply with the applicable requirements of Section 403(b) of the Internal Revenue Code (IRC) of 1986, as amended. A tax determination letter program is not yet available for IRC Section 403(b) plans through the Internal Revenue Service (IRS). The plan administrator believes that the Plan is currently designed and is being operated in compliance with applicable requirements of the IRC. The Plan's federal information returns are subject to examination by the IRS generally for a period of three years after the returns are filed.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator does not believe that the Plan has any uncertain tax positions. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

Note 8: Parties-In-Interest

Certain officers and employees of the Plan sponsor are administrators of the plan acting as fiduciaries and are also participants in the Plan. The Plan offers participants an individual variable annuity contract, which is a product of Lincoln, the custodian of the Plan. In addition, the underlying investment options available to the participants under this contract are also products of Lincoln, therefore these transactions qualify as party-in-interest transactions. In addition, Lincoln provides various recordkeeping services to the Plan for which it is compensated. For the years ended December 30, 2024 and December 31, 2023, the Plan paid administrative fees to Lincoln totaling \$104,479 and \$277, respectively.

Note 9: Administrative Expenses

The Plan's expenses are paid by either the Plan or the Organization, as provided by the Plan document. Expenses paid directly by the Organization are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments.

Note 10: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

Note 11: Reconciliation of Financial Statements to Form 5500
