NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Integrated Dermatology, LLC 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Integrated Dermatology, LLC (the "Company" or "Plan Sponsor") in January 2010. Employees of the Company and other participating employers (which include the Company's parent and certain related entities under common ownership) are eligible to participate in the Plan provided they are at least 18 years of age and have at least three months of service with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan's management determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan's trustee is Reliance Trust Company ("Trustee") and recordkeeper is Automatic Data Processing, Inc. ("ADP").

Contributions

Participants may contribute up to 90% of their pretax annual compensation, as defined in the Plan document, without exceeding limitations prescribed by the Internal Revenue Code (the "Code"). Effective December 1, 2017, the Plan was amended to also allow participants to make Roth 401(k) deferrals to the Plan, subject to the same limitations and eligibility provisions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans ("rollovers"). Additionally, participants age 50 or older who are making contributions to the Plan, can make catch-up contributions as defined in the Plan document and subject to certain limitations under the Code. Participants direct the investment of all contributions into various investment options offered by the Plan.

The Company may make discretionary non-elective contributions to the Plan on behalf of eligible participants. Discretionary non-elective contributions, if any, are allocated to each eligible participant in proportion to the participant's eligible compensation, as defined in the Plan document, as compared to the total eligible compensation of all participants sharing in the contribution. Discretionary non-elective contributions made by the Company are invested in accordance with each participant's investment elections and are subject to limitations prescribed by the Code. The Company did not make any discretionary non elective contributions to the Plan for the year ended December 31, 2024.

Investment Options

The Plan offers various mutual funds and collective trust funds as investment options for participants. Participants may change their investment options at their discretion.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of: (a) the Company's discretionary non-elective contributions, if any; and (b) Plan earnings or losses and is charged with certain of the Plan's administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their own contributions plus actual earnings thereon. Participants also become fully vested in their account in the event of death, disability, or upon attaining the Plan's normal retirement age, as defined in the Plan document. Vesting in the Company's discretionary non-elective contributions, plus actual earnings thereon, is based upon years of service with the Company. Participants vest in Company contributions based upon the following schedule:

Forfeitures

Forfeitures of terminated non-vested account balances may be used to reduce the Company's contributions, if any, or to pay the Plan's administrative expenses. There were no forfeitures applied or used during 2024 and no unapplied forfeitures at December 31, 2024 and 2023.

Notes Receivable from Participants

Participants may borrow a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at the prime rate as published in the Wall Street Journal on the 14th day of each month, plus 2%. Principal and interest are paid ratably through payroll deductions. All notes have a definite repayment period not to exceed five years, unless used for the purchase of a primary residence in which case the repayment period may extend up to 30 years. Participants may not have more than one note outstanding at any time. The interest rate charged on all participants' loans outstanding ranged from 5.25% to 10.5% as of December 31, 2024 and from 5.25% to 10.5% as of December 31, 2023.

Benefit Payments

Upon death, disability, or retirement, participants' accounts become 100% vested and participants or their beneficiaries may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account if the benefit payable does not exceed \$5,000. If the benefit payable exceeds \$5,000, the participant or their beneficiaries may elect to receive a single lump-sum payment, a partial withdrawal or an annuity. If a participant meets certain criteria, benefits may also be received as an in-service withdrawal.

Upon termination of service, benefits relating to employee contributions and vested Company contributions are distributed and subject to the applicable taxes and penalties or rolled over if the total investment amount is \$5,000 or less. If the investment amount is greater than \$5,000, a participant may elect to have the funds remain in the Plan, until age 73. Upon termination of service, an automatic lump-sum distribution will be made for vested amounts less than \$1,000 and unless otherwise directed by the participant, automatic individual retirement account rollovers will be made for vested amounts between \$1,000 and \$5,000. If the investment amount is greater than \$5,000, a distribution of the participant's account may not be made without the participants' consent, until age 73.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net Appreciation in Fair Value of Investments

Net realized and unrealized appreciation of investments is recorded in the accompanying statement of changes in net assets available for benefits as net appreciation in fair value of investments and includes gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make note repayments and the Plan Administrator deems the note to be in default, the remaining note balance is reduced, and a benefit payment is recorded.

Risks and Uncertainties

The Plan provides for investment options in a variety of investment securities. Investment securities in general are exposed to various risks, such as interest rate, market volatility, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Benefit Payments

Benefits are recorded when paid.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. As of December 31, 2024 and 2023, excess contributions amounted to \$97,267 and \$65,065, respectively.

Administrative Expenses

The Plan pays the account administrative service fee from income earned by the Plan. The Company pays the legal and accounting fees, and other expenses on the behalf of the Plan.

NOTE 3 - CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend and interest income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Reliance Trust Company.

NOTE 4 - FAIR VALUE OF MEASUREMENTS

The Financial Accounting Standards Board ("FASB") issued Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds - Valued at the net asset value ("NAV") of shares held by the Plan at year end as traded in active markets. The mutual funds provide for daily redemptions by the Plan at reported NAVs with no advance notice requirement.

Collective trust fund - The Plan holds an interest in a collective investment trust, valued at NAV of units held. The NAV is used as a practical expedient to estimate fair value. There are no participant redemption restrictions or unfunded commitments. Redemption can occur daily.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in all Company contributions.

NOTE 6 - TAX STATUS

The IRS issued an opinion letter dated October 6, 2020, indicating that the prototype plan document adopted by the Plan, as then designed was in compliance with applicable requirements of the Code. Although the Plan has been amended from the original prototype plan document, Plan management believes that the Plan was operated in accordance with the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of both December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that required recognition of a liability (or asset) or disclosure in the financial statements. The Plan will recognize interest and penalties accrued on any unrecognized tax benefits as a component of income tax expense. As of December 31, 2024 and 2023, the Plan has not accrued interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Transactions with the Trustee and ADP qualify as party-in-interest transactions. Certain other investment-related fees incurred by the Plan are netted against the appreciation in fair value of investments as they are paid through revenue sharing, rather than as a direct payment. All other Plan related fees are paid for by the Company. Notes receivable from participants, are also considered to be party-in-interest transactions.

NOTE 9 - SUBSEQUENT EVENTS
