NOTE A – DESCRIPTION OF PLAN

The following description of The Embrace Families Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan, organized as a profit-sharing plan under Section 401(k) of the Internal Revenue Code (IRC) covering substantially all employees of Embrace Families Community Based Care, Inc., Embrace Families Solutions, Inc., Embrace Families Foundation, Inc., and Embrace Families, Inc. (collectively, the Employer, the Company or the Plan Sponsor) who meet certain eligibility requirements. Employees become eligible to participate in the Plan on the first monthly date coinciding with or immediately following the completion of one month of service. The Board of Directors of the Plan Sponsor is responsible for oversight of the Plan. The Plan’s trustee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan Sponsor’s Finance and Audit Committee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may make a combination of pre-tax or Roth contributions up to 100% of annual compensation, as defined in the Plan. Effective December 24, 2021, the Plan provides for automatic enrollment of all newly eligible participants and deferral of 4% of eligible wages unless the participant specifically elects to defer a different percentage or not contribute at all. Participants who have reached age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

The Company makes safe harbor matching contributions equal to 100% of each participant’s contribution up to a maximum of 4% of compensation, as defined in the Plan agreement. The Company may make discretionary profit sharing contributions to the Plan in addition to any matching contributions. The monies will be allocated to the Plan participants in the same proportion that such participant’s compensation for the plan year bears to the total compensation of all participants for the plan year. A discretionary profit sharing contribution was not made during the period ended October 7, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Investment options

Upon enrollment in the Plan, a participant may direct all contributions to selected investments as more fully described in the Plan’s literature. Participants may change their investment options daily.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and the Plan Sponsor’s matching contribution, as well as allocations of any profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE A – DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are vested immediately in their contributions and employer safe harbor matching contributions plus actual earnings thereon. Participants are vested in the employer discretionary profit sharing contributions plus actual earnings thereon based on years of continuous service. A participant is 20% vested after two years of service and continues to vest an additional 20% each year. A participant is 100% vested in their employer discretionary profit contributions after six years of service.

Payment of benefits

The Plan permits withdrawals when a participant terminates employment, retires, or becomes disabled or deceased. In-service withdrawals are also permitted for certain financial hardships or when a participant reaches age 59½. Benefits are payable in lump-sum payments with certain exceptions allowed.

Forfeitures

Forfeitures are used to reduce future employer contributions or pay Plan expenses. During 2024, there were no forfeitures used by the Plan. As of October 7, 2024 and December 31, 2023, there were no forfeitures held by the Plan.

Notes Receivable

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of 50% of the participant's vested account balance or \$50,000, reduced by the highest outstanding note balance during the one-year period ending on the day before the note was made. Loan terms range up to five years or over a reasonable period of time for the purchase of a primary residence, as established by the Plan Administrator at the time of the loan. The loans are collateralized by the vested balance in the participant's account and bear a fixed rate of interest based on the prevailing prime rate plus 1%. These rates range from 4.25% to 9.50% on loans outstanding at October 7, 2024, and the loans mature through 2029. Principal and interest are paid ratably through monthly payroll deductions. A participant may have a maximum of two outstanding notes.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates and assumptions.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

The Plan follows the fair value measurement requirements of Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, which defines fair value as the exchange price that would be received for the asset or paid to transfer a liability in an orderly transaction between market participants. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the gains and losses on investments bought and sold during the year as well as the change in the unrealized appreciation or depreciation on those investments during the year.

Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make the scheduled repayments and the Plan Administrator deems the participant to be in default, the participant's note receivable is reduced and a benefit payment is recorded based on the terms of the Plan. No allowance for credit losses has been recorded as of October 7, 2024 and December 31, 2023.

Excess contributions payable

Participant contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction in contributions.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025 the date the financial statements were available to be issued.

NOTE D – FAIR VALUE MEASUREMENTS

FASB ASC 820 provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: The investments are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE D – FAIR VALUE MEASUREMENTS (CONTINUED)

Common collective trust stable value fund: a stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to requires 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

To access the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. The Plan evaluates the significance of the transfer between levels based upon the nature of the investment and the size of the transfer relative to total net assets available for benefits.

NOTE E – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

FMTC is the trustee of the Plan; therefore, transactions with the trustee qualify as party-in-interest transactions. Fees paid by the Plan to the trustee totaled \$34,173 for the period ended October 7, 2024. The Plan Sponsor also paid certain administrative expenses of the Plan.

NOTE F – PLAN TERMINATION

The Plan was terminated on October 7, 2024, after the Company ceased operations earlier in the year. The Plan ceased operations on May 31, 2025 and began the liquidation process and participants became 100% vested in the Organization’s contributions. All Plan assets were distributed or transferred from the Plan as of October 7, 2024 to qualifying institutions or to Plan participants.

NOTE G – TAX STATUS

Effective November 24, 2021, the Plan adopted non-standardized form of a pre-approved plan. The pre-approved plan provider, FMR LLC, received an opinion letter from the IRS dated June 30, 2020, as to the pre-approved plan’s qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan, and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes of risk associated with certain investment securities will occur in the near term, and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.


