### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Jack Resnick & Sons, Inc. 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to *the Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **Note 1. Description of Plan**

The following description of Jack Resnick & Sons, Inc. 401 (k) Saving (Plan) provides only general information. For a more complete description of the Plan's provisions, refer to the agreement governing the Plan (Plan Agreement).

**General**

The Plan is a defined contribution 401(k) plan—per adoption agreement effective November 1, 1987, covering eligible employees of Jack Resnick & Sons, Inc. and other entities related by common ownership (Companies). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Plan was amended to adopt the provisions of the *Coronavirus Aid, Relief, and Economic Security (CARES) Act*, effective as of March 27, 2020. The Plan was amended effective as of July 1, 2022, to include that each employee of the Companies shall be eligible to participate in the plan upon meeting the requirements that they attained 21 years of age and are not included in a unit of employees covered by a collective bargaining agreement. The Plan was further amended and restated, effective as of January 1, 2024, which included an auto-enrollment provision whereby all eligible participants are automatically enrolled in the Plan unless they affirmatively elect to not participate in the Plan and allowed participants to make “Roth” deferral contributions. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation.

**Eligibility**

Each employee of the Companies shall be eligible to participate in the Plan upon meeting all the following requirements:

- Attaining 21 years of age
- Not included in a unit of employees covered by a collective bargaining agreement

**Participant Contributions**

Participants may direct the Companies to deposit up to 100% of their annual eligible compensation directly into their plan accounts on a before-tax basis. The amount deferred in any calendar year may not exceed the limits specified under the Internal Revenue Code Sections 401(k), 404, and 415.

**Employer Contributions**

The Companies have the right to make discretionary contributions based on a percentage of the annual compensation of eligible participants. The employer contribution percentage was 4% for the year ended December 31, 2024.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, the Companies' discretionary contribution and plan earnings. Allocations are based on participant's earnings or account balances, as defined.

Participants can elect from several investment vehicles offered by the Plan to which contributions on their behalf shall be directed. The plan trustee authorized the investments to be held by Principal Financial Group.

**Notes Receivable from Participants**

Participants may obtain loans against the vested value of their accounts. The minimum loan amount is \$1,000. The maximum amount of the loan cannot exceed the lesser of a) \$50,000 or b) 50% of the participant's vested account balance.

The funds required to satisfy a loan request are withdrawn on a pro-rata basis from the participant's account in the various investment funds.

The loans generally must be repaid within five years, except in the case of a loan for acquiring any principal residence, of which is determined by the plan administrator, in accordance with the Plan's loan policy. Interest and principal repayments are credited directly to the borrower's respective account and are repaid by payroll deductions.

In accordance with the Plan Agreement, the loans bear interest equal to the prime interest rate plus 1%, determined at the time the loan is disbursed. For the years ended December 31, 2024 and 2023, the prime rate on the outstanding notes receivable from participants ranged from 4.25% to 9.50%.

***Vesting***

All participants of the Plan are immediately 100% vested in their elective and rollover deferral contributions plus actual earnings thereon. Vesting in employer contributions is based upon the following schedule:

<u>Years of Service</u>	<u>Vesting %</u>
Less than or equal to two years	0%
Over two years but less than or equal to three years	35%
Over three years but less than or equal to four years	70%
Over four years	100%

However, participants will always be 100% vested in nonelective contributions if they are employed on or after their normal retirement age or if they terminate employment on account of death or becoming disabled.

***Payment of Benefits***

The distribution to which a plan participant is entitled is the participant's vested account balance, including net realized and unrealized investment gains and losses. A distribution election may be made upon retirement, death, or termination to be paid in a lump sum or an annuity. Participants may withdraw from their individual accounts pursuant to specific guidelines as set forth in the Plan.

***Administrative Expenses***

A portion of administrative expenses are paid directly by the Employer. To the extent expenses are not paid by the Employer, expenses may be paid out of the assets of the plan in accordance with ERISA guidelines.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (See Note 4 for discussion of fair value measurement). Earnings are based on each account's proportionate share of the respective fund.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Benefits Paid to Participants***

Benefit payments to participants are recorded upon distribution.

***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when incurred. Delinquent loans receivable from participants are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses have been recorded as of December 31, 2024 and 2023.

***Forfeited Accounts***

Under the Plan Agreement, forfeitures of the employer's discretionary contributions are first restored to re-employed individuals that meet the conditions set forth in the Plan Agreement and are then used to pay administrative expenses under the Plan. At December 31, 2024 and 2023, cumulative forfeited nonvested accounts totaled approximately \$170,000 and \$150,000, respectively.

**Note 3. Information Certified by The Plan's Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate.

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the years ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

#### **Note 4. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2** Inputs other than quoted prices included within Level 1 that are observable for the asset or liability either directly or indirectly include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Money market funds*: Money market funds are valued at cost plus accrued interest, which approximates fair value.
- *Mutual funds*: Mutual funds are stated at fair value based on unadjusted quoted prices in an active market for each share held by the Plan.
- *Common collective trust funds*: Common collective trust funds are stated at fair value which is determined by the trustee of the common collective trust based on the underlying assets, which represent net asset value of units held by the trusts. The net asset value is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. The common collective trust funds invest primarily in mutual funds and do not have any unfunded commitments relating to its investment, or any significant restriction or redemptions. Participant-directed redemptions can be made on any business day and do not have a redemption notice period.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **Note 5. Plan Termination**

Although it has not expressed any intention to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contribution.

## **Note 6. Tax Status**

The Company adopted a Prototype Non-Standardized Profit Sharing Plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Code (IRC) on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. The plan administrator believes that the plan amendments and the plan sponsor have operated the Plan in a manner that did not jeopardize its tax-exempt status.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more-likely-than-not would be sustained upon examination by federal and state jurisdictions. The Company concluded that it has no material uncertain tax liabilities to be recognized at December 31, 2024. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 7. Party-in-Interest Transactions**

The Custodian of the Plan manages certain plan investments; therefore, these transactions qualify as party-in-interest transactions. Fees paid to the Custodian by the Plan for administrative services amounted to \$125,863 and \$105,856 for the years ended December 31, 2024 and 2023, respectively.

### **Note 8. Concentrations**

Balances in three investments accounted for approximately 53% of investments as of December 31, 2024. Balances in four investments accounted for approximately 63% of investments as of December 31, 2023.

### **Note 9. Risks and Uncertainties**

The Plan's investments are concentrated in mutual fund accounts and common collective trust funds that invest in marketable equity, debt and fixed income securities. Such securities are subject to various risks that determine the value of the funds. Due to the level of risks associated with certain securities and the level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

### **Note 10. Subsequent Events**

The Plan has evaluated subsequent events through October 10, 2025, the date these financial statements were available for issuance. All subsequent events requiring recognition and disclosures as of December 31, 2024 have been incorporated in these financial statements.
