Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Paumac Tubing LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Paumac Tubing LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Note A—Description of Plan

The following description of the Paumac Tubing LLC (Company) 401(k) Plan provides general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees who have completed three months of service by the next plan entry date and are age 19 or older. The entry date is the first day of any month. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan sponsor oversees governance of the Plan.

Contributions - Each year, participants may contribute on a pretax and or roth basis not less than 1%, and up to 90% of annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various common collective trust funds and registered investment company funds. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set at 4% of eligible compensation. Contributions are automatically invested in a designated balanced fund until changed by the participant. The Company contributes 25% of the employees' contributions, limited to a maximum of 4% of the employee's compensation. Contributions are subject to certain statutory limitations.

Participant Accounts - Each participant's account is credited with the participant's and Employer's contributions and allocations of (a) the Employer's matching contributions and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on the years of continuous service. A participant is 100% vested after five years of credited service.

Payment of Benefits - On termination of service due to death, disability or retirement, a participant may elect or receive either a lump-sum amount equal to the value of the participants' vested interest in his or her account or various installment annuities. An active participant may also elect to seek in service withdrawals as defined in the Plan document.

Loans - The Plan does not allow participants to take out loans.

Forfeited Accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$19,974 and \$8,585 respectively. These accounts will be used to reduce future employer contributions. Also, during December 31, 2024 and 2023, employer contributions were reduced by \$6,171 and \$3,693 from forfeited nonvested accounts, respectively.

Note B - Summary of Significant Accounting Policies

Expenses - Certain expenses of maintaining the Plan are paid by the Employer and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Fees for the administration of benefit payments are included in administrative expenses and charged directly to the participants account.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition - Accounting policies relative to the basis of recording assets conform with the Department of Labor guidelines. Assets are presented at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized gain from investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note B - Summary of Significant Accounting Policies (Continued)

Excess Contributions Payable - Amounts payable to the participants for contributions in excess of amounts allowed by the IRS are recorded as accounts payable, with a corresponding reduction to contributions. There were no excess contributions payable for 2024 and 2023.

However, the November 24, 2017 payroll contributions and employer match were paid twice in January 2018. The plan sponsor was aware of the duplicate payment and is working to correct the overpayment. As of December 31, 2024, the overpayment was still outstanding. The balance of the excess contribution and employer match as of December 31, 2024 and 2023 was \$5,216, respectively.

Payment of Benefits - Benefits are recorded when paid. All benefits were paid as of December 31, 2024.

Note C - Certified Information

Reliance Trust Company holds the Plan's investments and executes all investment transactions as of and for the years ended December 31, 2024 and 2023. The investment balances, and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Reliance Trust Company.

Note D - Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs are not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring use of Level 2 or 3 inputs for the periods presented.

Level 1 Fair Value Measurements - The fair value of the funds held is based on quoted net asset values of the shares as reported by the fund. The funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The funds held by the Plan are considered to be actively traded.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective funds are measured at net asset value. The net asset value as provided by the trustee is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. The use of net asset value is deemed appropriate as the collective funds do not have a finite life, unfunded commitments or significant restrictions on redemptions.

Gains and losses included in changes in net assets available for benefits for the year ended December 31, 2024 is reported in net realized and unrealized gain from investments.

Note E - Income Tax Status

The Internal Revenue Service issued a determination letter dated October 6, 2020, stating that the plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code and that the related trust is, therefore, not subject to tax. The Plan administrator has a copy of this determination letter in their possession.

Note F - Party in Interest Transactions

Certain Plan investments are shares of mutual funds managed by Reliance Trust Company. Reliance Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. ADP retirement services manages the recordkeeping of the Plan and the Plan paid them \$12,825 for the year ended December 31, 2024.

These party-in-interest transaction are exempt from the prohibited transaction rules of ERISA.

Note G - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants would become 100% vested in their employer contributions.

Note H - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note I - Subsequent Events

The date to which events occurring after December 31, 2024, the date of the most recent statement of net assets available for plan benefits, have been evaluated for possible adjustment to or disclosure in the financial statements is September 30, 2025, which is the date on which the financial statements were available to be issued.

Starting January 1, 2025, the terms of the Plan have been updated. If a participant's vested account balance is equal to or less than \$7,000 at the time of termination of employment, the account is automatically distributed as a lump-sum payment. On November 29th, 2024, employees who were terminated with vested balances equal to or less than \$7,000 were notified that they would receive a cash out distribution on February 14th, 2025.

On December 31, 2024 Reliance Trust Company resigned as the plan's trustee. The plan entered a new trust agreement with ADP Retirement Trust Services, LLC which will be the trustee effective January 1, 2025 per the trust agreement amendment, which the plan sponsor did not object to.
