

NOTE 1 – DESCRIPTION OF PLAN

Tifco Industries, Inc. Employees' 401(k) Plan (the Plan) is a qualified retirement plan adopted by TIFCO Industries, Inc. (the Company) on January 1, 1967 to provide employees with the opportunity to save for retirement on a tax-deferred basis. The Plan was amended during 2018 to conform to new tax laws. Subsequently, the Plan was amended and restated effective January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The following description of the Plan provides only general information. Participants should refer to the legal Plan document for a more complete description of the Plan's provisions.

Eligibility: All non-excluded employees of the Company who have completed 6 months of service are eligible to participate in the Plan upon reaching an entry date. The entry date is the first day of the Plan year coinciding with or next following the date the employee satisfies the eligibility requirement.

Contributions: Participants may elect to defer an amount of compensation into the Plan not to exceed a dollar limit that is set by law. Participants who have attained age 50 before the end of a calendar year may elect to defer additional amounts as catch-up contributions. Participants may modify or revoke their election at any time. Participants are also permitted to deposit into the Plan distributions they have received from other plans and certain IRAs as rollover contributions.

The Company may contribute a discretionary percentage of participants' salary deferrals which will be determined each year. For 2024, the Company contributed a matching amount equal to 25% of participant contributions up to 6%.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and losses, and (c) forfeitures of employer contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are immediately vested in their contributions and rollovers plus actual Plan earnings thereon. Vesting in employer contributions and actual Plan earnings thereon is based on vesting years of service. Participants become 100% vested after six years of credited service.

Payment of Benefits: If a participant terminates employment for any reason, including retirement, and the value of their vested benefit does not exceed \$5,000, they will be entitled to a lump-sum distribution within a reasonable time after termination of employment. If the vested benefit exceeds \$5,000, they must elect to receive the benefit in either a single lump-sum payment or installments over a period of not more than their assumed life expectancy.

Distributions from a participant's account before they terminate employment are permitted upon attainment of age 59½ or if the participant incurs a proven financial hardship.

Notes Receivable From Participants: Loans are available to participants on a reasonably equivalent basis. No loan in an amount less than \$1,000 will be made. The maximum loan will be the lesser of \$50,000 reduced by the excess of their highest outstanding balance of loans from the Plan during the prior one-year period or 50% of their vested account balance. All loans are adequately secured and charged a reasonable rate of interest. Generally, the term of the loan may not exceed five years unless used by the participant to purchase a principal residence.

NOTE 1 – DESCRIPTION OF PLAN (Continued)

Forfeitures: The non-vested portion of a terminated participant's account balance remains in the Plan as a forfeiture. Forfeitures may be used for the payment of Plan expenses or to offset employer contributions.

Plan Termination: Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participants' accounts will become 100% vested. The Company will direct the distribution of participants' accounts in a manner permitted by the Plan as soon as practical.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 14, 2025, which is the date the financial statements were available to be issued.

Effective April 1, 2025, the Plan was amended and restated to comply with recent laws and regulations. As part of this restatement: (i) the entry date was updated from the first day of the Plan year coinciding with or next following the date an employee satisfies the eligibility requirement to the first day of the Plan year quarter coinciding with or next following the date the employee satisfies the eligibility requirement; (ii) the Plan added an automatic enrollment feature, under which new hires are automatically enrolled at a 2% deferral rate unless they elect otherwise, with an automatic escalation of 1% each Plan year up to a maximum of 6% of compensation; (iii) Roth elective deferrals were introduced as an additional contribution option effective April 1, 2025; and (iv) distribution provisions were updated to clarify and expand available forms of payment, including partial withdrawals consistent with minimum distribution requirements.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 3. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Benefits Paid to Participants: Benefits are recorded when paid.

Excess Contributions: Refunds of excess participant deferral contributions may be required to satisfy the relevant nondiscrimination provisions of the Plan. Such refunds are accrued as a liability and reduction in contributions in the Plan year in which the excess deferrals were made to the Plan.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks related to global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC, as an authorized representative of Ascensus Trust Company and Newport Trust Company, LLC (for the year ended December 31, 2024 and for the period from April 18, 2024 to December 31, 2024) and Newport Trust Company, LLC (for the year ended December 31, 2023 and for the period from January 1, 2024 to April 17, 2024).

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Ascensus, LLC, Ascensus Trust Company, Newport Group, Inc. and Newport Trust Company are service providers to the Plan and, therefore, the Plan's payment of fees to the service providers qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original non-standardized pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
