Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Tradewind Aviation, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Tradewind Aviation, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Tradewind Aviation, LLC 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE #1 - DESCRIPTION OF PLAN

The Plan is a defined contribution plan covering substantially all employees of Tradewind Aviation, LLC. The Plan, which is participant-directed, was adopted and effective on March 15, 2016, and has since been amended to remain in compliance with laws and regulations. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Employees who have at least attained the age of twenty-one and have completed two hundred and fifty hours in four consecutive months of employment are eligible to make elective deferrals and receive employer safe harbor matching and profit-sharing contributions.

Contributions

Contributions to the Plan include salary deferral contributions authorized by participating employees, employer safe harbor matching contributions as defined by the Plan and discretionary profit-sharing contributions. Participants may contribute to the Plan at their discretion a portion of their annual pre-tax or post-tax wages not to exceed IRS regulations. Participants maximum contributions are limited by IRS regulations to \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively, of annual compensation as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions of \$7,500 for the years ended December 31, 2024 and 2023, respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The employer safe harbor matching contributions are defined as 100% of elective deferrals less than or equal to 3% of participants eligible compensation and 50% of elective deferrals greater than 3%, but less than or equal to 5% of eligible compensation. Additional discretionary amounts may be contributed at the option of the Company as profit sharing contributions. All employer contributions are invested in the exact percentage allocation as the employee's deferral allocation.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are also immediately vested in any employer safe harbor matching contributions. Vesting in the employer's profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service, one year can be an equivalent of 1,000 hours of service for a year.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participants account and bear interest at prime plus 1% at the time of the loan. The interest rates varied from 4.50-9.00% as of December 31, 2024 and 2023. Principal and interest is paid ratably through payroll deductions. Participant loans as of December 31, 2024 and 2023 were \$69,578 and \$67,294, respectively.

Payment of Benefits

Payments of any vested benefits are made from a participant's account in the event of termination of employment, disability, retirement, attainment of age 59 ½ or death. The participants are also eligible for a withdrawal in the case of severe financial hardship as defined by the Plan.

Forfeited Accounts

Forfeitures may be used to reduce any employer contributions to the plan, for payment of Plan administrative expenses, or the restoration of participant's individual account. As of December 31, 2024 and 2023 there were no forfeited non-vested accounts. During 2024 and 2023 there were no forfeitures used to offset plan administrative expenses.

Termination of Plan

In the event of Plan termination, the Plan administrator will continue to function during such period as is necessary to make remaining normal distributions and to administer and distribute the residual interests of the participants. Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to provisions of ERISA.

NOTE #2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note #3 for discussion regarding fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Participants' contributions are recorded as they are withheld from the participant's wages.

Notes Receivable from Participants

The notes are valued at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions in any of the available investment options. Participants may change their investment options at any time.

Payment of Benefits

Benefits are recorded when paid.

Plan Administrative Costs

The Company absorbs significant costs of the Plans administrative related recordkeeping and general administrative expenses.

Date of Management Evaluation

Management has evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued.

NOTE #3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Assets classified as Level 1 assets are valued using quoted prices in active markets for identical investments. An active market for an investment is a market in which the investment is traded with sufficient frequency and volume to provide pricing information on an ongoing basis. A quoted price in an active market provides the most reliable evidence of fair value.

Level 2 – Assets classified as Level 2 are valued using inputs other than quoted prices. These inputs are observable, either directly or indirectly. Level 2 inputs include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Assets classified as Level 3 assets are valued based on inputs that are unobservable for the investment. Unobservable inputs are inputs that reflect the reporting entity's own assumptions used in pricing an investment based on the best information available. Unobservable inputs must be used to measure fair value when observable inputs are not available, or when there is little, is any, market activity for the investment at the valuation date.

The Plan maintains a policy to use the most relevant data or markets available.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund: Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidation will be carried out in an orderly business manner.

All mutual funds are valued using Level 1 inputs.

The Plan recognizes transfers between levels as of the beginning of the reporting period. There were no transfers between the levels for the years ended December 31, 2024 and 2023.

The Internal Revenue Service has determined that the Master Plan utilized by the Company is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes both the 2024 and 2023 tax filings are subject to examination by the Internal Revenue Service.

NOTE #5 - INFORMATION CERTIFIED BY THE TRUSTEE

At December 31, 2024, the Ascensus Trust Company as trustee held the Plan's investments. The following is a summary of the Plan's financial information that is included in the financial statements based on information certified by the Trustee as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

Ascensus, Inc. is the record-keeper, Vanguard, Inc. is the third-party administrator and Hooker and Holcombe Investment Advisors, Inc. is the advisor of the Plan.

Administrative expenses of the Plan are paid by the participants except for certain fees which are paid by the Company. Participant fees paid by the Plan to parties-in-interest amounted to \$10,630 for the year ended December 31, 2024.
