Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Custom Agri Systems, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Years Ended December 31, 2024 and 2023

Note 1 – Description of Plan

The following description of the Custom Agri Systems, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan, as amended and restated, is a defined contribution plan of Custom Agri Systems, Inc. and participating employers (the Plan Administrator and Company), covering all eligible employees, as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, and an allocation of Plan earnings (losses). The allocation of Plan earnings (losses) is based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the vested value of the participant's account. Participants direct the investment of their account balances among the investment funds offered by the Plan.

Notes Receivable from Participants

Participants are permitted loans up to the lesser of \$50,000 or 50% of their vested account balance. Participants should refer to the Plan document for a complete description of loan provisions.

Contributions

Participants may elect to defer as pre-tax and/or Roth contributions, an amount up to the maximum percentage allowable, or may elect not to participate in the Plan. If an employee does not make an election, the employee will be automatically enrolled at an initial pre-tax rate of 5%. Participants over age 50 may also defer catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Company provides a safe harbor matching contribution totaling 100% of the participant's deferrals not exceeding 3% of eligible compensation, plus 50% of the deferrals from 3% to 5% of eligible compensation.

Payment of Benefits

On termination of service, death, disability, or retirement, a participant may receive a payment in the amount equal to the value of the participant's vested interest in his or her account. The Plan provides for normal retirement at age 59 ½. The total vested portion of a participant's account balance is distributed in the form of a lump sum payment or as a non-recurring partial payment.

Note 1 – Description of Plan (continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Company contributions are fully vested after completing three years of service.

Forfeitures

Forfeited balances of terminated participants' non-vested accounts may be used to pay Plan expenses or used to reduce the employer matching contribution, as defined in the Plan document and determined by the Plan Administrator.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

Administrative Expenses

Certain administrative expenses are paid by the Plan, as described in the Plan document. The Company paid for other costs of administering the Plan. The services are rendered by parties-in-interest to the Plan.

Note 2 – Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Benefit payments to participants are recorded upon distribution.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. There have been no changes in the valuation methods used. The Plan's investments were held and certified by Alerus Financial, N.A.

Mutual funds represent investments with various investment managers. The fair values of these investments are determined by reference to the fund's underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are valued at net asset value.

Investment Valuation and Income Recognition (continued)

Exchange-traded funds are valued at fair value based on closing prices on the last business day of the Plan year.

The Cash Reserve Federal Money Market and the Federal Money Market Fund are government money market funds investing 99.5% or more of the total assets in extremely liquid investments such as cash and government securities. The investments are valued at fair value using the amortized cost method as permitted by Rule 2a-7 under the Investment Company Act of 1940.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement.

Purchases and sales of the investments within the Plan are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent outstanding loans and are measured at their unpaid principal balance plus accrued interest.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that could affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Subsequent Events

Management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

Note 3 – Investments

Investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation (depreciation) of investments, and interest and dividends for the years then ended, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Alerus Financial, N.A.

Note 4 – Fair Value Measurements

The various inputs that may be used to determine the value of the Plan's investments are summarized in three broad levels within the fair value hierarchy. The three levels are described below:

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly; and
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's investments valued at fair value, as held at December 31, 2024 and 2023, were all Level 1 investments.

Note 5 – Income Tax Status

The Internal Revenue Service ruled on June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA plan (the document plan upon which the Plan is based) qualifies under Section 401 of the Internal Revenue Code (IRC) and the related trust is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes the Plan is currently designed in compliance with the applicable requirements of the IRC and has indicated that it is taking the necessary steps, if any, to bring the Plan's operations into compliance.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.
