### Note 1: Description of Plan

The following description of Goodwill Industries of South Central WI, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of Goodwill Industries of South Central WI, Inc. (the "Employer"). Employees who have reached the age of 18 and completed 260 hours within two months of hire, excluding co-employment employees, are eligible to participate the first day of the month upon meeting these requirements. Any employee who does not meet the 260 service hour requirement in their first two months of hire have twelve months to meet 1,000 hours during the Plan year. All employees who have completed the initial service requirements are eligible for Employer profit sharing and qualified automatic contribution arrangement (QACA) safe harbor matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Company Board of Directors and Plan Trustees are responsible for oversight of the Plan.

#### Contributions

Each year, participants may contribute pretax or after-tax annual contributions to the Plan up to 75% of compensation, as defined in the Plan, subject to the maximum amount allowable by the Internal Revenue Service (IRS) and provided these contributions will not cause the Plan to exceed the discrimination limits, in which case, excess contributions will be refunded to the participants. Participants who reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company contributes safe harbor matching contributions of 100% of an eligible participant's contributions that are not in excess of 1% of the participant's compensation, plus 50% of the amount of the participant's contributions that exceed 1% of the participant's compensation but that do not exceed 6% of the participant's compensation. A discretionary profit sharing contribution was not made for 2024.

Employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation, with the option to elect a higher or lower deferral rate. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contribution, the Employer's QACA safe harbor matching contribution, and allocations of (a) additional discretionary Employer contributions (if any) and (b) plan earnings or losses. Allocations are based on the participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting and Forfeitures

Participants are vested immediately in their deferral and rollover contributions, plus actual earnings thereon. Vesting in the Employer's additional discretionary contributions, plus actual earnings thereon, is based on years of service as follows:

Less than 3 years	0
3 or more years	100

Vesting in the Employer's QACA safe harbor matching contributions, plus actual earnings thereon, is based on years of service as follows:

Participants are considered to have completed one year of service for the purpose of vesting upon the completion of 1,000 hours of service during the Plan Year.

Forfeitures of nonvested participant balances can be used to reduce future Employer contributions or pay Plan expenses. For the year ended December 31, 2024, forfeitures of \$32,611 were used to reduce Employer contributions. As of December 31, 2024 and 2023, \$43,092 and \$45,798 were available in the Plan's forfeiture account.

#### Investment Options

Upon enrollment in the Plan, participants may direct the investment of their account balance into a variety of investment options as more fully described in the Plan's literature. Participants may change their investment options daily.

#### **Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the participant's highest outstanding note balance during the preceding 12-month period or 50% of their vested account balance. Maturities may not exceed five years unless the note is used to acquire a principal residence for the participant. Participants may not have more than one note outstanding from the Plan at any time. The notes are collateralized by the balance in participant's account. Interest rates on existing loans range from 4.25% - 9.50%, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through payroll deductions.

#### **Payment of Benefits**

Upon death, disability, retirement, or upon termination of service for any reason, a participant will receive benefits in a lump-sum payment equal to the value of the participant's vested interest in their account balance. Participants may elect to withdraw all or any part of their vested account at any time upon reaching age 59 1/2. In addition, hardship withdrawals are also permitted if a participant meets certain conditions defined in the Plan document. Account balances less than \$7,000 upon termination can be paid out as soon as administratively feasible without participant consent.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates in Preparation of Financial Statements**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contract (FBRIC). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Finance/Audit Committee determines the Plan's valuation policies utilizing information provided by the investment advisor. See Note 4 for discussion of fair value measurements.

#### **Investment Valuation and Income Recognition (Continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

The FBRIC is reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Fees related to benefit payments and administration of notes receivable from participants are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### **The Secure 2.0 Act**

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued.

### Note 3: Information Prepared and Certified by Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest on notes receivable from participants, and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the Custodians of the Plan.

### Note 4: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

*Mutual funds:* Shares of registered investment companies are valued at the daily closing price as reported by the fund. These funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

### Note 5: Fully Benefit-Responsive Investment Contract (FBRIC)

The Plan has a group fixed deferred annuity contract with Empower Annuity Insurance Company of America ("Empower"). Empower maintains the contributions in a general account. The account is credited with all contributions made by or on behalf of the participant as well as earnings and charged for participant withdrawals and administrative expenses. The contract issuer must repay the principal and a specified interest rate is guaranteed to the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with Empower including plan termination and other events as specified in the FBRIC. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The FBRIC does not permit Empower to terminate the agreement prior to the scheduled maturity date.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The average yield earned by the Plan and the average interest rate credited to the participants' accounts for the year December 31, 2024 was 1.41%.

### Note 6: Income Tax Status

The Company adopted a nonstandard prototype document with an IRS notification letter which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### Note 7: Related-Party Transactions and Party-in-Interest Transactions

Certain plan investments are managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC. Empower Annuity Insurance Company of America and Empower Trust Company, LLC, are the Custodians, as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. The Plan administrative expenses to this party were \$14,525 for the year ended December 31, 2024.

### **Note 7: Related-Party Transactions and Party-in-Interest Transactions (Continued)**

Certain plan services are provided by Gallagher Benefit Services Inc DBA Gallagher Fiduciary (Gallagher). Gallagher is an investment advisor, as defined by the Plan, and therefore these transactions qualify as party-in-interest transactions. The Plan administrative expenses to this party were \$18,681 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Certain employees of the Employer provide administrative services for the Plan and are not reimbursed for their services from the Plan. Certain other administrative expenses are paid by the Employer on behalf of the Plan.

### **Note 8: Plan Termination**

Although it has not expressed an intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### **Note 9: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
