LIBERTY RESOURCES RETIREMENT PLAN

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following brief description of the Liberty Resources Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan with salary reduction features as permitted under section 401(k) of the Internal Revenue Code and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent legislation, where applicable. The Plan is funded by employee and discretionary employer contributions. The Plan covers all employees of Liberty Resources, Inc.; Liberty Resources Disabilities Services, Inc.; Liberty Resources Behavioral Healthcare, Inc.; Liberty Resources Family Services, Inc.; Liberty Management Services, Inc.; Liberty Resources POST, LLC; Liberty Resources Psychology, Physical, Occupational and Speech Therapy, PLLC; MESA of N.Y., Inc. and MESA Management Services, LLC (collectively, the Company). Liberty Management Services, Inc. is the plan sponsor. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal) is the custodian of the Plan.

Eligibility

All employees of the Company are eligible to participate in the Plan upon the completion of three months of service and attaining the age of 21.

Contributions

Participants may elect to defer from 1% up to 100% of pretax annual compensation subject to the maximum allowable contributions under the Internal Revenue Code. Participants who attain age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). For participants who elect to defer a portion of their salary, the Company may contribute a discretionary matching contribution. Discretionary matching contributions made to the Plan were approximately \$310,000 and \$319,000 for 2024 and 2023, respectively.

The Company may make a discretionary contribution in addition to the discretionary match. The discretionary contribution is equal to a uniform percentage of each eligible participant's contribution as determined by the Company's Board of Directors. There were no discretionary contributions made to the Plan during 2024 or 2023.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings/(losses) thereon. Vesting in the Company's contributions plus earnings/(losses) thereon is based on years of service. Participants are 20% vested in the Company's contribution after one year of service. Vesting increases in increments of 20% for each additional year of service thereafter until 100% vesting occurs after five years.

1. DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contribution, if any, and Plan earnings/(losses). Allocations are based on participant earnings/(losses) or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions and their share of the Company's contributions into various investment options offered by the Plan. Participants may change their investment allocation at any time.

Payment of Benefits

Participants or their beneficiaries are eligible to receive benefits under the Plan upon normal retirement, death, total and permanent disability or terminations for any reason other than those previously mentioned. In addition, the Plan provides for in-service distributions of upon attaining age 50. Benefits are payable as a lump-sum amount or annual installments. Distributions resulting from disability or death result in payment of 100% of the account balance to the participant or designated beneficiary.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from a participant's voluntary contributions account. All hardship withdrawals must comply with Internal Revenue Service rules relating to hardships, which are uniformly applicable to all participants.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$28,491 and \$18,416, respectively. Forfeited nonvested accounts may be used to satisfy any contribution that may be required, to pay any administrative expenses of the Plan or be distributed to plan participants. Company contributions were reduced by \$9,403 through the application of forfeitures in 2024. In addition, during 2024 and 2023, forfeitures of approximately \$322 and \$155 were used to reduce administrative expenses, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Estimates

The preparation of financial statements in accordance with GAAP requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from these estimates.

Contributions Receivable and Allowance for Credit Losses

The Plan records a receivable for employee and employer contributions that are remitted to the Plan subsequent to the Plan's year end.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

The Plan invests in registered investment companies, which are reported at fair value based on quoted market prices. Purchases and sales of investments are recorded on a trade-date basis. Dividend income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both realized and unrealized gains and losses on those investments.

Risks and Uncertainties

The Plan's underlying investments are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the accompanying financial statements.

Fair Value Measurement - Definition and Hierarchy

Financial Accounting Standards Board (FASB) ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value and disclosing fair value measurements. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- *Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- *Level 2:* Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- *Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Registered investment companies are valued using quoted market prices. The fair values of interests in pooled separate accounts and common/collective trusts are measured based upon the NAV published on a daily basis using the fair value of the fund's underlying assets.

There were no changes in the valuation techniques during 2024 or 2023.

Administrative Expenses

All administrative expenses are paid by the Plan.

Payment of Benefits

Benefits are recorded when paid.

4. FAIR VALUE MEASUREMENTS

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Pooled Separate Accounts (other than the U.S. Property Separate Account):* Valued at net asset value ("NAV"). Invest in domestic stocks, international stocks, and fixed securities, such as asset or mortgage-backed securities and corporate bonds, and in mutual funds that hold such investments. The net asset values of the pooled separate accounts are not publicly quoted. The values of the underlying investments are used in determining the net asset value of each separate account. Underlying equity securities have observable quoted pricing inputs. Underlying fixed securities have observable pricing inputs, including quoted prices for similar assets in the active or non-active markets. Underlying mutual funds are valued at publicly quoted pricing inputs. The pooled separate accounts do not have any unfunded commitments relating to their investments, nor any restrictions on redemptions. Participant-directed redemptions can be made daily and do not have a redemption notice period.
- *Common/Collective Trusts:* Valued at NAV. Contain investments in a collective trust fund as well as a variety of separate accounts and mutual funds. The fair value of the collective trust fund and the separate accounts are not publicly quoted pricing inputs. The fair value of the mutual funds are publicly quoted pricing inputs. The fair value of all these investments are used in determining the NAV of the common/collective trust, which is not publicly quoted. The common/collective trusts can be redeemed at NAV as of the measurement date.

4. FAIR VALUE MEASUREMENTS (Continued)

The underlying investments are valued as follows; the fair value of conventional investment contracts is determined using a discounted cash flow methodology where the individual contract cash flows are discounted at the prevailing interpolated yield curve rate as of year-end. Individual assets of the synthetic investment contract are generally valued at representative quoted market prices. Short-term securities, if any, are stated at amortized cost, which approximates market value. Debt securities are valued on the basis of valuations furnished by a pricing service approved by the Trustee, which determines valuations using methods based on market transactions for comparable securities and various relationships between securities which are generally recognized by institutional traders. Accrued interest, if any, on the underlying investments is added to the fair value of the investments for presentation purposes. The common/collective trusts can be redeemed on a daily basis and there are no restrictions. There are no unfunded commitments.

- *Registered Investment Companies:* Values are determined based on quoted market prices in active markets.

The methods described previously may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (a) In accordance with the FASB authoritative guidance regarding fair value measurement, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. GUARANTEED INTEREST ACCOUNT

The Plan invested in a guaranteed interest account through Principal Fixed Income Guaranteed Option (PFIGO). PFIGO is a fully benefit-responsive group annuity contract issued by Principal. PFIGO contracts were reported at contract value, which was the aggregation of contributions, plus interest, less withdrawals, if any. The crediting interest rate is based on a formula agreed upon with Principal. Under the terms of the contract, the crediting rate is reset on a semiannual basis.

PFIGO is a single group annuity contract with a fixed rate of interest. As a result, the average yield earned by the Plan is the yield earned (i.e. interest credited) on the group annuity contract. By definition, PFIGO is an insurance contract. As a result, the Plan is able to transact according to the terms defined in the contract at any time.

PFIGO offers Plan participants stability of principal and a declared interest rate. This contract guarantees principal and provides a stated rate of return backed by the General Account of Principal. The general account consists of more than 7,000 investments, which include corporate bonds, Treasuries, commercial real estate mortgages, mortgage-backed securities, and short-term cash equivalents. There are no redemption restrictions or unfunded commitments related to this investment.

6. PLAN TERMINATION

While it has not expressed any intent to do so, the trustees of the Plan have the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of termination, partial termination, or complete discontinuance of contributions to the Plan, all amounts credited to the accounts of the participants would become fully vested and nonforfeitable. All distributions would be made in accordance with any applicable requirements of ERISA and the Internal Revenue Code (the Code).

7. TAX STATUS

The IRS has determined and informed by letter for the Volume Submitter Profit Sharing Plan adopted by the Plan, dated August 8, 2014, that the Volume Submitter Profit Sharing Plan is designed in accordance with applicable sections of the IRC. The Plan has not requested its own determination letter from the IRS. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provisions for income taxes have been included in the Plan's financial statements.

8. PARTY-IN-INTEREST TRANSACTIONS

Principal manages the Plan's investments and is the custodian of the Plan. As such, transactions between Principal and the Plan qualify as party-in-interest transactions.
