Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of The Blair Companies Retirement Income Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of The Blair Companies Retirement Income Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Note 1: Description of Plan

The following description of The Blair Companies Retirement Income Plan provides only general information. Participants should refer to the Plan Agreement for a complete description of the Plan's provision.

General

The Plan is a multi-employer defined-contribution plan with the following participating employers Blair Design & Construction Co., Inc., Blair Electric Service Co., Inc., Blair Real Estate LP, and Lakemont Park Center LLC referred hereafter as (the Company), covering employees of the Company who have three months of service, with at least 250 hours, and are 18 years of age or older. Employee is defined as any person employed by the Company not covered by a collective bargaining contract where retirement benefits were the subject of good faith bargaining with the union. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute pre-tax or Roth deferrals up to the maximum permitted under law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Effective April 1, 2020, a newly-hired employee is automatically enrolled in the Plan at 3% pre-tax contribution unless the employee elects otherwise. Effective March 1, 2024, the automatic enrollment deferral rate increased to 6%. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company discretionary contribution was fifty of the first three percent of base compensation that a participant contributes to the Plan. Additional profit sharing amounts may be contributed at the option of the Company's board of directors. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participants contributions and allocation of (a) the Company's contribution, (b) plan earnings, and (c) forfeitures of terminated participants' nonvested accounts and charged with an allocation of any administrative expenses paid by the Plan.

Vesting

Participants are immediately vested in their contributions and the actual earnings thereon. Vesting in the Company's match and profit sharing contribution portion of their accounts is based on years of continuous service as shown in the schedule below. A participant is 100% vested after 3 years of credited service.

Notes Receivable from Participants

Effective January 1, 2024, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lessor of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of 8.75% to 9.50% which commensurate with one percentage point over the prime interest rate. Principal and interest are paid ratably through monthly payroll deductions. Loans to participants are reported at their unpaid principal balance plus accrued interest.

Payment of Benefits

Prior to a participant attaining age 60, in-service withdrawals from all vested participant's accounts are permitted only on the basis of participant age being 59½ or financial hardship. Once participants attain age 60, they may withdraw up to 100% of their vested account in one or more withdrawals. Once a participant's employment with the Company ceases due to termination of employment, retirement, death or a participant's total disability, the participant can elect a lump-sum distribution of 100% of the participant's vested account balance.

If a participant's account balance is less than \$5,000 upon retirement or termination, a distribution of the participant's account will be made automatically.

Forfeited Accounts

For December 31, 2024 and 2023, forfeited nonvested accounts totaled \$7,964 and \$8,288, respectively. These accounts will be used to reduce future employer contributions. In 2024, employer contributions were reduced by \$41,849 from forfeited nonvested accounts.

Investment Options

The Plan is entirely participant-directed and, as such, upon enrollment in the Plan, a participant may direct employee and employer contributions in any investment option offered in the Plan. Participants may change their investment options at any time. The Plan currently offers various mutual funds as investment options.

Secure Act and Secure Act 2.0

The Plan is currently working with their third party administrator to ensure compliance and any required plan changes are made to comply with the Secure Act and the Secure Act 2.0.

Note 2: Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

An investment contract held by a defined-contribution plan is required to be reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Date of Management's Review

Subsequent events were evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in value of assets.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are treated as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024.

Note 3: Fair Value Measurement

ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 or 3 inputs were available to the Plan.

Level 1 Fair Value Measurements

At December 31, 2024 and 2023, the Plan's investments consist of various mutual funds. Mutual funds are based on quoted net asset value of the shares held by the Plan at year end. There have been no changes in methodologies or level designations as of December 31, 2024 and 2023.

Note 4: Information Prepared and Certified by the Custodian (Unaudited)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Empower Trust Company LLC, the custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023 and the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on note receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

Note 5: Separated Participants

Amounts allocated to withdrawing participants are recorded on the Schedule H of Form 5500 for benefit claims that have been processed and approved for payment prior to December 31 but not yet paid as of that date.

Note 6: Tax Status

The Internal Revenue Service has determined and informed the Company, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan is a prototype non-standardized profit sharing plan. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would

not be sustained upon examination. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 8: Related Party and Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds managed by J.P. Morgan on the investment platform of the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

Cambridge Investment Group provides investment advisory services and, therefore, these transactions qualify as party-in-interest transactions. Retirement Plan Solutions provides certain third-party administrative services and, therefore, these transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Fees paid by the Plan for the administrative services amounted to \$28,190 for the year ended December 31, 2024.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
