Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Alliance Profit Sharing and Employee Savings Plan ("Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended, and the related notes to the financial statements ("2024 Financial Statements").

NOTE 1 – PLAN ADMINISTRATION AND DESCRIPTION

The following description of the Alliance Profit Sharing and Employee Savings Plan (“Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

Effective January 1, 1981, Alliance Rubber Company (“Company”), established the Plan. The Plan is a voluntary contribution profit sharing plan covering substantially all employees, except for leased employees, of the Company. Each employee is eligible to become a participant in the Plan after completing three months of service and attaining age 21. Once an employee is eligible to enter the Plan, he or she will become a member on January 1st or July 1st coincident with or next following the date eligibility requirements are satisfied. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Contributions

Each year, participants may contribute up to 90 percent of their pretax annual compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). For the years ended December 31, 2024 and 2023, the Company made a discretionary employer matching contribution of 100 percent of the participants’ elected contribution up to seven percent of the participants’ pretax annual compensation. The Company may also make a non-elective discretionary contribution (profit-sharing contribution) to the Plan. Participants must have performed one year of service (defined as 1,000 hours of service during the Plan year) and be employed on the last day of the plan year, except in the event of death, disability or retirement during the year, to be eligible for the profit-sharing contribution. No non-elective discretionary contribution was made for the years ended December 31, 2024, and 2023. Participants direct the investments of the contributions to their account to various investment plans offered by the Plan. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, rollover contributions, and allocations of (a) the Company’s contribution, if applicable, and (b) plan earnings, and forfeitures of terminated participant’s nonvested accounts less administrative expenses. Allocations are based on participant earnings or account balances, or participant requested transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Administrative fees, except loan fees and certain investment fees, are allocated based on participant earnings or account balances.

Vesting

Participants are immediately vested in their contributions, rollover contributions, and safe harbor contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service as follows:

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate for the life of the loan. Principal and interest are paid ratably through payroll deduction over a period not to exceed five years unless the loan is taken out for the acquisition of a principal residence.

Payment of Benefits

A participant's entire interest in the Plan is payable upon death, attainment of normal retirement age, becoming disabled, as defined, or termination of service. A participant may elect to receive a lump-sum, partial, or installment amount equal to the vested portion of the participant's account. Participants may elect to rollover their vested balance to another qualified retirement plan or IRA. Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$5,000 or less. For terminated participants with vested balances greater than \$5,000, their vested balance may be automatically rolled into an IRA unless otherwise elected. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan. Participants may also withdrawal an amount at age 59½ if certain criteria are met.

Forfeited Accounts

Forfeitures are used to pay plan expenses or to reduce employer contributions. There were forfeited nonvested accounts totaling \$150 and \$1,546 for the years ended December 31, 2024 and 2023, respectively. There was \$152 of forfeitures used to reduce employer contributions for the year ended December 31, 2024.

Administration Expenses

The Plan permits the payment of Plan expenses to be made from Plan assets. If the Company does not pay these expenses, then the expenses paid using the Plan's assets will be allocated among the participant accounts. All fees related to contract administration, recordkeeping, and investment management are included in administration expenses. Additional investment related expenses are included in the net appreciation or depreciation of the fair value of investments. For the year ended December 31, 2024, \$60,198 of administrative fees were paid for by plan assets. Any expenses paid by the Plan Sponsor are excluded from these financial statements.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Reclassification

Certain amounts in the prior year's financial statements have been reclassified to conform to the current year's presentation. The reclassifications included are primarily due to the classification of all investment components as investments. The reclassifications had no effect on the previously reported changes in net assets.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared using the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP"), which requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

The Financial Accounting Standards Board ("FASB") has adopted the Accounting Standards Codification ("ASC") as the sole source of authoritative GAAP. The FASB will issue Accounting Standards Updates ("ASU") from time to time to make adjustments to GAAP.

B. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. The Plan's investments are valued daily.

Net appreciation or depreciation of investments included in the accompanying statement of changes in net assets available for benefits include realized gains or losses from the sale of

investments and unrealized appreciation or depreciation in fair value of investments bought and sold as well as held during the year.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

C. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit loss has been recorded as of December 31, 2024 or 2023.

D. Contributions

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Company contributions are recorded in the relevant period in accordance with the terms in the Plan document.

E. Payment of Benefits

Benefits are recorded when paid.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Reliance Trust Company (“Reliance”) and Automatic Data Processing, Inc. (“ADP”) is the record keeper of the Plan. The administrative fees paid to ADP by the Plan qualify as party in interest transactions. The Company pays directly any other fees related to the Plan’s operations. Investment fees paid to Reliance are netted against investment returns.

Reliance has an agreement with ADP to perform the record keeping for the plan. Administrative services to the plan provided by ADP included in the statements of changes in net assets are \$29,975 for the year ended December 31, 2024.

The Plan has engaged Merrill Lynch for investment advisor services. Administrative services to the plan provided by Merrill Lynch included in the statements of changes in net assets are \$30,223 for the year ended December 31, 2024.

NOTE 6 – TAX STATUS

The Plan obtained its latest determination letter on October 6, 2020, in which the IRS stated that the Plan, as then designated, was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the Plan Administrator is not aware of any events that have occurred that might adversely affect the Plan’s qualified status.

The Plan follows the accounting guidance for uncertainty in income taxes using the provisions of FASB ASC Topic 740, Income Taxes. Using that guidance, tax positions initially need to be recognized in the financial statements when it is more-likely-than-not the position will be sustained upon examination by the tax authorities.

The Plan has concluded that there are no significant uncertain tax positions requiring disclosure, and there are no material amounts of unrecognized tax benefits. The Plan’s evaluation was performed for tax years ended December 31, 2021 through December 31, 2024, the years that remain subject to examination by major tax jurisdictions as of December 31, 2024.

NOTE 7 – AMOUNTS OWED TO WITHDRAWN PARTICIPANTS

As of December 31, 2024, the amount of net assets available for benefits that were in accounts of participants that are no longer employees of the Plan Sponsor totaled \$291,977. Of those balances, no amounts had been requested to be paid to the participants but were not paid until subsequent to the Plan’s year end.
