Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Frontline Ag Solutions, LLC 401(k) plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Frontline Ag Solutions, LLC (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Company established the Plan to provide employees with a systematic means of savings and investing for the future. Eligible employees of the Company, as defined by the Plan document, can enroll on the first day of each month of the Plan Year coinciding with or immediately following the date the employee satisfies the eligibility requirements.

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Assets of the Plan are allocated to participant accounts based on specific contributions made by each participant and respective match made by the Company. Investment income (loss) is credited to each account based on appreciation (depreciation) of specific assets held in each participant account and any earnings thereon.

The plan was originally effective on January 1, 1997. The amended and restated provisions of the Plan, which pertained to expanded eligibility service requirements and additional distribution provisions, became effective on October 1, 2021.

Automatic Enrollment

The Plan has an automatic enrollment feature. An initial pre-tax deferral contribution of 3% of each eligible employee’s compensation is made for all participants who do not specify a deferral percentage or opt out of the Plan. If a deferral election is not made, the initial deferral percentage is increased on the first day of each plan year in accordance with the following schedule:

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the company's matching contributions, Plan gains or losses, and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's accounts.

Participants are immediately 100% vested in their elective deferrals and rollover contributions, plus actual earnings thereon. Participants vest in Qualified Automatic Contribution Arrangement (QACA) safe harbor matching contributions based on year of service as follows:

Contributions

Upon meeting the eligibility requirements, participants may contribute a minimum of 1 percent of their compensation, as defined by the Plan, by means of payroll deductions on a pre-tax or Roth basis. Contributions are subject to certain discrimination tests prescribed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. These catch-up contributions are subject to certain statutory limitations.

The Company makes a qualified automatic contribution arrangement (QACA) safe harbor matching contribution base on the participants deferred amount, in the amount of 100% of the first 1% of compensation deferred and 50% of the next 5% of compensation deferred. The Company may also make additional discretionary matching contributions and discretionary profit-sharing contributions to participants who have met plan eligibility requirements. The Company elected not to make any discretionary matching contributions or discretionary profit-sharing contributions for the years ended December 31, 2024 and 2023. Contributions are subject to certain statutory limitations.

NOTE 1 – DESCRIPTION OF THE PLAN – CONTINUED

Investment Options

Upon enrollment in the Plan, participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and money market investments for participants.

Payment of Benefits

Upon termination of service, death, disability, or retirement, participants may elect to receive a lump-sum amount equal to the vested value of their account or may transfer the vested value of their account to another retirement investment vehicle. If the participant does not initiate a withdrawal and the value of their vested account is less than \$1,000, the vested balance is distributed to the participant, regardless of consent. If the participant's vested account balance is between \$1,000 and \$5,000, the participant must withdraw the vested balance from the Plan or the Plan Sponsor will roll it to an individual retirement account. Participants with vested account balances greater than \$5,000 may delay distributions until required by law to receive required minimum distributions. Hardship withdrawals are permitted for certain situations.

Notes Receivable from Participants

Participant loans are not permitted from the Plan.

Participant Investment Rollovers

Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$142 and \$73, respectively. These accounts will be used, at the discretion of the Plan administrator, to reduce the Company's contributions. For the years ended December 31, 2024 and 2023, \$3,443 and \$2,945, respectively, were reallocated from forfeitures accounts to be used for employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value

is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Accounting Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets and liabilities and changes therein, disclosure of contingent assets and liabilities. Accordingly, the actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expense charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation in fair value of investments.

Contributions

Contributions from employees are recorded as they are withheld from the participant's wages.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as accounts payable, with a corresponding reduction to contributions. There were no excess contributions for the years ended December 31, 2024 and 2023.

Payment of Benefits

Benefit payments to participants are recorded when paid.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

NOTE 3 – INVESTMENTS (UNAUDITED)

The Plan's investments were held in trust and administered by the trustee, Ascensus Trust Company for the years ended December 31, 2024 and 2023. All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and net appreciation (depreciation) in fair value of investments and interest and dividends, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the trustee.

NOTE 4 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 4 - FAIR VALUE MEASUREMENTS - CONTINUED

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds (Level 1): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market funds (Level 1): Fair value is based on quoted prices in active markets for identical securities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 - FAIR VALUE MEASUREMENTS – CONTINUED

Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation (depreciation) in fair value of investments.

The Plan's policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers of investments into or out of Level 3.

NOTE 5 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Ascensus Trust Company, the trustee of the Plan and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services were included as a reduction of the return earned on each fund. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party-in-interest transactions.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

NOTE 7 – INCOME TAX STATUS

The Company has adopted a prototype non-standardized plan pre-approved by the IRS. The IRS issued an opinion letter dated June 30, 2020, that the prototype non-standardized plan is acceptable with the applicable section of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of American require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 – RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

There were no reconciliations of net assets available for benefits or reconciliations of the change in net assets available for benefits per the financial statements to Form 5500 at December 31, 2024 and 2023.

NOTE 10 – SUBSEQUENT EVENTS

The Plan did not have any subsequent events through October 10, 2025, which is the date the financial statements were available to be issued, requiring recording or disclosure in the financial statements for the year ended December 31, 2024.
