INDEPENDENT AUDITORS' REPORT

To the management of Latium USA Group 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Latium USA Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Latium USA Group 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

1. PLAN DESCRIPTION

Background - The Latium USA Group 401(k) Plan (the "Plan") is a defined contribution plan as described in the Internal Revenue Code section 401(k), sponsored by Four Seasons Solar Products LLC (the "Company"). The Plan was adopted on January 31, 1980 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Reliance Trust Company is the trustee of the Plan. ADP Retirement Services ("ADP") is the third-party administrator of the Plan. Merrill Lynch provides investment advisory services to the Plan.

Amendments to the Plan - The Plan implemented certain provisions of the Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE Act"), which was signed into law during December 2019. The SECURE Act raised the age for minimum distributions from 70 1/2 to 72 effective January 1, 2020. The SECURE 2.0 Act, which was signed into law during December 2022, raised the age for minimum distributions from 72 to 73 effective January 1, 2023.

During March 2020, the Plan implemented certain provisions of the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act"). For the year ended December 31, 2020, the CARES Act allowed certain eligible individuals to take coronavirus-related distributions, temporarily increased participant loan borrowing limits, allowed for the suspension of repayments on participant loans, and suspended required minimum distribution rules. Participants had the option of repaying distributions under the CARES Act within three years after the date the distribution was received; accordingly, such repayment period extended into 2023.

The Plan was amended to include as participating employers Four Seasons Marketing (effective November 3, 2023), Kennedy Property Investments (effective February 1, 2024), Alumawood Outdoor Living LLC (effective April 1, 2024), and SoCal Metal Painting LLC (effective April 1, 2024).

LATIUM USA GROUP 401(k) PLAN

1. PLAN DESCRIPTION (continued)

Written amendments to the Plan to reflect the operational changes in the SECURE, SECURE 2.0, and CARES Acts will be adopted in accordance with applicable law and IRS guidance.

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

Eligibility - The Plan is available to employees of the Company and affiliated participating employers Latium USA Trading LLC (d.b.a., Four Seasons Building Products, Alumaline Distribution, C-Thru, and Superior Mason Products), Latium Enterprises Inc., Four Seasons Marketing LLC, Kennedy Property Investments LLC, Alumawood Outdoor Living LLC, and SoCal Metal Painting LLC, excluding those who are represented by a bargaining unit for collective bargaining purposes, leased employees, and part-time employees whose regularly scheduled service aggregates less than 1,000 hours in a calendar year, who have attained age 21 and completed three months of service. An eligible employee may elect participation in the Plan as of the first day of the following month.

Contributions and Vesting - Participants in the Plan may make pre-tax salary deferral contributions, subject to section 401(k) maximum limitations (\$23,000 in 2024). Employees who attain age 50 are permitted to make catch-up contributions of up to \$7,500 in 2024.

An eligible employee may make a transfer to the Plan of a benefit from a qualified retirement plan of another employer, referred to as rollover contributions, with certain restrictions.

The Plan provides for employer matching contributions, which are equal to 100 percent of pre-tax 401(k) deferral contributions of up to 2 percent of eligible compensation.

Participants are fully and immediately vested with respect to their elective deferral contributions and earnings thereon. Vesting in employer contributions and the earnings thereon occurs at the rate of 50 percent after one year of service and 100 percent after two years of service. Employees of Latium USA Trading LLC (including former employees of Metals Building Products and Superior Mason Products), Four Seasons Marketing, Kennedy Property Investments, Alumawood Outdoor Living LLC, and SoCal Metal Painting LLC have been granted prior service credit for eligibility and vesting purposes. In addition, participants become fully vested in employer contributions upon attainment of normal retirement age (age 65), total disability, as defined in the Plan, death, or the termination of the Plan.

1. PLAN DESCRIPTION (continued)

Forfeitures – When participants terminate employment prior to full vesting, the nonvested amounts in their individual accounts, referred to as forfeitures, may be used to reduce future employer contributions or to pay Plan expenses. During the year ended December 31, 2024, forfeitures were used to reduce employer contributions and to pay plan expenses in the amounts of \$17,291 and \$489, respectively. Unallocated forfeitures as of December 31, 2024 approximated \$3,000.

Distributions to Participants - Distributions to participants are available upon the following events: retirement, attainment of age 59 1/2, termination of employment, disability, or death. Payment shall be made as soon as administratively feasible following the date on which the event occurs provided that the participant's consent is obtained for distributions of amounts in excess of \$7,000. Distributions can be made in the form of lump sum payments or rollovers to qualified plans. Participants with vested balances in excess of \$7,000 can also elect to receive installment payments or partial withdrawals, as defined in the Plan, and may elect to defer payment until April 1 following the calendar year in which the participant attains age 73 or terminates employment, whichever is later. The Plan also provides for hardship withdrawals to participants meeting certain requirements as described in the Plan agreement.

Upon enrollment in the Plan, participants are directed to designate a beneficiary or beneficiaries by completing a designation form. If a married participant designates someone other than their spouse as primary beneficiary, then the spouse must consent to this designation by signing the form and his/her signature must be witnessed by a Plan representative or a notary public. A participant's entire account balance is payable to the designated beneficiary upon his/her death.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate, which is determined by the Plan administrator based on the prime rate plus one percent, remains fixed for the duration of the loan. The interest rate ranged from 4.25 to 9.5 percent per annum on loans outstanding during the year ended December 31, 2024. Principal and interest is paid ratably through various semi-monthly payroll deductions over periods of 1 to 5 years, or up to 10 years for purposes of using loan proceeds in the purchase of a primary residence.

Administrative Expenses and Other Income - A substantial portion of administrative expenses incurred in connection with the management of the Plan are paid by the Company. In accordance with Plan provisions, the Company may, at any time, elect to have some or all of such expenses paid by the Plan.

An ERISA budget account accumulates available revenue credits on certain plan investments, which are used to pay a portion of plan administrative expenses.

Termination - The Company intends to continue the Plan indefinitely, but reserves the right to modify or discontinue it at its discretion, subject to applicable provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation - The Plan's policy is to prepare financial statements on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America for defined contribution plans.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further information regarding fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation (depreciation) in fair value of investments include the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Risks and Uncertainties - The Plan provides for various participant-directed investment options in securities including mutual funds and a collective investment trust fund. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. As a result of the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes in net assets available for benefits.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. The Plan distributes the excess contributions to the applicable participants prior to March 15th of the subsequent year.

Subsequent Events - The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued (see Note 8).

3. INCOME TAX STATUS

In October 2020, the Internal Revenue Service stated in an opinion letter that the prototype plan adopted by the Plan administrator was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter, however, the Plan administrator and management believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Accordingly, they believe that the Plan was qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that would likely not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any open tax periods.

Investments in mutual funds - The participant-directed mutual funds offer various investment options ranging from conservative funds which principally seek to preserve capital and provide fixed income to aggressive funds invested principally in common stocks, which seek growth of capital over the long term. The mutual funds also include JPMorgan Retirement Funds with varied target retirement dates. See Note 5 for a description of mutual funds stated at fair value.

Investment in collective investment trust fund - The Putnam Stable Value Fund Class 50 has underlying investments, which include guaranteed investment contracts and security-backed contracts issued by insurance companies and other financial institutions, and short-term investments. The trustee of this fund provides annual audited financial statements which describe the nature of the underlying investments and how they are valued.

See Note 5 for a description of the measurement of the collective investment trust fund stated at fair value.

5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- * quoted prices for similar assets or liabilities in active markets;
- * quoted prices for identical or similar assets or liabilities in inactive markets;
- * inputs other than quoted prices that are observable for the asset or liability;
- * inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no material changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust fund - The Putnam Stable Value Fund is valued at the net asset value of the units of the collective investment trust. The net asset value is used as a practical expedient to estimate the fair value. This practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan were to initiate a full redemption of the Putnam Stable Value Fund held by the Plan, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

8. SUBSEQUENT EVENTS

Effective January 1, 2025, the Company elected to implement an auto-enrollment provision under which newly eligible employees are automatically enrolled in the Plan at a pre-tax salary deferral contribution rate of 3 percent, unless they elect not to participate in the Plan.

The SECURE 2.0 Act of 2022 contains numerous provisions that impact 401(k) plans. These provisions, which will continue to take effect in years subsequent to 2024, address various issues including financial incentives to contribute to a retirement plan, automatic enrollment, required minimum distribution age, contribution limits and part-time worker access.
